FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, Bartolomeo Puglisi, P.O. Box 462, Port Lincoln, S.A. 5607, (the 'exemption holder') or a person acting as his agent, is exempt from the provisions of section 41 of the Fisheries Act 1982, in so far as he may engage in the collection of spat (the 'exempted activity') from the waters described in Schedule 1, using the gear specified in Schedule 2 subject to the conditions set out in Schedule 3 from the date of gazettal of this notice until 30 June 2005, unless varied or revoked earlier.

1. All fish taken pursuant to this notice must be relocated to aquaculture site FM00141 (Boston Shellfish Pty Ltd).

2. While engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce that notice to a PIRSA Fisheries Compliance Officer if requested.

3. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
