FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Aaron Morgan, Augusta Water Cruises, 3 Loudon Road, Port Augusta, S.A. 5700 (the 'exemption holder'), is exempt from Schedule 6 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder shall not be guilty of an offence when engaged in the activity specified in Schedule 1 ('exempted activity') using the gear specified in Schedule 2, subject to the conditions specified in schedule 3, from 3 February 2005 until 31 December 2005.

SCHEDULE 1

The taking and possession of silver whiting, black whiting, mullet, garfish, snapper, flathead, flounder, blue swimmer crabs and Australian herring (Tommy ruff) below the minimum legal length from the waters spanning from approximately 30 km south of Port Augusta to the tip of Spencer Gulf.

SCHEDULE 2

- two handlines or two rods and lines or one handline and one rod and line
- one dab net (to be used from shore or boat)
- one bait trap.

SCHEDULE 3

1. Any specimens that are taken and held pursuant to this exemption may be used for display purposes only at Augusta Water Cruises, 3 Loudon Road, Port Augusta, S.A. 5700 and must not be sold, released or removed from the site without the written permission of the Director of Fisheries.

2. The exemption holder must not, at any one time, possess more than the number of each species shown in the following table:

Silver whiting	3
Mullet	3
Snapper	3
Black whiting	3
Garfish	3
Flounder	3
Flathead	3
Blue swimmer crab	3
Australian herring	3

3. Within 14 days of the taking and release of organisms at the premises specified in condition 1 in Schedule 3, the exemption holder must provide a report in writing to the Director of Fisheries, (Attention: Alex Chalupa, G.P.O. Box 1625, Adelaide, S.A. 5001), giving the date and time of collection, the name and number of each species taken, the name of the person who collected the organisms and the number of mortalities resulting from the exempted activity.

4. Whilst engaged in the exempted activity, the exemption holder must have in their possession of a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

5. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Jason Higham, 5 Flame Tree Court, Greenwith, S.A. 5125 (the 'exemption holder') is exempt from section 41 of the Fisheries Act 1982 and the Fisheries (General) Regulations 2000, insofar as he may engage in the collection of fish (the 'exempted activity') from the waters described in Schedule 1, using the gear specified in Schedule 2, subject to the conditions set out in Schedule 3, from 3 February 2005 until 7 February 2005, unless varied or revoked earlier.

SCHEDULE 1

Torrens River catchment.

SCHEDULE 2

- Fyke nets
- Seine net
- Box trap
- Dip net

SCHEDULE 3

1. The specimens collected by the exemption holder are to be released in a private dam located within the Torrens River catchment.

2. A total of 50 flathead gudgeon (*Philypnidon grandiceps*) and 50 common galaxias (*Galaxias maculatus*) may be taken pursuant to this notice.

3. All native fish taken pursuant to the exempted activity must be immediately returned to the water when transported to the new water body.

4. A maximum of 50 fish of any species per location may be taken for the translocation.

5. The exemption holder must notify PIRSA Fishwatch on 1800 065 522 at least two hours prior to conducting the exempted activity and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption notice at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and boats involved, the number of agents undertaking the exempted activity and other related questions.

6. The exemption holder must provide a report in writing detailing the outcomes of the research and the collection of organisms pursuant to this notice, to the Director of Fisheries, (G.P.O. Box 1625, Adelaide, S.A. 5001) by the end of February 2005, giving the following details:

- the date, soak time and location of collection;
- the number of nets used;
- the description of all species collected (fish, invertebrates, turtles);
- the number of each species collected; and
- any other information regarding size, breeding or anything deemed relevant or of interest that is able to be volunteered.

7. While engaged in the exempted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

8. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
