1—Short title

This proclamation may be cited as the *Administrative Arrangements (Constitution of Ministers as Bodies Corporate) Proclamation 2011.*

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Dissolution of certain bodies corporate

The bodies corporate referred to in Schedule 1 are dissolved.

4—Constitution of certain Ministers as bodies corporate

The Ministers referred to in Schedule 2 are constituted as bodies corporate.

5—Vesting of certain assets, rights and liabilities

- (1) The assets, rights and liabilities of the former body corporate known as the Minister for Agriculture, Food and Fisheries are vested in and attached to the Minister for Agriculture and Fisheries and the Minister for Food Marketing according to the distribution of Ministerial responsibilities and functions between the relevant Ministers so that assets, rights and liabilities appropriate to particular responsibilities or functions vest in, or attach to, the appropriate body corporate.
- (2) The assets, rights and liabilities of the former body corporate known as the Minister Assisting the Premier in Public Sector Management are vested in and attached to the Minister for Public Sector Management.
- (3) The assets, rights and liabilities of the former body corporate known as the Minister for the City of Adelaide are vested in and attached to the Minister for Urban Development, Planning and the City of Adelaide.
- (4) The assets, rights and liabilities of the former body corporate known as the Minister for Federal/State Relations are vested in and attached to the Premier.
- (5) The assets, rights and liabilities of the former body corporate known as the Minister for Urban Development and Planning are vested in and attached to the Minister for Urban Development, Planning and the City of Adelaide.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Conferral of ministerial functions and powers

The ministerial functions and powers of the Minister for State/Local Government Relations under Part 2 of the *City of Adelaide Act 1998* are conferred on the Minister for Urban Development, Planning and the City of Adelaide.

Administrative Arrangements (References to Ministers) Proclamation 2011

under section 8 of the Administrative Arrangements Act 1994

1—Short title

This proclamation may be cited as the *Administrative Arrangements (References to Ministers) Proclamation 2011*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Interpretative provision

- (1) A reference to the Minister for Agriculture, Food and Fisheries in an Act or a statutory instrument under an Act will, if the Act was on the day immediately before the effective date, committed to the administration of that Minister, have effect as if it were a reference to the Minister to whom the administration of the Act is for the time being committed.
- (2) A reference to the Minister for Agriculture, Food and Fisheries in a statutory instrument or any other kind of instrument, or a contract, agreement or other document, made or entered into before the effective date (other than a reference to which subclause (1) is applicable) will have effect as if it were a reference to the Minister for Agriculture and Fisheries or the Minister for Food Marketing according to the distribution of Ministerial responsibilities and functions between the relevant Ministers so that the reference will have effect as if it were a reference to the Minister to whom the relevant responsibilities or functions are currently assigned.
- (3) A reference to the Minister Assisting the Premier in Public Sector Management in an Act, a statutory instrument, or any other kind of instrument, or a contract, agreement or other document, will have effect as if it were a reference to the Minister for Public Sector Management.
- (4) A reference to the Minister for the City of Adelaide in an Act, a statutory instrument, or any other kind of instrument, or a contract, agreement or other document, will have effect as if it were a reference to the Minister for Urban Development, Planning and the City of Adelaide.
- (5) A reference to the Minister for Federal/State Relations in an Act, a statutory instrument, or any other kind of instrument, or a contract, agreement or other document, will have effect as if it were a reference to the Premier.
- (6) A reference to the Minister for Urban Development and Planning in an Act, a statutory instrument, or any other kind of instrument, or a contract, agreement or other document, will have effect as if it were a reference to the Minister for Urban Development, Planning and the City of Adelaide.

(7) In this clause—

effective date means the date on which this proclamation is made.

Public Sector (Administrative Units of Public Service— Variation 1) Proclamation 2011

1—Short title

This proclamation may be cited as the *Public Sector* (*Administrative Units of Public Service—Variation 1*) *Proclamation 2011*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Alteration of Minister responsible for Olympic Dam Taskforce

The Minister Assisting the Premier with the Olympic Dam Expansion Project is designated as the Olympic Dam Taskforce's Minister with responsibility for the Taskforce.

4—Alteration of Minister responsible for Department of Planning and Local Government

The Minister for Urban Development, Planning and the City of Adelaide is designated as the Department of Planning and Local Government's Minister with responsibility for the Department.
