Administrative Arrangements (Constitution of Ministers as Bodies Corporate) Proclamation 2014

under section 7 of the Administrative Arrangements Act 1994

1—Short title

This proclamation may be cited as the *Administrative Arrangements (Constitution of Ministers as Bodies Corporate) Proclamation 2014.*

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Dissolution of certain body corporate

The body corporate referred to in Schedule 1 is dissolved.

4—Constitution of certain Ministers as bodies corporate

The Ministers referred to in Schedule 2 are constituted as bodies corporate.

5—Vesting of certain assets, rights and liabilities

The assets, rights and liabilities of the former body corporate known as the Minister for Manufacturing, Innovation and Trade are vested in and attached to the Minister for Manufacturing and Innovation and the Minister for Investment and Trade according to the distribution of Ministerial responsibilities and functions between the relevant Ministers so that assets, rights and liabilities appropriate to particular responsibilities or functions vest in, or attach to, the appropriate body corporate.

Administrative Arrangements (Committal of Acts) Proclamation 2014

under section 5 of the Administrative Arrangements Act 1994

1—Short title

This proclamation may be cited as the *Administrative Arrangements (Committal of Acts) Proclamation 2014.*

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Committal of Acts

The administration of an Act referred to in Schedule 1 is committed to the Minister for Manufacturing and Innovation.

Administrative Arrangements (References to Ministers) Proclamation 2014

under section 8 of the Administrative Arrangements Act 1994

1—Short title

This proclamation may be cited as the *Administrative Arrangements (References to Ministers) Proclamation 2014*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Interpretative provision

- (1) A reference to the Minister for Manufacturing, Innovation and Trade in an Act or a statutory instrument under an Act will, if the Act was, on the day immediately before the effective date, committed to the administration of that Minister, have effect as if it were a reference to the Minister to whom the administration of the Act is for the time being committed.
- (2) A reference to the Minister for Manufacturing, Innovation and Trade in a statutory instrument or any other kind of instrument, or a contract, agreement or other document, made or entered into before the effective date (other than a reference to which subclause (1) is applicable) will have effect as if it were a reference to the Minister for Manufacturing and Innovation or the Minister for Investment and Trade according to the distribution of Ministerial responsibilities and functions between the relevant Ministers so that the reference will have effect as if it were a reference to the Minister to whom the relevant responsibilities or functions are currently assigned.
- (3) In this clause—

effective date means the date on which this proclamation is made.

Public Sector (Administrative Units—Responsible Ministers) Proclamation 2014

under section 28 of the Public Sector Act 2009

1—Short title

This proclamation may be cited as the *Public Sector (Administrative Units—Responsible Ministers) Proclamation 2014*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Alteration of Minister responsible for Defence SA

The Minister for Defence Industries is designated as Defence SA's Minister with responsibility for the Department.

4—Alteration of Minister responsible for Department for Manufacturing, Innovation, Trade, Resources and Energy

The Minister for Manufacturing and Innovation is designated as the Department for Manufacturing, Innovation, Trade, Resources and Energy's Minister with responsibility for the Department.
