Expiration of provisions of the Emergency Management (COVID-19 Requirements) (Consolidated Measures) Direction 2022 and the Emergency Management (Residential Aged Care Facilities No. 49)(COVID-19) Direction 2022

Preamble

Subsection 90E(1)(a) of the *South Australian Public Health Act 2011* provides that the Minister for Health and Wellbeing may, by notice in the *Gazette*, fix a day or days on which a direction under section 90C, or specified provisions of such a direction, will expire.

NOTICE

Pursuant to subsection 90E(1)(a) of the Act, I fix 12:01am on Friday 23 September 2022 as the day on which the following provisions of the specified Directions will expire:

- A. The following provisions of the *Emergency Management (COVID-19 Requirements) (Consolidated Measures) Direction 2022*:
 - 1. clause 6
 - 2. clause 8(1)-(3); and
- B. The following provisions of the *Emergency Management (Residential Aged Care Facilities No. 49)(COVID-19) Direction 2022*:
 - 1. clause 7(4)
 - 2. clause 10(4)(a).

Under s 107, the time for the making of the final determination on the *Establishing revenue determinations for Intending TNSPs* (Ref. ERC0343) proposal has been extended to **1 December 2022**.

Under s 107, the time for the making of the final determination on the *Recovering the cost of AEMO's participant fees* (Ref. ERC0335) proposal has been extended to **20 October 2022**.
