CROWN LAND MANAGEMENT ACT 2009

Section 55—Minister may make declaration in relation to land

I, Michael Joseph Williams, Director of National Parks and Wildlife and authorised delegate of the Minister for Climate, Environment and Water, being the Minister responsible for the *Crown Land Management Act 2009*, hereby declare under Section 55 of the *Crown Land Management Act 2009* that—

- (a) Sections 61, 62, 63 and 64 of the *Crown Land Management Act 2009* will not apply to the land defined in The Schedule for a period of 24 months from the date of this notice, and
- (b) the following provisions apply to the land defined in The Schedule, during the period specified above, as if it were a national park constituted under the *National Parks and Wildlife Act 1972*:

SECTION 68

Revocation of Approval of Category B Containers

I, Nicholas Stewart, Team Leader, Container Deposit Legislation and Delegate of the Environment Protection Authority (the Authority), pursuant to section 68 of the *Environment Protection Act 1993* (SA) (the Act) hereby:

Approval of Category B Containers:

Approve as Category B Containers, subject to the conditions in subclauses 1, 2, 3 and 4 below, each of the classes of containers identified by reference to the following matters described in the first 4 columns of Schedule 1 of this Notice which are sold in South Australia:

- (a) the product which each class of containers shall contain;
 - (b) the size of the containers;
 - (c) the type of containers;
 - (d) the name of the holders of these approvals.
1. That containers of the class to which the approval relates must bear the refund marking specified by the Authority for containers of that class. The Authority specifies the following refund markings for Category B containers:
 - (1) "10c refund at collection depots when sold in SA",
Or
 - (2) "10c refund at SA/NT collection depots in State/Territory of purchase"
Or
 - (3) "10c refund at collection depots/points in participating state/territory of purchase"

2. The holder of the approval must have in place an effective and appropriate waste management arrangement in relation to containers of that class. For the purpose of this approval notice the company named in column 5 of Schedule 1 of this Notice is the nominated super collector.
3. In the case of an approval in relation to category B containers that the waste management arrangement must require the holder of the approval to provide specified super collectors with a declaration in the form determined by the Authority in relation to each sale of such containers by the holder of the approval as soon as practicable after the sale;
4. The holder of these approvals must ensure that if a sticker bearing the refund marking has been approved, and is applied to the container, then the sticker must not be placed on any portion of the opening mechanism or in any other place that would require complete or partial removal of the sticker before the contents may be consumed.

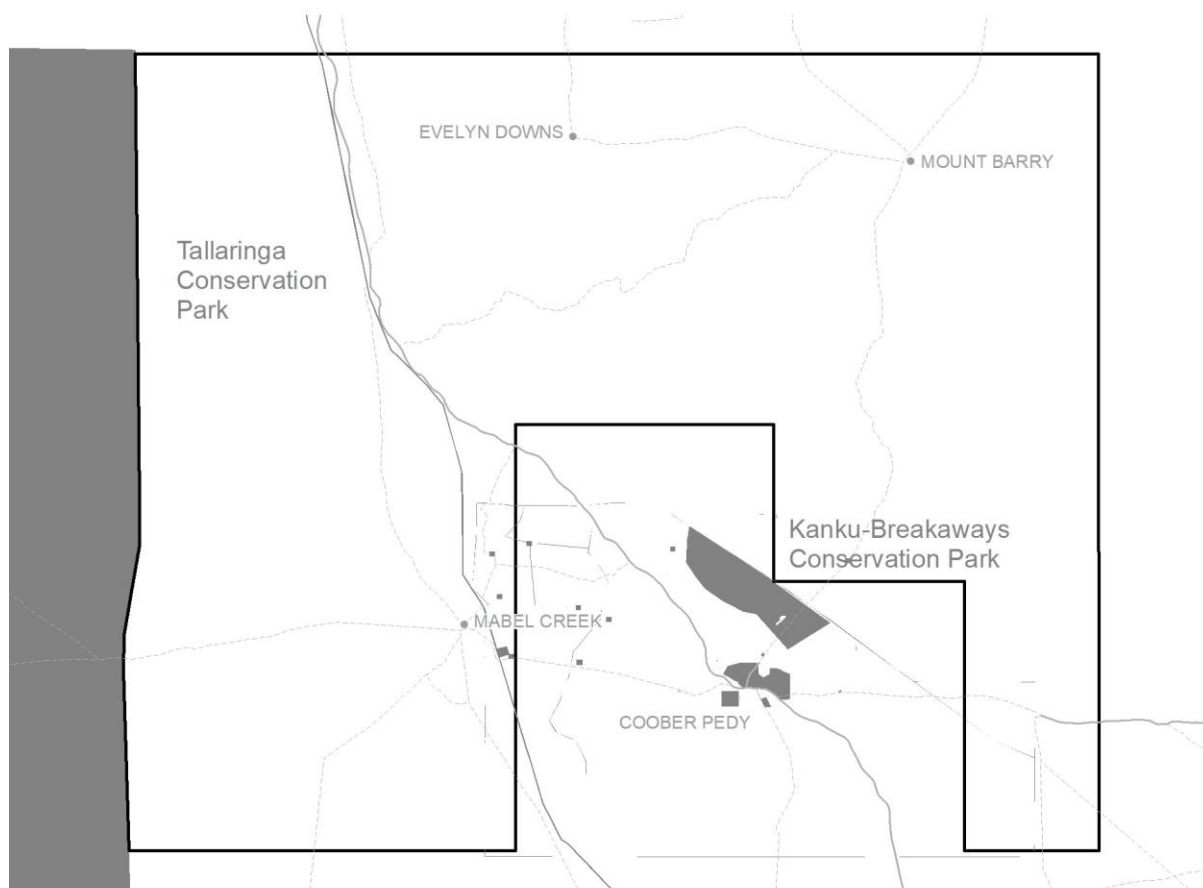

 - Hazards (Bushfire - High Risk)
 - Hazards (Bushfire - Medium Risk)
 - Hazards (Bushfire - General Risk)
 - Hazards (Bushfire - Urban Interface)
 - Hazards (Bushfire - Regional)
 - Hazards (Bushfire - Outback)
 - Heritage Adjacency
 - Limited Land Division
 - Local Heritage Place
 - Noise and Air Emissions
 - Scenic Quality
 - State Heritage Place
 - Stormwater Management

- b. In Part 13 of the Code – Table of Amendments, update the publication date, Code version number, amendment type and summary of amendments within the ‘Table of Planning and Design Code Amendments’ to reflect the amendments to the Code as described in this Notice.

THE REMUNERATION TRIBUNAL

REPORT—NO. 7 OF 2023

*2023 Review of Accommodation and Meal Allowances for
Ministers of the Crown and the Leader and Deputy Leader of the Opposition*

INTRODUCTION

1. The Remuneration Tribunal (**Tribunal**) has conducted a review of Determination 16 of 2022 which sets accommodation and meal allowances payable to Ministers of the Crown and the Leader and Deputy Leader of the Opposition.
2. As explained in this report, the Tribunal has determined to increase the allowances by 1.5%. The Tribunal has issued an accompanying determination, which applies from 1 January 2024.

THE REVIEW PROCESS

3. On 26 September 2023, and in accordance with sections 10(2) and 10(4) of the *Remuneration Act 1990* (**Act**), the Tribunal wrote to and invited submissions by 30 October 2023 in respect of this review from:
 - a. the Honourable Premier of South Australia – as the Minister responsible for the Act who may make submissions or introduce evidence in the public interest
 - b. members of Parliament
 - c. the Treasurer
 - d. the Independent Commissioner Against Corruption (**ICAC**)
4. The Tribunal also advertised its intention to review this, and other determinations applicable to Members of Parliament, on its website from 26 September 2023. Submissions were also invited by 30 October 2023.
5. On 26 September 2023, the ICAC confirmed that no submission would be made.
6. On 26 October 2023, the Premier’s representative confirmed that no submission would be made. No other submissions were received in respect of this review.

CONSIDERATIONS

7. The determination under review sets allowances to cover the costs of commercial accommodation and meals associated with official travel by Ministers, the Leader of the Opposition and Deputy Leader of the Opposition.
8. In considering this matter, the Tribunal has had regard to the following economic data relevant to the costs of commercial accommodation and meals:
 - a. The Consumer Price Index (All groups Adelaide) shows the following percentage changes from the corresponding quarters of previous years:
 - i. 8.6% for December 2022

- ii. 7.9% for March 2023
 - iii. 6.9% for June 2023
 - iv. 5.9% for September 2023
- b. As at August 2023 the Reserve Bank of Australia forecast of the Consumer Price Index was as follows:
 - i. 4 ¼ % for December 2023
 - ii. 3 ½ % for June 2024
 - iii. 3 ¼ % for December 2024
 - iv. 3% for June 2025
 - v. 2 ¾ % for December 2025
- c. The Australian Taxation Office Taxation Determinations TD 2022/10 and TD2023/3, which respectively set for taxation purposes reasonable accommodation, meal and incidental expenses for the 2022-23 and 2023-24 income years. The Tribunal has noted the following percentage changes between those respective Taxation Determinations, for the highest earners:
 - i. 0% increase to accommodation costs for Brisbane, Canberra, Darwin, Hobart, Melbourne, Perth, Sydney and most country centres
 - ii. 0.96% increase to accommodation costs for Adelaide
 - iii. 19.90% increase to accommodation costs for Tasmania
 - iv. 1.83% increase to breakfast costs
 - v. 1.76% increase to lunch costs
 - vi. 1.78% increase to dinner costs
 - vii. 7.87% increase to incidentals
 - viii. overall 1.16% to 1.81% increase for daily total (which includes accommodation, meals and incidentals), with the exception of Hobart which had an 11.26% increase to the daily total
- 9. The Tribunal has noted that domestic holiday travel and accommodation, within the CPI data, fell by 2.5%.
- 10. The Tribunal continues to adopt a cautionary approach to inflationary movements.
- 11. Having regard to these factors, the Tribunal has decided that these allowances should be increased by 1.5%, with effect from 1 January 2024.

DETERMINATION—NO. 7 OF 2023

Accommodation and Meal Allowances for Ministers of the Crown and the Leader and Deputy Leader of the Opposition

SCOPE OF DETERMINATION

1. This Determination applies to Ministers of the Crown, and to the Leader and Deputy Leader of the Opposition.

INTERPRETATION

2. In this Determination, unless the contrary appears:

“**Commercial Accommodation**” means short term (not permanent) accommodation in a commercial establishment such as a hotel, motel or serviced apartment, Airbnb or similar platform and must be a genuine arms-length commercial transaction.

“**Incurs Actual Expenditure**” means an amount of money spent by a Minister, Member or Officer of the Parliament.

“**Metropolitan Adelaide**” bears the same meaning as defined in the *Development Act 1993* (SA).

“**Meals**” means food or drink purchased by a Minister, Member or Officer of the Parliament in connection with an allowance payable under this Determination.

“**Minister**” means a Minister of the Crown in the right of the State of South Australia.

“**Official Duties**” means activities undertaken by a Member of Parliament in relation to their role as a Minister, or their role as the Leader or acting Leader of the Opposition.

“**Sydney**” means locations which are less than 10km by road from the Sydney General Post Office (by the most direct route), or less than 5km by road from Sydney’s principal airport (by the most direct route).

ACCOMMODATION AND MEAL ALLOWANCES

3. A Minister who incurs actual expenditure for both commercial accommodation and meals when travelling as part of their official duties and which necessitates absence from home overnight shall be entitled to be paid a per day accommodation and meal allowance, as follows:
 - 3.1 Outside Metropolitan Adelaide, but within South Australia:
 - 3.1.1 An allowance at the rate of \$317 per day for the purpose of meeting expenditure in relation to commercial accommodation and meals.
 - 3.2 Outside South Australia, but within Australia (other than Sydney):
 - 3.2.1 An allowance at the rate of \$472 per day for the purpose of meeting expenditure in relation to commercial accommodation and meals.
 - 3.3 Sydney:
 - 3.3.1 An allowance at the rate of \$533 per day for the purpose of meeting expenditure in relation to commercial accommodation and meals.

- 3.4 Provided that, where it is necessary and appropriate, reasonable additional expenditure to that prescribed by the allowances in 3.1, 3.2 and 3.3 for the purposes of commercial accommodation and meals may be reimbursed on the basis of evidence being produced of that additional expenditure.
4. The allowances provided by this Determination shall also be payable to the Leader of the Opposition, and to the Deputy Leader of the Opposition when he or she deputises, at the Leader's request, for the Leader of the Opposition in his or her official capacity.

DATE OF OPERATION

5. This Determination operates from 1 January 2024. It supersedes Determination 16 of 2022.

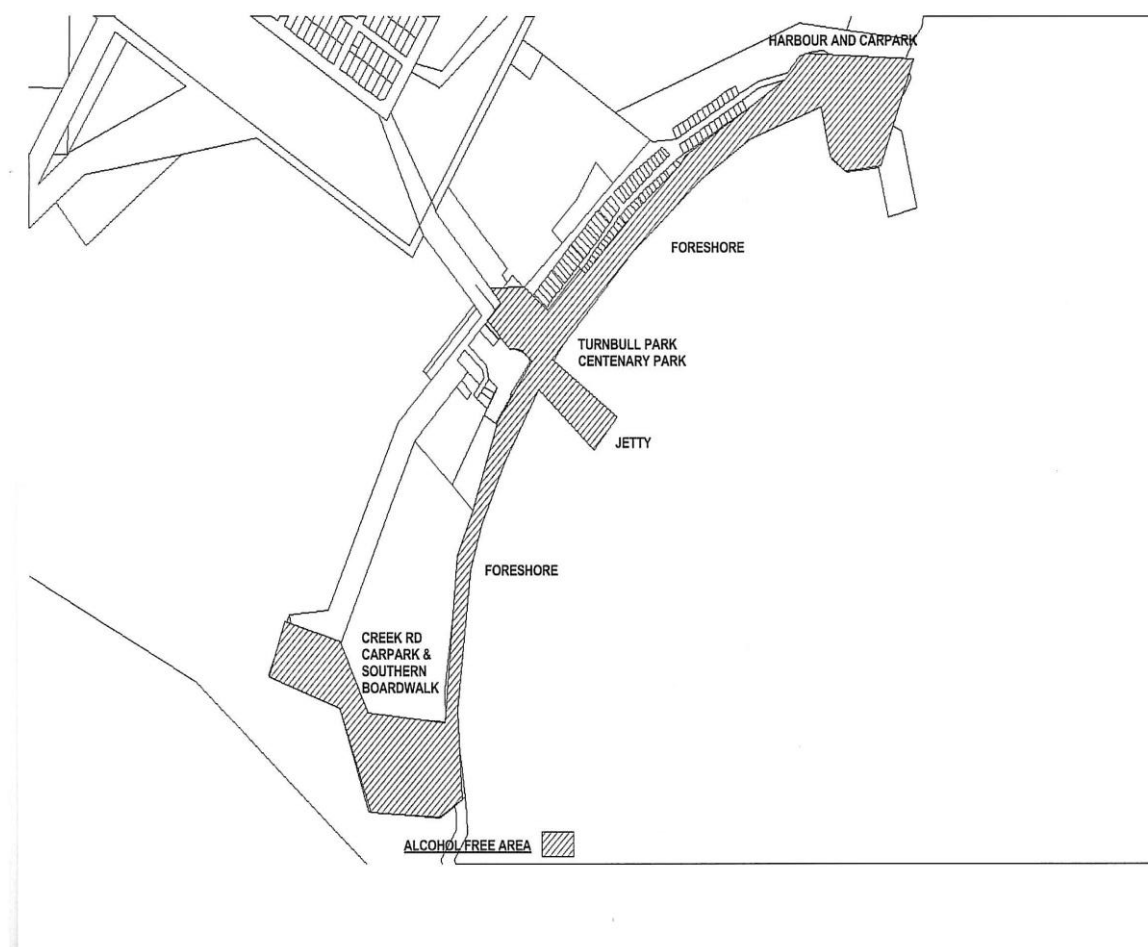

 - (i) the liquor is in the original container in which it was purchased from licensed premises; and
 - (ii) the container has not been opened; or
 - (b) a person who has possession of the liquor in the course of carrying on a business or in the course of his or her employment by another person in the course of carrying on a business; or
 - (c) a person who is permanently or temporarily residing at premises within the area or on the boundary of the area and who enters the area solely for the purpose of passing through it to enter those premises or who enters the area from those premises for the purpose of leaving the area.

Schedule – Kimba Area 1

1—Extent of prohibition

The consumption of liquor is prohibited and the possession of liquor is prohibited.

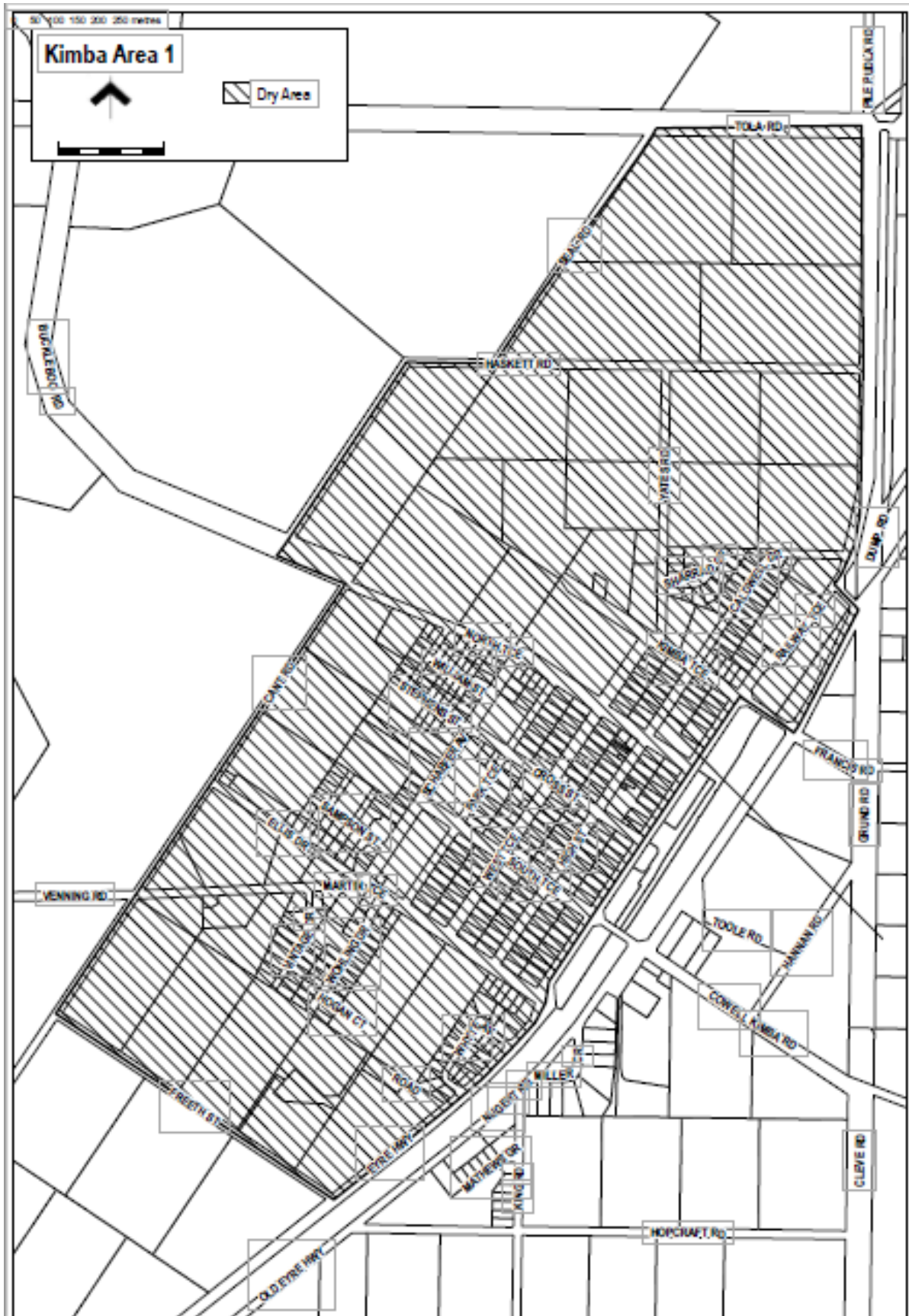
2—Period of Prohibition

From 9pm on 31 December 2023 until 8am 1 January 2024.

3—Description of area

Kimba Area 1

The area in and adjacent to Kimba bounded as follows: commencing at the point at which the prolongation in a straight line of the eastern boundary of Railway Terrace intersects the northern boundary of Tola Road, then westerly along the northern boundary of Tola Road to the point at which it is intersected by the prolongation in a straight line of the north-western boundary of Seal Road, then south-westerly along that prolongation and boundary of Seal Road to the northern boundary of Haskett Road, then westerly and south-westerly along that boundary of Haskett Road, and the prolongation in a straight line of that boundary, to the southern boundary of Buckleboo Road, then south-easterly along that boundary of Buckle boo Road to the north-western boundary of Cant Road, then south-westerly along that boundary of Cant Road to the point at which it is intersected by the prolongation in a straight line of the south-western boundary of Freeth Road, then south-easterly along that prolongation and boundary of Freeth Road, and the prolongation in a straight line of that boundary, to the south-eastern boundary of Eyre Highway, then generally north-easterly along that boundary of Eyre Highway to the southern side of the intersection at which Eyre Highway, South Terrace and Railway Terrace meet, then in a straight line by the shortest route (across the intersection) to the south-western end of the south-eastern boundary of Railway Terrace, then generally north-easterly along the south-eastern boundary of Railway Terrace to the south-western boundary of Kimba Terrace, then south-easterly along that boundary of Kimba Terrace to the north-western boundary of Eyre Highway, then generally north-easterly along that boundary of Eyre Highway to the south-western boundary of Grund Road, then north-westerly along that boundary of Grund Road to the south-eastern boundary of Railway Terrace, then generally north-easterly and northerly along that boundary of Railway Terrace, and the prolongation in a straight line of that boundary, to the point of commencement.
