FISHERIES (GULF ST. VINCENT PRAWN FISHERY
RATIONALISATION) ACT 1987: SECTION 8 (1)

TAKE notice that pursuant to section 8 (1) of the Fisheries (Gulf St Vincent Prawn Fishery Rationalisation) Act 1987 ('Act'), that as of 1 October 1999 ('the appointed day') the net liabilities of the fund under the Act is two million five hundred and fifty nine thousand, four hundred and eight dollars and thirty three cents (\$2 559 408.33) being the aggregate of compensation paid to former licensees and the amount expended in the purchase of vessels and equipment from former licensees before 1 October 1999 and the interest and charges, that had accrued up to 1 October 1999, in respect of money borrowed by the Minister under the Act, less the aggregate of the net amount realised from the sale of vessels and equipment under the Act before 1 October 1999 and the amount received by way of surcharges imposed under the Act.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Shane Roberts (hereinafter referred to as the 'permit holder'), c/o Ib Svane, P.O. Box 120, Henley Beach, S.A. 5022 is exempt from the Fisheries Act 1982, but only insofar as the permit holder shall not be guilty of an offence when taking blue

crabs (*Portunus pelagicus*) below the legal minimum length (hereinafter referred to as the 'permitted activity'), subject to the conditions specified in Schedule 1.

SCHEDULE 1

1. This permit is valid from 27 November 1999 to 2 December 1999.
2. The permit holder must notify the PIRSA Fisheries and Aquaculture Compliance Unit on 1800 065 522 at least two hours prior to conducting the permitted activity.
3. The permit holder may take up to a maximum of 50 blue crabs (*Portunus pelagicus*) below the legal minimum length.
4. The permit holder must comply with all instructions provided by the South Australian Research and Development Institute.
5. Whilst engaged in the permitted activity the permit holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries and Aquaculture Compliance Officer.
6. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.
