## FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that, pursuant to Section 115 of the Fisheries Management Act 2007, ('the Act') those classes of persons specified in Schedule 1 are exempt from Sections 71 and 72 (2) (b) of the Fisheries Management Act 2007, insofar as they may take, injure, damage, or otherwise harm, or possess White Shark also known as Great White or White Pointer Shark (*Carcharodon carcharias*) ('the exempt activity') in all waters of the State except waters contained within the boundaries of the Adelaide Dolphin Sanctuary and Marine Parks, subject to the conditions specified in Schedule 2, from 14 October 2011 until 14 October 2012, unless otherwise varied or revoked. Exemption No. 9902441.

## SCHEDULE 1

1. Fisheries Officers appointed under the Fisheries Management Act 2007; or

2. Members of the South Australia Police.

## SCHEDULE 2

1. Authorisation to carry out the exempt activity may only be granted in such circumstances where there is threat to human life and/or public safety and is in the public interest.

2. Subject to Condition 1 under Schedule 2, the exempt activity must not be carried out without the authorisation and at the direction of one of the following:

- (a) Executive Director, Fisheries and Aquaculture;
- (b) Director Policy, Fisheries and Aquaculture;
- (c) Director Operations, Fisheries and Aquaculture;
- (d) General Manager Compliance, Fisheries and Aquaculture;
- (e) Regional Manager, Fisheries and Aquaculture; and
- (f) Manager Offshore Patrol Operations, Fisheries and Aquaculture.

3. No authorisation is required if:

- (a) the threat to human life from shark attack is considered to be so imminent that seeking authorisation is not reasonably practicable; or
- (b) all reasonable attempts to contact the persons listed in Condition 2 under Schedule 2 have been unsuccessful.

## FISHERIES MANAGEMENT ACT 2007

*November Closure of Snapper Fishery*

ALL recreational and commercial fishers are reminded that the November prohibition on the taking of Snapper will apply from midday on 1 November to midday on 30 November 2011.

The closed season is designed to reduce overall fishing effort by all sectors and to maximise successful spawning of Snapper in South Australian waters.

During the closed period fishers are not permitted to target Snapper. This includes targeted catch and release fishing for Snapper. Any Snapper accidentally caught during the closure must be returned to the water immediately.

## FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that pursuant to Section 115 of the Fisheries Management Act 2007, Michael Hammer of Native Fish Australia (SA), 17 Homestead Drive, Aberfoyle Park, S.A. 5159 (the 'exemption holder'), or a person acting as his agent, is exempt from Sections 70 and 71 of the Fisheries Management Act 2007, but only insofar as the exemption holder may take fish species specified in Schedule 1 using the gear specified in Schedule 2 (the 'exempted activity'), subject to the conditions specified in Schedule 3, from 20 October 2011 until 20 October 2012, unless varied or revoked earlier.

## SCHEDULE 1

The collection of native fish from the inland waters, whole estuaries and nearshore marine habitats of South Australia (excluding River Murray specially protected area), including protected species of Genus Ambassidae, species of *Mogurnda* and *Nannoperca*, River Blackfish (*Gadopsis marmoratus*), Freshwater Catfish (*Tandanus tandanus*), Trout Cod (*Maccullochella macquariensis*), Silver Perch (*Bidyanus bidyanus*) and Murray Cod (*Maccullochella peelii*).

## SCHEDULE 2

- 1 Seine nets (maximum length 20 m, minimum mesh 10 mm).
- 1 Seine nets (maximum length 6 m, minimum mesh 4 mm).
- 1 Dab net per person.
- 2 Bait traps (600 mm x 400 mm, with 50 mm entrance).

## SCHEDULE 3

1. All fish of the genus Ambassidae, species of *Mogurnda* and *Nannoperca*, Freshwater Catfish, Trout Cod, Silver Perch, River Blackfish (*Gadopsis marmoratus*) and Murray Cod (*Maccullochella peelii*) collected pursuant to this notice must be returned to the water on completion of scientific evaluation.

2. All other native fish must be either returned to the water on completion of scientific evaluation or lodged with the South Australian Museum. All non-native fish must be destroyed and disposed of appropriately.

3. Before conducting the exempted activity, the exemption holder must contact PIRSA Fishwatch on 1800 065 522 and answer a series of questions about the exempted activity. You will need to have a copy of your exemption with you at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related issues. Exemption No. 9902483.

4. The exemption holder must provide a report in writing detailing the outcomes of the research and the collection of organisms pursuant to this notice to the Executive Director, Fisheries and Aquaculture, (G.P.O. Box 1625, Adelaide, S.A. 5001) within three months of the expiry of this notice, giving the following details:

- the date, soak time and location of collection;
- the number of nets used;
- the description of all species collected (fish, invertebrates, turtles);
- the number of each species collected; and
- any other information regarding size, breeding or anything deemed relevant or of interest that is able to be volunteered.

5. While engaging in the exempted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer if requested.

6. The exemption holder must not contravene or fail to comply with the Fisheries Management Act 2007, or any regulations made under that Act, except where specifically exempted by this notice.






