## CONTROLLED SUBSTANCES ACT 1984

#### *Fees and Charges*

I, JACK SNELLING, Minister for Mental Health and Substance Abuse, hereby give notice pursuant to Section 55 of the Controlled Substances Act 1984, of the following fees to apply for licences issued under the Act:

These charges will operate from 1 July 2014 to 30 June 2015.

#### 1. Annual fee for manufacturers licence:

(a) for a manufacturer who manufactures only Schedule 1 poisons .....	No fee
(b) for a manufacturer who manufactures Schedule 2 poisons .....	\$270.00
(c) for a manufacturer who manufactures Schedule 3 poisons .....	\$270.00
(d) for a manufacturer who manufactures Schedule 4 poisons .....	\$270.00
(e) for a manufacturer who manufactures Schedule 7 poisons .....	\$270.00
(f) for a manufacturer who manufactures drugs of dependence .....	\$353.00

#### Note—

The maximum cumulative annual fee is:

- for a manufacturer of poisons other than drugs of dependence is \$897.
- for a manufacturer of drugs of dependence is \$1 124.

#### 2. Annual fee for wholesale dealers licence:

(a) for a wholesaler who sells only Schedule 1 poisons .....	No fee
(b) for a wholesaler who sells Schedule 2 poisons .....	\$89.50
(c) for a wholesaler who sells Schedule 3 poisons .....	\$89.50
(d) for a wholesaler who sells Schedule 4 poisons .....	\$181.00
(e) for a wholesaler who sells Schedule 7 poisons .....	\$181.00
(f) for a wholesaler who sells drugs of dependence .....	\$353.00

#### Note—

The maximum cumulative annual fee is:

- for a wholesaler who sells poisons other than drugs of dependence is \$450.
- for a wholesaler who sells drugs of dependence is \$688.

4. Annual fee for medicine sellers licence ..... \$41.00

5. Annual fee for licence to supply, possess or administer:
- (a) S4 drugs (other than drugs of dependence) (Section 18) ..... \$89.50

DETERMINATION AND REPORT OF THE  
REMUNERATION TRIBUNAL

NO. 3 OF 2014

*Conveyance Allowance—Judges, Court Officers and  
Statutory Officers*

SCOPE OF DETERMINATION

THE Remuneration Tribunal is given jurisdiction under Sections 13 of the Remuneration Act 1990 (the Act), to determine the remuneration payable to the judiciary, magistrates and certain other judicial officers. The Tribunal is also given jurisdiction under Section 14 of the Act to determine the remuneration payable to holders of certain statutory public offices. The Act defines remuneration as including; salary, allowances, expenses, fees and any other benefit of a pecuniary nature.

This Determination deals with the conveyance allowance payable to Judges, Court Officers and those Statutory Officers whose position comes within the ambit of Section 14.

Section 8 of the Act requires the Tribunal to review at least once each year, any previous determination of remuneration made under the Act.

REPORT

The previous determination dealing with the conveyance allowance payable to Judges, Court Officers and Statutory Officers (Determination 4 of 2013) has been reviewed and updated. Accordingly, this Determination 3 of 2014 has been issued to replace Determination 4 of 2013.

The allowances at Clause 2 in this determination have been adjusted to reflect increases in the Fleet SA Annual Charges Payable.

In accordance with recent amendments to the Magistrates Act 1983, Clause 1.1 of this Determination has been varied by designating the Chief Magistrate as a Judge of the District Court and by removing the positions of Supervising Magistrate and Assistant Supervising Magistrate from the definition of 'judge'.

DETERMINATION

1. *Interpretation*

- 1.1 In this Determination, unless the contrary appears:

'Court Officer' means Commissioners of the Environment, Resources and Development Court;

'Executives' means persons appointed to an executive position under the Public Sector Act 2009;

'Judges' means any of the following members of the judiciary:

- the Chief Justice of the Supreme Court;
- Puisne Judges of the Supreme Court;
- Masters of the Supreme Court;
- the Chief Judge of the District Court;
- Judges of the Environment, Resources and Development Court;
- Masters of the District Court;
- Other District Court Judges;
- the Chief Magistrate (as a Judge of the District Court);

- the Deputy Chief Magistrate;
- Stipendiary Magistrates;
- the Supervising Industrial Magistrate;
- other Industrial Magistrates;
- the State Coroner;
- the Deputy State Coroner;
- the Senior Judge of the Industrial Relations Court and President of the Workers Compensation Tribunal;
- the President of the Industrial Relations Commission and Judge of the Industrial Relations Court;
- other Judges of the Industrial Relations Court who hold joint commissions in Fair Work Australia and the Industrial Relations Commission of South Australia.

'Registrar' means the 'Industrial Registrar' or 'Registrar' within the meaning of the Fair Work Act 1994 (SA) and the Workers Rehabilitation and Compensation Act 1986 (SA).

'Relevant authority' means:

- (a) the State Courts Administrator in relation to Judges and Court Officers;
- (b) the Registrar in relation to members of the Industrial Relations Court and Commission of South Australia, and the Workers Compensation Tribunal including members who are Statutory Officers;
- (c) the Director, Fleet SA in relation to other Statutory Officers.

'Retirement' bears the same meaning as in the Judges' Pensions Act 1971, the Superannuation Act 1988 and the Southern State Superannuation Act 2009.

'Resignation' bears the same meaning as in the Judges' Pensions Act 1971, the Superannuation Act 1988, and the Southern State Superannuation Act 2009.

'Statutory Officers' means any of the following statutory office holders:

- Deputy Presidents of the Industrial Relations Commission;
- Commissioners of the Industrial Relations Commission;
- the Auditor General;
- the Electoral Commissioner;
- the Deputy Electoral Commissioner;
- the Employee Ombudsman; and
- the Health and Community Services Complaints Commissioner.

- 1.2 For the purposes of this Determination, 'salary' bears the same meaning as in the Judges' Pensions Act 1971, Southern State Superannuation Act 2009, and in the Superannuation Act 1988, to the intent and effect that any amount paid by way of conveyance allowance is not 'salary', and that any abatement or reduction of salary in accordance with this Determination will not affect the determination of entitlements or obligations pursuant to those Acts.

2. *Conveyance Allowances*

2.1 Amount of Allowances

Subject to the conditions set out in this Determination, Judges, Court Officers and Statutory Officers are entitled to receive a Conveyance Allowance payable fortnightly at an annual rate as follows:

2.1.1 For:

- Judges of the Supreme Court;
- the Chief Judge of the District Court;
- the Senior Judge of the Industrial Relations Court;
- the President of the Industrial Relations Commission; and

the Auditor General;  
an amount which is the higher of:

- (a) \$20 118; and
- (b) the amount determined from time to time by Fleet SA as the annual charge payable by Executives for a Holden Calais VF V-Series Sedan, less the sum of \$758.

#### 2.1.2 For:

Judges of the District Court;  
the Chief Magistrate;  
Judges of the Industrial Relations Court;  
Judges of the Environment, Resources and Development Court;  
Masters of the Supreme Court;  
the Electoral Commissioner; and  
the Health and Community Services Complaints Commissioner;  
an amount which is the higher of:

- (a) \$17 751; and
- (b) the amount determined from time to time by Fleet SA as the annual charge payable by Executives for a Holden Calais VF Sedan, less the sum of \$758.

#### 2.1.3 For:

the Deputy Chief Magistrate;  
Stipendiary Magistrates;  
Industrial Magistrates;  
Masters of the District Court;  
the State Coroner;  
the Deputy State Coroner;  
Deputy Presidents (other than Judges) and Commissioners of the Industrial Relations Commission; and  
Commissioners of the Environment, Resources and Development Court;  
the Employee Ombudsman; and  
the Deputy Electoral Commissioner;  
an amount which is the higher of:

- (a) \$15 192; and
- (b) the amount determined from time to time by Fleet SA as the annual charge payable by Executives for a Holden Commodore VF Evoke Sedan, less the sum of \$758.

### 2.2 Part Time Appointees

Where a person to whom this Determination applies is appointed on a part time basis, that person is entitled to receive a Conveyance Allowance at a pro rata amount of the relevant allowance in Clause 2.1, based on the number of ordinary hours worked as a proportion of the full time equivalent.

### 2.3 Temporary Appointees

Where a person who is not provided with a vehicle in their substantive position is appointed on a temporary basis to act as a Judge, Court Officer or Statutory Officer, that person is entitled after the expiration of the first calendar month of service to receive a Conveyance Allowance in accordance with Clause 2.1.

### 2.4 Use of Taxis and Private Vehicles

#### 2.4.1 Judges and Court Officers

A Judge or Court Officer is not entitled to use a government fleet vehicle allocated to the Courts Administration Authority, or to engage taxis or hire car at the expense of the State Courts Administrator, or to seek the payment of any additional allowance for the use of a private vehicle, whether for official or unofficial purposes unless:

- (a) it has been certified by the State Courts Administrator that it was inefficient or not cost effective for the Judge or Court Officer to use the vehicle available for their official and private use; or
- (b) such use or engagement is consistent with a general direction given by the Chief Judicial Officer of the relevant Court, or in the case of Court Officers, the presiding officer of the relevant Tribunal, as to the circumstances where the vehicle available for official and private use, need not be used by reason of efficiency and cost effectiveness.

For members of the Industrial Relations Court and Commission of South Australia and the Workers Compensation Tribunal, the Registrar is the relevant approval authority.

An example of circumstances where such certification or general directions may be given is for journeys to and from the airport, where it may be more efficient or cost effective to use a taxi.

#### 2.4.2 Statutory Officers

A Statutory Officer must not engage a taxi or hire car, and is not entitled to the payment of any additional allowance for the use of a private vehicle, whether for official or unofficial purposes, unless it is inefficient or not cost effective to use the vehicle available for the Officer's official and private use.

#### 2.4.3 Amount of Reimbursement

Where any person subject to this determination is seeking payment of an additional allowance to cover the use of a private motor vehicle for official purposes, reimbursement of the cost will be made, calculated at the rate per kilometre at a rate equating to that pursuant to the SA Public Sector Salaried Employees Interim Award.

## 3. Vehicles for Official and Private Use

### 3.1 Selection of Vehicle

Persons who are subject to this Determination are entitled, in accordance with the conditions specified herein, to elect to have allocated to them a motor vehicle of any model and type in the attached Schedule of vehicles (as varied from time to time). Notice of the selected motor vehicle should be made in writing as follows:

- by Judges and Court Officers to the State Courts Administrator;
- by members of the Industrial Relations Court and Commission of South Australia and the Workers Compensation Tribunal of South Australia to the Registrar, including members who are Statutory Officers;
- by other Statutory Officers to the Director, Fleet SA.

The annual charge payable for each vehicle, determined by Fleet SA on the same basis as the calculation made in respect of the use of motor vehicles by Executives, and current at the date of this Determination, is set out in the Schedule.

### 3.2 Alternative Vehicle

An alternative vehicle may be supplied where required because of a medical disability or the family circumstances of a Judge, Court Officer or Statutory Officer, but only where approved by the Remuneration Tribunal. The annual charge for the use of the vehicle will be calculated on the same basis as the calculation made by Fleet SA for annual charges for use of motor vehicles by Executives.

### 3.3 Temporary Appointees

Persons appointed on a temporary basis to act as a Judge, Court Officer or Statutory Officer are not entitled to make an election under Clause 3.1.

### 3.4 Charges for Use of Vehicles

The amount payable by a Judge, Court Officer or Statutory Officer for the use of a selected vehicle is the amount set out in the Schedule adjacent to the description of the type of vehicle under the heading 'Annual Charge Payable'.

Where a person to whom this Determination applies is appointed on a part time basis, and elects pursuant to Clause 3.1 to have a motor vehicle, the charge payable by that person pursuant to Clause 3.5 shall be an amount determined by Fleet SA, which may be greater than the standard charge to a full time officer to appropriately reflect the proportionately greater private use of such a motor vehicle.

### 3.5 Payment of Vehicle Charges

If a Judge, Court Officer or Statutory Officer makes an election under Clause 3.1 and a vehicle is supplied in accordance with that election, then the salary and allowances otherwise payable to the Judge, Court Officer or Statutory Officer must be abated and reduced so as to offset the charges for the use of the vehicle for the period during which the Judge, Court Officer or Statutory Officer has the use of the vehicle.

### 3.6 New Models or Types

3.6.1 If a new type of vehicle, or a new model of a type specified in the Schedule becomes available for selection in terms of 3.1 after the date of election but before the placement of a binding order, the Judge, Court Officer, or Statutory Officer is entitled to withdraw the original election and elect to take the new model or type of vehicle.

3.6.2 The annual charge payable for a new model or new type of vehicle is that amount determined by Fleet SA as the annual charge for private use of the vehicle by Executives. The annual charge takes into account the following:

- purchase price and depreciation;
- fuel, maintenance, insurance and registration costs and interest rates; (operating costs are calculated on the basis of an average of 70% private usage);
- Goods and Services Tax (GST);
- Fringe Benefits Tax (FBT) based on an attributed business rate of 20 000 kilometres per year;
- the vehicle being retained for 3 years or 60 000 kilometres travelled, whichever first occurs.

3.6.3 If a model or type of vehicle selected by a Judge, Court Officer or Statutory Officer becomes unavailable before the placement of a binding order, the Judge, Court Officer or Statutory Officer must be advised accordingly and allowed to make a further election under Clause 3.1.

3.6.4 If a model becomes unavailable after the date of placement of a binding order and a later or better model vehicle is supplied, any Judge, Court Officer or Statutory Officer who has selected the unavailable vehicle is liable only to pay the annual charge for the vehicle as selected, and not the charge payable for the vehicle as supplied.

### 3.7 Accessories

The Judge, Court Officer or Statutory Officer may choose to have manufacturer approved accessories fitted to the vehicle. The full cost of the accessories and the expense of having them fitted (including any tax incurred) is payable by the Judge, Court Officer or Statutory Officer. When the vehicle is due for return the Judge, Court Officer or Statutory Officer may have personally-installed accessories removed from the vehicle, providing the Judge, Court Officer or Statutory Officer, meets the full cost of restoring the vehicle to the same condition as if the accessories had not been fitted. No compensation will be paid if options are left on the vehicle unless agreed by the relevant authority.

Options such as airbags, ABS brake systems and cruise control may not be removed, and tow bars must not be reinstalled on another vehicle.

### 3.8 Retention of Vehicle

Once having made an election and receiving the vehicle, the Judge, Court Officer or Statutory Officer must keep the vehicle for a period equivalent to the period determined from time to time by Fleet SA as the period for the replacement of vehicles provided to Executives.

At the conclusion of that period the Judge, Court Officer or Statutory Officer will be entitled to make a new election, or, if he or she does not make an election, to be paid the allowance.

### 3.9 Conditions of Use

The vehicle will be fully maintained, serviced and insured by the relevant authority.

Parking for the vehicle will be made available at or near the place of duty of the Judge, Court Officer, or Statutory Officer and the vehicle will be available for private and official use, subject to the following:

3.9.1 The Judge, Court Officer, or Statutory Officer must make the vehicle available for official use (including for official use by the Judge, Court Officer, or Statutory Officer) at all times whilst the vehicle is parked at or near the usual place of work of the Judge, Court Officer, or Statutory Officer, and the Judge, Court Officer or Statutory Officer, does not require the vehicle for private use.

3.9.2 The Judge, Court Officer, or Statutory Officer will be authorised by the relevant authority to refuel the vehicle provided the vehicle is fuelled in accordance with any requirements specified by Fleet SA, which may include requirements that the vehicle be fuelled using a particular brand of motor fuel and that it be only fuelled in South Australia. (If fuelled otherwise than in accordance with those requirements, it will be at the cost of the Judge, Court Officer, or Statutory Officer).

3.9.3 The Judge, Court Officer, or Statutory Officer must make the vehicle available as required by the relevant authority for the purposes of the maintenance and repair of the vehicle and must deliver the vehicle to such place as the relevant authority may specify for that purpose.

3.9.4 The relevant authority will ensure that Judges, Court Officers and Statutory Officers are insured (which may be pursuant to Government 'self-insurance') in respect of compulsory third party liability, third party property damage and any property damage to the vehicle and will hold the Judge, Court Officer, or Statutory Officer harmless in respect of any such property damage. Personal items within the vehicle need not be covered. The Judge, Court Officer, or Statutory Officer must comply with any requirements of the insurance policy of which the member is aware or should have been aware.

3.9.5 The Judge, Court Officer or Statutory Officer will be responsible for any driving or parking fines for offences incurred.

3.9.6 The vehicle is available to the Judge, Court Officer or Statutory Officer while on leave. Where the Judge, Court Officer or Statutory Officer is absent from duty for a period greater than 7 days then the Judge, Court Officer, or Statutory Officer will be responsible for fuelling the vehicle until returning to duty.

3.9.7 Vehicles may be driven interstate during periods of leave and there is no limit to privately travelled kilometres. Fuel charges for private interstate trips are entirely the personal responsibility of the Judge, Court Officer, or Statutory Officer.

## 3.10 Special Conditions of Use

Notwithstanding anything else in this Determination:

- 3.10.1 where any damage is the result of wilful or deliberate act of any person, the relevant authority may take such action as he or she thinks fit to recover the cost of such damage;
- 3.10.2 the insurance and discharges are not applicable if the driver is under the influence of drugs and/or alcohol;
- 3.10.3 the insurance and discharges are not applicable if the insurance has been brought to the attention of the Judge, Court Officer or Statutory Officer and is avoided by an action of the driver of the vehicle;
- 3.10.4 where the insurance policy contains an excess Clause, then the Judge, or Court Officer or Statutory Officer will be liable to repay the relevant authority the amount of that excess (or any part thereof) in the event that it becomes payable by reason of the driver of the vehicle being blameworthy for any of the damage giving rise to a claim on the policy when the vehicle is being used other than for official use.

## 3.11 Care of Vehicle

The Judge, Court Officer or Statutory Officer is responsible for ensuring that reasonable care is taken of the vehicle. Off street parking at the home of the person concerned is to be used if available and reasonable steps are to be taken to ensure its security. Where any damage to a vehicle supplied to a:

- 3.11.1 Judge or Court Officer is, in the opinion of the Courts Administration Council, the consequence of a serious breach of the obligations imposed by this Clause, the Judge, or Court Officer must, on demand, pay the Courts Administration Authority the proper cost of rectification of such damage;
- 3.11.2 Statutory Officer is, in the opinion of the Director, Fleet SA, the consequence of a serious breach of the obligations imposed by this Clause, the Statutory Officer concerned must, on demand, pay to Fleet SA the proper cost of rectification of such damage; and
- 3.11.3 Member of the Industrial Relations Court and Commission of South Australia and the Workers Compensation Tribunal, including a member who is a Statutory Officer, is, in the opinion of the Registrar, the consequence of a serious breach of the obligations imposed by this Clause, the Member concerned must, on demand, pay to the Tribunal the proper cost of rectification of such damage.

## 3.12 Additional Drivers

The vehicle may be driven by any other Government employee who requires the vehicle for official use.

Judges, Court Officers, and Statutory Officers, must nominate to the relevant authority the names of any persons to use the vehicle at times when it is not required to be available for official use and, subject to the control and direction of the Judge, Court Officer or Statutory Officer, such persons will be authorised to use the vehicle upon such nomination.

Approval is required from the relevant authority for the vehicle to be driven by holders of any form of provisional licence or learner's permit. Approval is also required if any other category of person not otherwise mentioned, is to drive the vehicle.

## 3.13 Right to Purchase

At any time during the 12 months immediately preceding the date of his or her retirement or resignation, a Judge, Court Officer, or Statutory Officer may, by notice in writing to the relevant

authority, elect to purchase the vehicle then allocated to him or her as at the date of his or her retirement or resignation or at the end of the lease period. After such notification has been given, the relevant authority must take such steps as are necessary to ensure that it can sell the vehicle to the member.

## 3.14 No Changeover

A Judge, Court Officer or Statutory Officer who makes an election under Clause 3.13 shall not be permitted or required to hand a vehicle in for normally scheduled changeover where that changeover would occur between the date of election and the date of retirement/resignation/end of lease period.

## 3.15 Conditions of Purchase

The conditions of in relation to a purchase made following an election under Clause 3.13 shall be:

- 3.15.1 The price will be the fair market value for such a vehicle sold without any statutory warranty.
- 3.15.2 The price will be agreed between the Director, Fleet SA, and the Judge, Court Officer or Statutory Officer, due regard being had to prices generally recovered for such vehicles at Fleet SA public auctions.
- 3.15.3 Failing such agreement, the price will be determined by an independent valuer agreed by the parties. Where the prospective retiree/resignee is a:
  - 3.15.3.1 Judge or Court Officer, any fee payable to such a valuer shall be borne in equal shares by the prospective retiree/resignee and the State Courts Administrator;
  - 3.15.3.2 Statutory Officer, any fee payable to such a valuer shall be borne in equal shares with half payable by the respective retiree/resignee and the other half being payable from funds appropriated to pay expenses associated with the statutory office held by the retiree/resignee; and
  - 3.15.3.3 Member of the Industrial Relations Court and Commission of South Australia and the Workers Compensation Tribunal, including a member who is a Statutory Officer, any fee payable to such a valuer shall be borne in equal shares by the prospective retiree/resignee and the Registrar.
- 3.15.4 The price shall be payable in full on, or prior to, the date of retirement/resignation of the Judge, Court Officer or Statutory Officer.

## 4. Date of Operation

- 4.1 The Conveyance Allowances prescribed in Clause 2.1 are operative from 1 July 2014.
- 4.2 If a Judge, Court Officer or Statutory Officer currently has the use of a vehicle pursuant to a previous Determination of the Remuneration Tribunal, the Conveyance Allowance and Annual Charge Payable under the previous Determination will continue to apply. Clause 2 and the Schedule to this Determination will have no effect until that Judge, Court Officer or Statutory Officer takes delivery of a vehicle pursuant to this Determination, or elects not to receive a vehicle.
- 4.3 This Determination replaces in entirety Determination 4 of 2013.

3. Fishing must cease if one of the following limits is reached:

- (a) A total of 14 nights of fishing are completed;
- (b) The average catch per vessel, per night (for all three vessels) drops below 300 kg for two consecutive nights;
- (c) The average prawn 'bucket count' for all three vessels exceeds 240 prawns per bucket on any single fishing night in the Coffin Bay area; or
- (d) The average prawn 'bucket count' for all three vessels exceeds 240 prawns per bucket on any single fishing night in the Venus Bay area; or
- (e) The average prawn 'bucket count' for all three vessels exceeds 270 prawns per bucket on any single fishing night in the Ceduna area.

4. The fleet must nominate a licence holder to provide a daily update by telephone or SMS message to the PIRSA Fisheries Manager, to report the average prawn catch per vessel and the average prawn 'bucket count' information.

5. No fishing activity may be undertaken between the prescribed times of sunrise and sunset for Adelaide (as published in the *South Australian Government Gazette* pursuant to the requirements of the Proof of Sunrise and Sunset Act 1923) during the period specified in Schedule 3.

FEES for storage, slipping, straddle carrier use and boat movements in Boat Yards at Port MacDonnell, Beachport and Kingscote are charged to recover some of the costs associated with the operation and administration of these facilities.

All of the fees and charges listed below are inclusive of GST.

##### *Port MacDonnell Boat Yard*

A boat yard fee is to be charged at the Port MacDonnell boat yard for all boats or trailers as follows:

- \$700 per boat or trailer for 12 months; or
- \$175 per boat or trailer per month or part thereof.

The fee entitles recipients to boat or trailer storage and unlimited use of the dirty work area for the period paid.

##### *Beachport Boat Yard*

A boat yard fee is to be charged at the Beachport boat yard for all boats at \$4 016 per boat for one year or part thereof. This fee entitles the recipient to boat storage, 4 slippages, 4 yard shifts using the straddle carrier and unlimited use of the dirty work area for one year.

A casual boat storage fee is to be charged at the Beachport boat yard for all boats at \$604 per month or part thereof.

A casual slipping fee (up to two hours) is to be charged at the Beachport boat yard for all boats at \$377.

A casual yard shift fee is to be charged for use of the straddle carrier to move a boat in one operation within the boat yard for all boats at \$249.

Additional to the above and only when applicable, an after hours yard shift fee or an after hours slipping fee of \$139 may apply.

##### *Slipway Fees—Kingscote*

Use of the Kingscote slipway will be charged a fee of \$146 per day or part thereof.

##### *Navigation Services Charge*

THE Navigation Services Charge is to recover the costs of providing navigation aids to commercial shipping using the State's indentured ports of Port Bonython and Whyalla. This will be a charge to boats on the basis of the number of times the boat enters State waters from outside those waters and proceeds to an indentured or private port in the State.

Note: Other charging arrangements have been made and apply to the ports of Ardrossan, Klein Point, Port Adelaide, Port Giles, Port Lincoln, Port Pirie, Thevenard and Wallaroo.

The base charge (GST inclusive) to be applied is \$1 432 + \$0.15769 per Gross Tonnage (GT) per trading voyage within South Australian waters.

The base charge will be reduced by 25% for each subsequent call of the commercial boat after the first call and within six months of the first call, (i.e. 100% of base charge for first call; 75% for second call within six months of the first call; 50% for the third call; 25% for the fourth call). No Navigation Services Charge will be payable for the fifth call and any subsequent call, provided they occur within six months of the first call.

Alternatively, an option of a one-off, up-front payment of 2.3 times the base charge for unlimited calls by the one commercial boat in a six month period is available. Application must be made prior to the entry of the boat into South Australian waters.

##### *Harbor Services Charge (Applied at Port Bonython Only)*

The Harbor Services Charge is to recover the costs of servicing boats in port and at berths.

The base charge (GST inclusive) to be applied is \$3 851 + \$0.00715 per Gross Tonnage (GT) of the boat per hour at berth.

(1) unless the contrary intention appears—

**admitted patient** means a patient of a public hospital site who has undergone the formal admission process of the public hospital site;

**Commonwealth benefit**, in relation to a patient, means the aggregate of the following amounts:

- (a) the maximum amount (expressed on a daily basis) payable as an age pension under the *Social Security Act 1991* of the Commonwealth to a person who is not a member of a couple within the meaning of that Act, excluding the amount of any pharmaceutical allowance payable under that Act; and
- (b) —
  - (i) if the patient receives rent assistance under that Act—the amount (expressed on a daily basis) received; or
  - (ii) if the patient is not entitled to an age pension or disability support pension under that Act—the maximum amount (expressed on a daily basis) payable as rent assistance under that Act;

**hospital in the home service**, in relation to a public hospital site, means treatment or care provided by the public hospital site to a patient at a location outside of the public hospital site's premises (being treatment or care provided as a direct substitute for treatment or care that would normally be provided as an inpatient service on the public hospital site's premises);

**incorporated hospital** means a hospital incorporated under the *Health Care Act 2008*;

**long stay patient** means a patient who has been an admitted patient in a public hospital site for a continuous period exceeding 35 days;

**Medicare patient** means a patient who is an eligible person for the purpose of receiving medical benefits under the *Health Insurance Act 1973* of the Commonwealth;

**overnight stay patient** means an admitted patient of a public hospital site who remains an admitted patient of the public hospital site until a day subsequent to the day of his or her admission;

**patient** means a person to whom a public hospital site provides medical or diagnostic services or other treatment or care and includes a person to whom a public hospital site provides outreach services;

**private**, in relation to a patient, connotes that the patient receives medical or diagnostic services from a medical practitioner selected by the patient;

**public**, in relation to a patient, connotes that the patient receives medical or diagnostic services from a medical practitioner selected by the public hospital site;

**public hospital site** means a hospital facility which is operated by and is part of an incorporated hospital and which can have buildings and facilities at more than one location in the State;

**same day patient** means an admitted patient of a public hospital site who, on the same day, is both admitted to and leaves the care of the public hospital site (whether on formal discharge by the public hospital site or voluntary discharge by the patient);

**single room**, in relation to the accommodation of a patient, means the accommodation of the patient in a room in which he or she is the only patient.

- (2) a patient will be regarded as being acutely ill during a particular period if a medical practitioner has certified that the patient will require extensive medical treatment and supervision during that period.
- (3) A certificate referred to in subsection (2) remains in force for the period specified in the certificate (not exceeding 30 days) or, if no period is specified, for a period of 30 days.

### **1—Fees for services provided to Medicare patients**

- (1) The fee to be charged by a public hospital site for a service of a kind set out in the Schedule provided to a Medicare patient who is not a compensable patient is as set out in the Schedule.
- (2) A person who is—
  - (a) a resident of a State or Territory of the Commonwealth other than South Australia; or

## Interpretation

- (1) unless the contrary intention appears—

**Act** means the *Health Care Act 2008*;

**admission** means the formal administrative process of a public hospital site by which a patient commences a period of treatment, care and accommodation in the public hospital site;

**admitted**, in relation to a patient, means a patient who has undergone the formal admission process of a public hospital site;

**compensable patient** means a patient receiving services from a public hospital site who is, or may be, entitled to payment, or has received payment, by way of compensation in respect of the injury, illness or disease for which the patient is receiving those services;

**day** means 24 hours (whether a continuous period or in aggregate);

**discharge** means the formal administrative process of a public hospital site by which a patient ceases a period of treatment, care and accommodation in that public hospital site;

**discharged**, in relation to a patient, means a patient who has undergone the formal discharge process of a public hospital site;

**health professional** includes a person employed to provide training or instruction to patients or their carers in relation to patient treatment and care;

**incorporated hospital** means a hospital incorporated under the *Health Care Act 2008*.

**Medicare patient** means a patient who is an eligible person for the purposes of receiving medical benefits under the *Health Insurance Act 1973* of the Commonwealth;

**non-admitted**, in relation to a patient, means a patient who is not an admitted patient;

**outreach service**, in relation to a public hospital site, means treatment or care provided by the public hospital site to a non-admitted patient at a location outside the public hospital site premises (being treatment or care provided as a direct substitute for treatment or care that would normally be provided on the public hospital site premises);

**patient** means a person to whom a public hospital site provides treatment or care (including outreach services or domiciliary maintenance and care);

**private**, in relation to a patient, connotes that the patient receives medical or diagnostic services from a medical practitioner selected by the patient;

**public**, in relation to a patient, connotes that the patient receives medical or diagnostic services from a medical practitioner selected by the public hospital site of which he or she is a patient;

**public hospital site** means a hospital facility which is operated by and is part of an incorporated hospital and which can have buildings and facilities at more than one location in the State;

**retrieval team** means a team of health professionals, at least one of whom is a medical practitioner, with specialist expertise in the treatment and care of seriously ill or seriously injured patients during transportation;

**salaried medical officer**, in relation to a public hospital site, means a medical practitioner who is employed by the employing authority under the *Health Care Act 2008*.

## Determination of fees

### Fees

- (1) Subject to subsection (3) and (4), the fee to be charged by a public hospital site for services of a kind set out in Schedule 1 provided to an admitted patient—
  - (a) who is a compensable patient,  
is the fee set out in, or determined in accordance with, that Schedule.
- (2) Subject to subsection (3) and (4), the fee to be charged by a public hospital site for services of a kind set out in Schedule 2 provided to an admitted patient—
  - (a) who is not a Medicare patient,  
is the fee set out in, or determined in accordance with, that Schedule.
- (3) Subject to subsection (3) and (4), the fee (or, where specified, the maximum fee) to be charged by a public hospital site for services of a kind set out in Schedule 3 provided to a non-admitted patient—
  - (a) who is a compensable patient; or
  - (b) who is not a Medicare patient,  
is the fee set out in, or determined in accordance with, that Schedule.
- (4) Subject to subsection (4), the fee (or, where specified, the maximum fee) to be charged by a public hospital site for services of a kind set out in Schedule 4 provided to a patient—
  - (a) who is a compensable patient; or
  - (b) who is not a Medicare patient,  
is the fee set out in, or determined in accordance with, that Schedule.
- (5) The fee to be charged by a public hospital site for services of a kind set out in Schedule 4A provided to a public patient—
  - (a) who is not a compensable patient; and
  - (b) who is not a Medicare patient,  
is the fee set out in, or determined in accordance with, that Schedule.

### Discount or remission of fees

A public hospital site may discount payment of, or remit, the whole or any part of a fee payable to it.

## Schedule 1— Incorporated hospitals and public hospital sites: fees for admitted patients who are compensable patients

### 1—Interpretation

- (1) In this Schedule, unless the contrary intention appears—

**AR-DRG** means Australian Refined Diagnosis Related Group;

**leave hour** means an hour for which an admitted patient of a public hospital site is on leave from the public hospital site without being discharged from the public hospital site;

**maintenance care** (formerly Nursing Home Type care) means treatment and care of an admitted patient in which the treatment goal is to prevent deterioration in the patient's health or ability to function and where care over an indefinite period, but not further complex assessment or stabilisation, is required;

**Manual** means the *Australian Refined Diagnosis Related Groups, Version 6.0, Definitions Manual*, released in November 2008 by the Commonwealth Department of Health and Ageing;

**rehabilitation**, or **rehabilitation care**, means the treatment and care of a patient with an impairment, disability or handicap in which the treatment goal is to improve the ability of the patient to function;

**rounded to the nearest hour**, in relation to the determination of a number of hours, means that where a number of hours includes a fraction of an hour, the number is to be rounded up to the nearest whole hour if the fraction consists of 30 minutes or more and rounded down to the nearest whole hour (or, where necessary, to zero) if the fraction consists of less than 30 minutes;

- (2) For the purposes of this Schedule—

- (a) AR-DRG reference numbers or descriptions are as set out in the Manual; and
- (b) terms and abbreviations used in AR-DRG descriptions have the meanings given by the Manual.

- (3) A reference in this Schedule to a Table of a specified number in this Schedule is a reference to the Table of that number in clause 9.

### 2—Determination of applicable AR-DRG

For the purposes of this Schedule, the AR-DRG applicable to a patient must be determined in accordance with the guidelines contained in *South Australian Morbidity Coding Standards and Guidelines (Inpatients)*, effective 1 July 2006, published by the Department of Health.

### 3—Standard fee for admitted patients

Subject to this Schedule, the fee to be charged by a public hospital site for a period of treatment, care and accommodation of an admitted patient to whom an AR-DRG specified in the first and second columns of Table 3 in this Schedule is applicable must be calculated as follows:

$$\text{Fee} = \text{Price} \times \text{Cost Weight}$$

where—

- (a) the **Price** is the price specified in the second column of Table 1 in this Schedule; and
- (b) the **Cost Weight** is the cost weight specified in the third or fourth column of Table 3 in this Schedule according to the patient classification (public or private) specified in those columns for the AR-DRG applicable to the patient.

### 4—Fee for rehabilitation or maintenance care

Despite clause 3, the fee to be charged by a public hospital site for a period of treatment, care and accommodation of an admitted patient where the treatment and care consists of rehabilitation or maintenance care must be calculated as follows:

$$\text{Fee} = \text{Price} \times \text{LOS}$$

where—

- (a) the **Price** is the price specified in the third column of Table 2 in this Schedule according to the patient classification (public or private) specified in the first column and the type of treatment or care specified in the second column of the Table; and
- (b) the **LOS** (length of stay) means the number of hours (rounded to the nearest hour) between—
  - (i) the admission of the patient to the public hospital site or, where the patient receives maintenance care, the commencement of maintenance care, whichever is the later; and
  - (ii) the discharge of the patient from the public hospital site, excluding any leave hours (rounded to the nearest hour) for the patient during that period, expressed as a figure in days (including parts of days) and rounded up to the nearest whole day.

### 5—Medical or diagnostic services not included in fees for private patients

In the case of a private patient, a fee determined in accordance with this Schedule does not include a fee for the cost of medical or diagnostic services provided by a medical practitioner selected by the patient.

## 6—Retrieval fee (admitted patients)

Where a retrieval team provided by a public hospital site or SA Ambulance Service monitors and treats a seriously ill or seriously injured admitted patient of that or any other public hospital site during the transportation of the patient to a the public hospital site or to another facility of the public hospital site, the fee to be charged by the public hospital site or SA Ambulance Service providing the retrieval team is as follows:

Provision of retrieval team—\$2 679.00

## 7—Transportation fee

- (1) Where, in addition to providing a service referred to in this Schedule, a public hospital site transports, or arranges for the transportation of, a patient to or from (or between different facilities of) the public hospital site, the public hospital site may charge an additional fee equal to the cost to the public hospital site of providing, or arranging for the provision of, that transportation.
- (2) Subclause (1) does not apply to the transportation of a patient with a retrieval team provided by the public hospital site.

## 8—Other fees

- (1) Pharmaceutical Reform arrangements

For public hospital sites participating in the pharmaceutical reform arrangements under the agreement between the South Australian and the Australian Government the following fees apply for pharmaceuticals provided to admitted patients on discharge:

- (i) For compensable patients:
  - (a) For the supply of Pharmaceutical Benefit Scheme items (per item) the community co-payment rate for pharmaceuticals as set under the Commonwealth *National Health Act 1953* each year on 1 January.
  - (b) For the supply of non-Pharmaceutical Benefit Scheme items (per item) an amount that is the cost to the public hospital (using a full cost recovery principle) for supply of that item.

## **Schedule 2— Incorporated hospitals and public hospital sites: fees for admitted patients who are not Medicare patients**

### **1—Standard fee for admitted patients**

Fee for treatment, care and accommodation of an admitted patient who is not a Medicare patient — per day or part day \$1 907.00

### **2—Medical or diagnostic services not included in fees for private patients**

In the case of a private patient, a fee determined in accordance with this Schedule does not include a fee for the cost of medical or diagnostic services provided by a medical practitioner selected by the patient.

### **3—Retrieval fee (admitted patients)**

Where a retrieval team provided by a public hospital site or SA Ambulance Service monitors and treats a seriously ill or seriously injured admitted patient of that or any other public hospital site during the transportation of the patient to a the public hospital site or to another facility of the public hospital site, the fee to be charged by the public hospital site or SA Ambulance Service providing the retrieval team is as follows:

Provision of retrieval team—\$2 679.00

### **4—Transportation fee**

- (1) Where, in addition to providing a service referred to in this Schedule, a public hospital site transports, or arranges for the transportation of, a patient to or from (or between different facilities of) the public hospital site, the public hospital site may charge an additional fee equal to the cost to the public hospital site of providing, or arranging for the provision of, that transportation.
- (2) Subclause (1) does not apply to the transportation of a patient with a retrieval team provided by the public hospital site.

### **5—Other fees**

- (1) Pharmaceutical Reform arrangements

For public hospital sites participating in the pharmaceutical reform arrangements under the agreement between the South Australian and the Australian Government the following fees apply for pharmaceuticals provided to admitted patients on discharge:

- (i) For patients who are not a Medicare patient for the supply of non-Pharmaceutical Benefit Scheme and Pharmaceutical Benefit Scheme items (per item) an amount that is the cost to the public hospital (using a full cost recovery principle) for supply of that item.

## Schedule 3— Incorporated hospitals and public hospital sites: fees for non-admitted patients that are compensable patients or are not Medicare patients

### 1—Interpretation

- (1) In this Schedule, unless the contrary intention appears—

**disposition category**, in relation to a non-admitted patient of a public hospital site, means the disposition category of the patient following an occasion of service provided by an emergency department of the public hospital site, being one of the following:

- (a) *admitted*—where the patient is admitted to the public hospital site, transferred to another public hospital site or provided with outreach services;
- (b) *died*—where the patient dies in the emergency department after treatment or care has commenced (this excludes patients who are dead on arrival at the public hospital site);
- (c) *home*—where the patient (not being a patient referred to in paragraph [a] or [b]) leaves the emergency department after treatment or care has commenced (whether or not treatment or care has been completed);

**emergency department (ED)**, in relation to a public hospital site, means a designated accident and emergency department of the public hospital site that provides emergency treatment and care to non-admitted patients;

**emergency department service** means treatment or care provided by an emergency department of a public hospital site;

**emergency occasion of service** means an occasion of service in which emergency treatment or care is provided by a public hospital site;

**group occasion of service**, in relation to outpatient services provided by a public hospital site to a non-admitted patient, means each occasion on which—

- (a) the same treatment or care is provided by the outpatient clinic to two or more patients; or
- (b) treatment or care by more than one medical practitioner or other health professional is provided by the clinic to the same patient;

**occasion of service**, in relation to services provided by a public hospital site, means each occasion on which treatment or care is provided by the public hospital site to a non-admitted patient and includes any diagnostic or imaging services (other than Magnetic Resonance Imaging) performed as part of that treatment or care;

**outpatient clinic**, in relation to a public hospital site, means a designated outpatient clinic of the public hospital site that provides non-emergency treatment and care (usually by appointment) to non-admitted patients;

**outpatient service** means treatment or care provided by the outpatient clinic of a public hospital site;

**outreach occasion of service** means an occasion of service in which outreach services are provided by a public hospital site;

**prescription item** means—

- (a) a pharmaceutical or other item supplied on the prescription of a medical practitioner, dentist or other person authorised to prescribe the item; or
- (b) an ancillary item required for the administration of such pharmaceutical or other item;

**SMO** means salaried medical officer;

**specialist, teaching, other metropolitan, country Accident and Emergency SMO, large country** and **other country**, in relation to the emergency department or outpatient classification of a public hospital site, means a public hospital site referred to in the first column of the Table in Schedule 4 whose emergency department or outpatient classification is identified in the second or third columns of that Table as specialist, teaching, other metropolitan, country Accident and Emergency SMO, large country or other country, as the case may be;

**triage**, in relation to a non-admitted patient of a public hospital site, means an assignment by the public hospital site to the patient of a classification of the level of urgency of the treatment required by the patient on an occasion of service in an emergency department of the public hospital site, determined in accordance with the following scale:

- (a) *triage 1*—Resuscitation, where the patient requires treatment within seconds;
  - (b) *triage 2*—Emergency, where the patient requires treatment within 10 minutes;
  - (c) *triage 3*—Urgent, where the patient requires treatment within 30 minutes;
  - (d) *triage 4*—Semi-urgent, where the patient requires treatment within 60 minutes;
  - (e) *triage 5*—Non-urgent, where the patient requires treatment within 120 minutes.
- (2) A reference in this Schedule to a Table of a specified number in this Schedule is a reference to the Table of that number in clause 9.

## **2—Fee for emergency department or emergency occasion of service**

- (1) The fee to be charged by a public hospital site for an occasion of service provided by an emergency department of the public hospital site to a non-admitted patient must be calculated as follows:

$$\text{Fee} = \text{ED Price} \times \text{ED Cost Weight}$$

where—

- (a) the ED Price is the price specified in the second or third column of Table 1 in this Schedule (according to the classification of the patient as public or private) for an emergency department service; and

- (b) the ED Cost Weight is the cost weight specified in the third, fourth, fifth, sixth or seventh column (according to the emergency department classification of the public hospital site providing the service) of Table 2 in this Schedule for the disposition category and triage of the patient specified in the first and second columns of the Table.
- (2) Where the emergency department classification of a public hospital site is **other country**, the fee to be charged by the public hospital site for an emergency occasion of service provided by the public hospital site to a non-admitted patient must be calculated as follows:

$$\text{Fee} = \text{ED Price} \times \text{Emergency Service Cost Weight}$$

where—

- (a) the ED Price is the price specified in the second or third column of Table 1 in this Schedule (according to the classification of the patient as public or private) for an emergency department service; and
- (b) the Emergency Service Cost Weight is 0.406.

### 3—Fee for outpatient of occasion of service

The fee to be charged by a public hospital site for an occasion of service provided by an outpatient clinic of the public hospital site to a non-admitted patient must be calculated as follows:

$$\text{Fee} = \text{OP Price} \times \text{OP Cost Weight}$$

where—

- (a) the OP Price is the price specified in the second or third column of Table 1 in this Schedule (according to the classification of the patient as public or private) for an outpatient service; and
- (b) the OP Cost Weight is the cost weight specified in the second, third, fourth, fifth or sixth column (according to the outpatient classification of the public hospital site providing the service) of Table 3 in this Schedule for the category of the treatment or care provided that is specified in the first column of the Table.

### 4—Fee for outpatient group occasion of service

The fee to be charged by a public hospital site for a group occasion of service provided by an outpatient clinic of the public hospital site to a non-admitted patient must be calculated as follows:

$$\text{Fee} = \text{OP Price} \times \text{OP Cost Weight}$$

where—

- (a) the OP Price is the price specified in the second or third column of Table 1 in this Schedule (according to the classification of the patient as public or private) for an outpatient service; and
- (b) the OP Cost Weight is the cost weight specified in the second, third, fourth, fifth or sixth column (according to the outpatient classification of the public hospital site providing the service) of Table 4 in this Schedule for the category of treatment or care provided that is specified in the first column of the Table.

## 5—Fee for outreach occasion of service

The fee to be charged by a public hospital site for an outreach occasion of service provided by the public hospital site to a non-admitted patient must be calculated as follows:

$$\text{Fee} = \text{Outreach Price} \times \text{Outreach Cost Weight}$$

where—

- (a) the Outreach Price is the price specified in the second or third column of Table 1 in this Schedule (according to the classification of the patient as public or private) for an outreach service; and
- (b) the Outreach Cost Weight is the cost weight specified in the second column of Table 5 in this Schedule for the category of the treatment or care provided that is specified in the first column of the Table.

## 6—Additional fees

The fees specified below (payable in addition to any other fee prescribed in this Schedule for an occasion of service) are to be charged by a public hospital site for the provision to a non-admitted patient of the services specified:

- (a) Magnetic Resonance Imaging (maximum fee per scan)—\$690.00;
- (b) for public hospital sites not participating in arrangements under the Pharmaceutical Reform Agreement the fee for the supply of a prescription item (per item)—\$29.50
- (c) for public hospital sites participating in arrangements under the Pharmaceutical Reform Agreement between South Australia and the Commonwealth of Australia, the following charges apply for the provision of pharmaceuticals if supplied on discharge from the public hospital site and/or provided as part of an outpatient consultation:
  - (i) For compensable patients:
    - (a) For the supply of Pharmaceutical Benefit Scheme items (per item) the community co-payment rate for pharmaceuticals as set under the Commonwealth *National Health Act 1953* each year on 1 January—\$36.90
    - (b) For the supply of non-Pharmaceutical Benefit Scheme items (per item) an amount that is the cost to the public hospital (using a full cost recovery principle) for supply of that item
  - (ii) For non-Medicare patients for the supply of non-Pharmaceutical Benefit Scheme and Pharmaceutical Benefit Scheme items (per item) an amount that is the cost to the public hospital (using a full cost recovery principle) for supply of that item

**7—Retrieval fee (non-admitted patients)**

Where a retrieval team provided by a public hospital site or SA Ambulance Service monitors and treats a seriously ill or seriously injured patient (who is not an admitted patient of any public hospital site) during the transportation of the patient to a public hospital site, the fee to be charged by the public hospital site or SA Ambulance Service providing the retrieval team is as follows:

Provision of retrieval team—\$2 679.00.

**8—Transportation fee**

- (1) Where, in addition to providing a service referred to in this Schedule, a public hospital site transports, or arranges for the transportation of, a non-admitted patient to or from (or between different facilities of) the public hospital site, the public hospital site may charge an additional fee equal to the cost to the public hospital site of providing, or arranging for the provision of, that transportation.
- (2) Subclause (1) does not apply to the transportation of a patient with a retrieval team provided by the public hospital site.

**occasion of service** means an occasion on which treatment or care is provided to a non-admitted patient and includes any diagnostic or imaging services performed as part of that treatment or care;

**South Australian Government Funded public non-Medicare patient (SAG patient)** means a public patient—

- (a) who is not a compensable or Medicare patient; and
- (b) who the Australian Cranio Facial Unit has undertaken in writing to admit for specified treatment or care as a SAG patient for no fee;

**Women's and Children's Hospital** means the Women's and Children's Hospital facility of the Children, Youth and Women's Health Service Incorporated.

### **2—Fee for SAG patient**

- (1) No fee is to be charged by a public hospital site for Australian Cranio Facial Unit or related treatment or care of a South Australian Government Funded public non-Medicare patient.

- (2) In this clause—

**Australian Cranio Facial Unit or related treatment or care**, in relation to a SAG patient, means the following:

- (a) a period of treatment, care and accommodation of an admitted patient by the Australian Cranio Facial Unit, or an occasion of service provided to a non-admitted patient by that Unit, where the treatment, care and accommodation, or occasion of service, forms part of the treatment or care for which the patient was admitted as a SAG patient;
- (b) a period of treatment, care and accommodation of an admitted patient by a public hospital site, or an occasion of service provided to a non-admitted patient by a public hospital site, where the treatment, care and accommodation, or occasion of service, is arranged by the Australian Cranio Facial Unit and is related to treatment or care of the patient by that Unit;

- (c) accommodation for a patient between or following admissions or occasions of service referred to above where the Australian Cranio Facial Unit determines that it is necessary for the proper treatment and care of the patient for the patient to remain in this State during that period;
- (d) accommodation for one escort of a patient while the patient is an admitted patient of a public hospital site or during a period referred to in paragraph (c);
- (e) transportation of a patient between public hospital sites or between different facilities of a public hospital site,

but does not include the following:

- (f) the provision of meals to an escort of a patient;
- (g) the provision of meals to a patient other than while he or she is an admitted patient;
- (h) transportation of a patient or escort to or from a public hospital site (other than as specified in paragraph (e)).

### **3—Fee for aliquot patient**

- (1) The fee to be charged by a public hospital for Australian Cranio Facial Unit treatment or care of an aliquot public non-Medicare patient is \$41 691.
- (2) In this clause—

***Australian Cranio Facial Unit treatment or care***, in relation to an aliquot patient, means the following:

- (a) a period of treatment, care and accommodation of an admitted patient by the Australian Cranio Facial Unit, or an occasion of service provided to a non-admitted patient by that Unit, where the treatment, care and accommodation, or occasion of service, forms part of the treatment or care for which the patient was admitted as an aliquot patient;
- (b) a period of treatment, care and accommodation of an admitted patient by any other part of the Women's and Children's Hospital, or an occasion of service provided to a non-admitted patient by any other part of that Hospital, where the treatment, care and accommodation, or occasion of service, is arranged by the Australian Cranio Facial Unit and is related to treatment or care of the patient by that Unit;
- (c) accommodation for a patient between or following admissions or occasions of service referred to above where the Australian Cranio Facial Unit determines that it is necessary for the proper treatment and care of the patient for the patient to remain in this State during that period;
- (d) accommodation for one escort of a patient while the patient is an admitted patient of the Women's and Children's Hospital (whether in the Australian Cranio Facial Unit or otherwise) or during a period referred to in paragraph (c),

but does not include the following:

- (e) the provision of meals to an escort of a patient;

- (f) the provision of meals to a patient other than while he or she is an admitted patient of the Women's and Children's Hospital (whether in the Australian Cranio Facial Unit or otherwise);
- (g) any transportation of a patient or escort.

## SCHEDULE 1

The basis of the assessment of water use will be the estimation of water requirements for a crop.

The method by which the estimation of water requirements for crops will be used is the methodology of Doorenbos and Pruitt (1977), as refined by Allen *et al.*, (1998) and set out in the Primary Industries and Resources SA Technical Report No. 263, second edition ('the Report'). Crop factors will be calculated from Kc (crop coefficient) values from Food and Agriculture Organisation of the United Nations, Rome Irrigation and Drainage Paper 56 (Allen, Pereira *et al.*, 1998) ('FAO 56') and using site specific monthly Kp (pan coefficient) values and average monthly Kg values (bird guard coefficient) set out in the Report.

The methodology incorporates the use of Bureau of Meteorology evaporation data, the application of crop specific factors to evaporation figures to calculate crop evapotranspiration for the crop and location in question, subtraction of effective rainfall and an allowance for leaching for salinity control and irrigation efficiency.

The water requirement calculated by this method is expressed as depth of water required in millimetres for a particular crop grown over a particular season. Depth multiplied by the number of hectares of that crop grown (in each specified season for short season crops), multiplied by 10 gives the volume of water required for each crop in kilolitres.



## Magistrates Court of South Australia

### Amendment 5 to the Magistrates Court (Civil) Rules 2013

PURSUANT to Section 49 of the *Magistrates Court Act 1991* and all other enabling powers, we, the undersigned, do hereby make the following amendments to the **MAGISTRATES COURT (CIVIL) RULES 2013** as amended.

1. These Rules may be cited as the 'Magistrates Court (Civil) Rules 2013 (Amendment 5)'.
2. The *Magistrates Court (Civil) Rules 2013* as amended by these amendments apply to and govern all actions commenced in the civil division of the Court on and after the date on which these amendments are gazetted.
3. Cost Scale 2 is deleted and replaced with the following:

#### **COST SCALE 2: Minor Civil Actions**

10. Any other request (Form18) for enforcement of judgment	\$50
11. All other Court fees	As allowed by the Court
12. Other disbursements	As allowed by the Court

- C Where a party intends to serve a claim by means other than post, e-mail or fax a disbursement equal to the amount a Sheriff is entitled to receive for serving a claim form is allowed, but if the process is returned to the Court unserved, or is served by post, e-mail or fax, the disbursement must be disallowed unless a Registrar is satisfied that the party made reasonable efforts to serve the claim by means other than post, e-mail or fax.
- D The costs in the scale do not include GST and if that is applicable the amount of GST may be added.

**DETERMINATION  
THIRD PARTY PREMIUMS COMMITTEE**

**TO: THE HONOURABLE MINISTER FOR TRANSPORT**

The Third Party Premiums Committee (the **Committee**) has reviewed the premium for Class 1 vehicles (Private Passenger Vehicles in Insurance Rating District 1) and premium relativities for categories of motor vehicles other than premium Class 1 for the purposes of determining what premiums are fair and reasonable. The Committee's deliberations were based upon actuarial reviews and supplementary material provided by the offices of the Motor Accident Commission. The Committee has had due regard to the Motor Accident Commission's obligations under the *Motor Accident Commission Act 1992 (SA)* to minimise premium charges and to achieve and maintain a sufficient level of solvency (within the meaning of that Act) in the Compulsory Third Party Fund.

The Committee has determined that as from 1 July 2014:

1. The premium for Premium Class 1, Private Passenger Vehicles, Insurance Rating District 1, No ITC entitlement, should decrease by 9.3% (being \$38) to \$370 p.a. and that the 2014/15 premium class relativities remain unchanged from those implemented for 2013/14, as recommended by the CTP Scheme Actuary.

Those categories of motor vehicles with a decrease less than the recommended -9.3% compared to 2013/14 premiums are referred to in Attachment 1.

The class 1 determination, the adoption of the 2013/14 relativities and premiums for policies of insurance for periods of 3, 6 and 9 months for 2014/15 are outlined in the attached CTP Premium Schedule 2014/15 approved by the Committee.
