It is necessary to amend the Murray Bridge Council Development Plan dated 20 December 2012.

NOTICE

PURSUANT to Section 29 (2) (b) (i) and (ii) of the Development Act 1993 (the Act), I, John Rau, being the Minister administering the Act:

1. Amend the Murray Bridge Council Development Plan dated 20 December 2012 by:

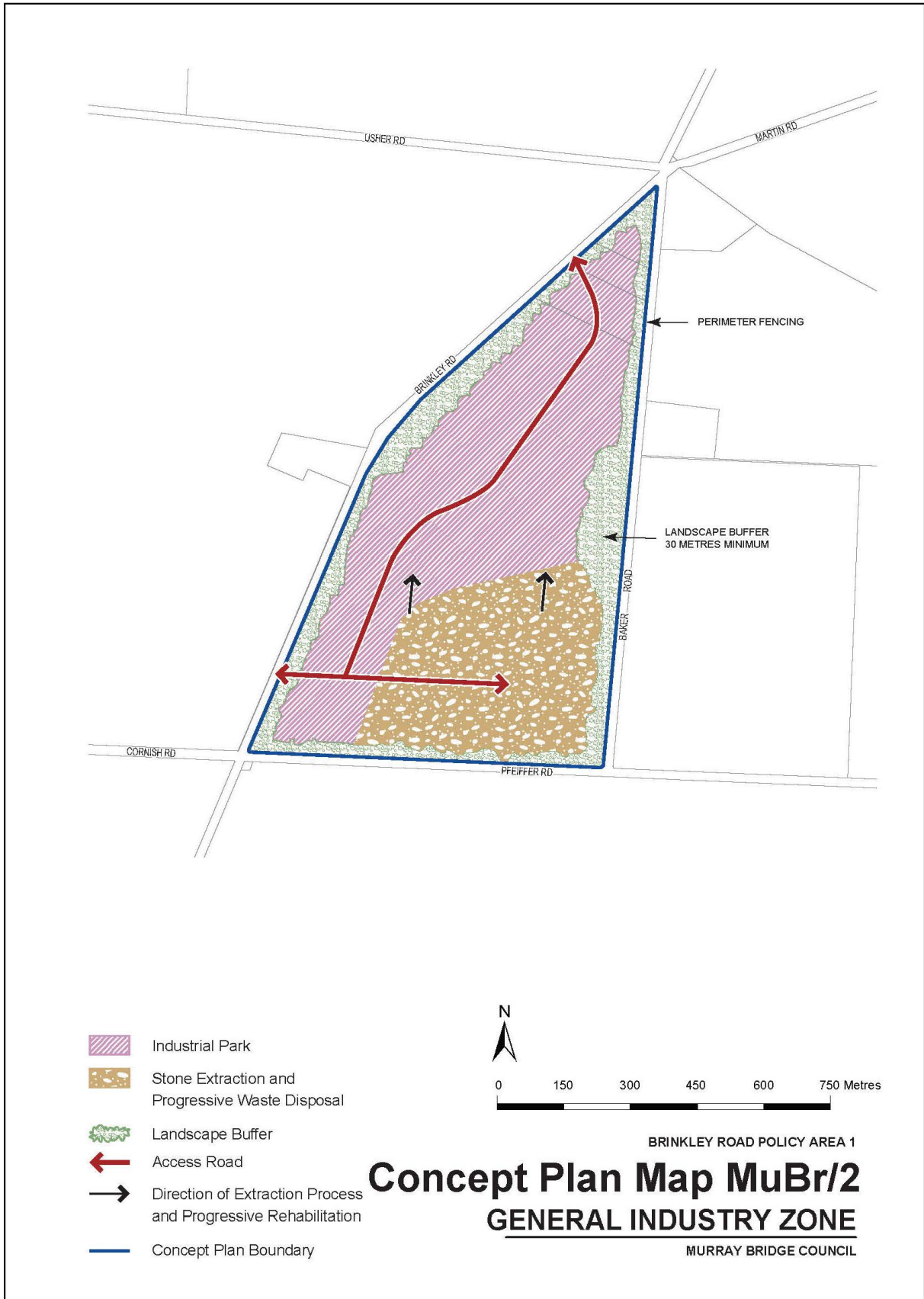
- (a) replacing the words ‘those dwellings’ with the words ‘this dwelling’ in the exception numbered (a) (iv) for form of development ‘Land division creating allotments less than 40 hectares within Central Policy Area 3, East Policy Area 4, North Central Policy Area 5, North West Policy Area 6 or South West Policy Area 8’ listed within the non-complying table of the ‘Primary Production Zone’;
- (b) replacing ‘Concept Plan Map MuBr/2—General Industry Zone’ with the contents of Attachment A;
- (c) replacing the words ‘developed is envisaged’ with the words ‘development is envisaged’ within the second sentence of the first paragraph of the ‘Desired Character’ of the ‘Rural Living Zone’;
- (d) replacing the the words ‘Murray Drive’ with the words ‘Avoca Dell Drive’ within ‘Principle of Development Control 23 (c)’ of the ‘Rural Living Zone’;
- (e) replacing ‘Concept Plan Map MuBr/8—Rural Living’ with the contents of Attachment B;
- (f) replacing ‘Concept Plan Map MuBr/12—River Murray Settlement Zone’ with the contents of Attachment C;
- (g) replacing the words ‘1200 metres’ with the words ‘1200 square metres’ within ‘Principle of Development Control 15’ of the ‘Country Township Zone’ under the sub-heading ‘Land Divison’;
- (h) replacing the ‘Council Index Map, Enlargement Index Map, Zone Map MuBr/4, Policy Area Map MuBr/4, Zone Map MuBr/5, Policy Area Map MuBr/5, Precinct Map MuBr/5’ with the contents of Attachment D;
- (i) inserting new ‘Zone Map MuBr/48, Policy Area Map MuBr/48, Zone Map MuBr/49, Policy Area Map MuBr/49’ included in Attachment E;
- (j) inserting zone map number references of MuBr/48 and MuBr/49 to the following zone names listed in the ‘Zone Maps’ sub-table of the ‘Map Reference Tables’:
 - Primary Production Zone
 - River Murray Flood Zone
 - River Murray Fringe Zone
- (k) inserting policy area map number reference of MuBr/48 to the ‘North Central Policy Area 5’ listed in the ‘Policy Area Maps’ sub-table of the ‘Map Reference Tables’; and
- (l) inserting policy area map number reference of MuBr/49 to the ‘East Policy Area 4’ listed in the ‘Policy Area Maps’ sub-table of the ‘Map Reference Tables’.

2. Fix the day on which this notice is published in the *Gazette* as the day on which the Amendment will come into operation.

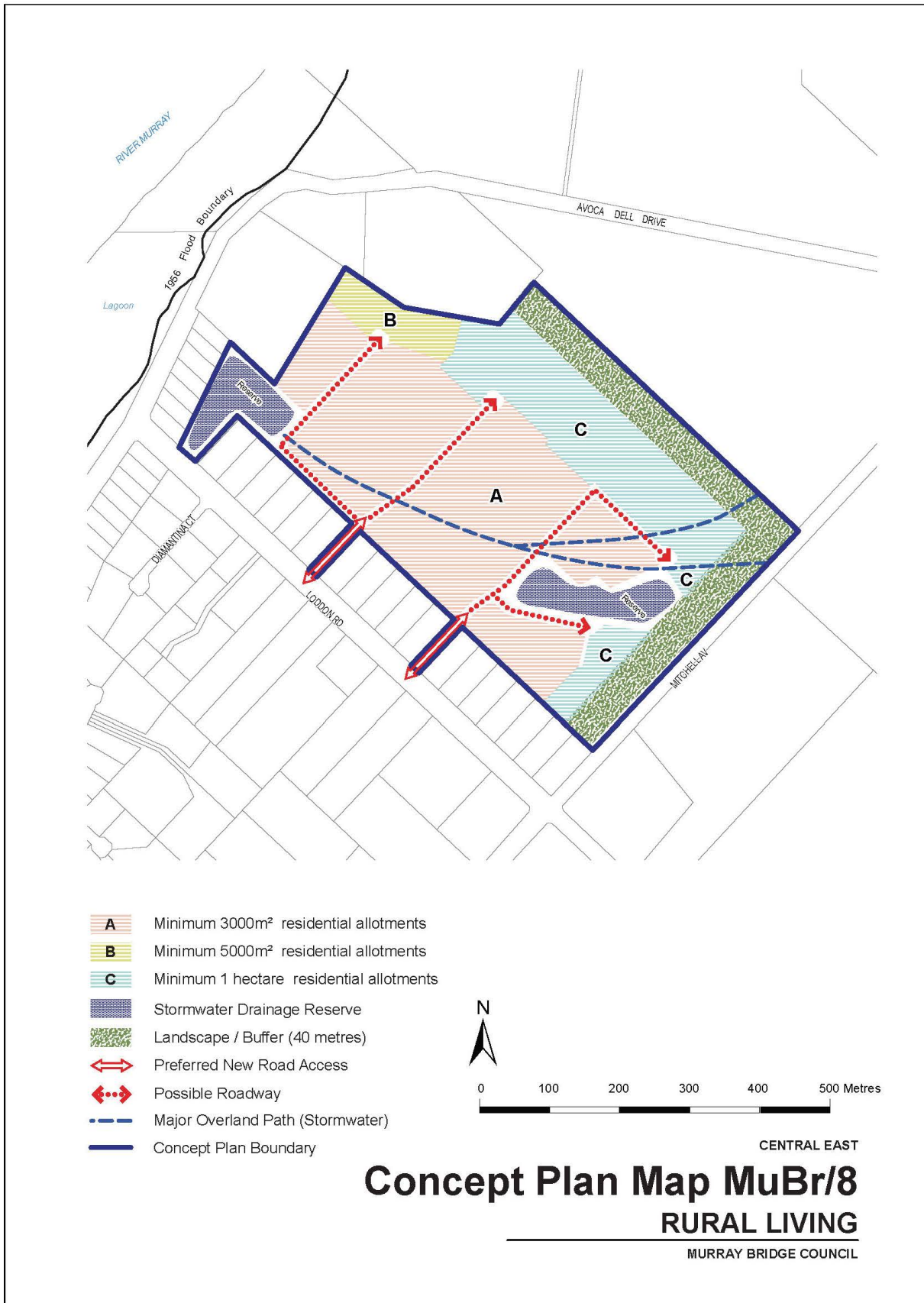

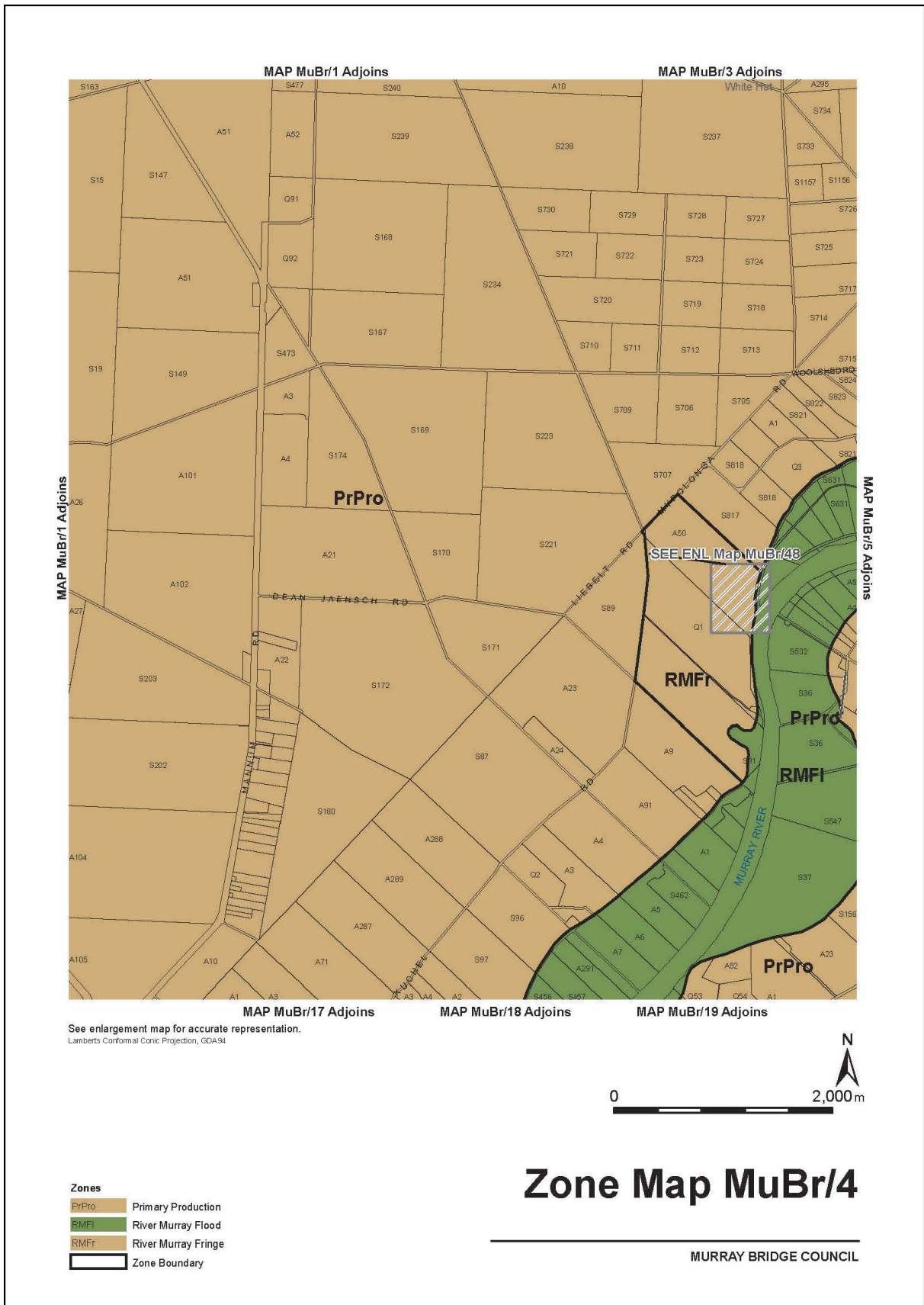

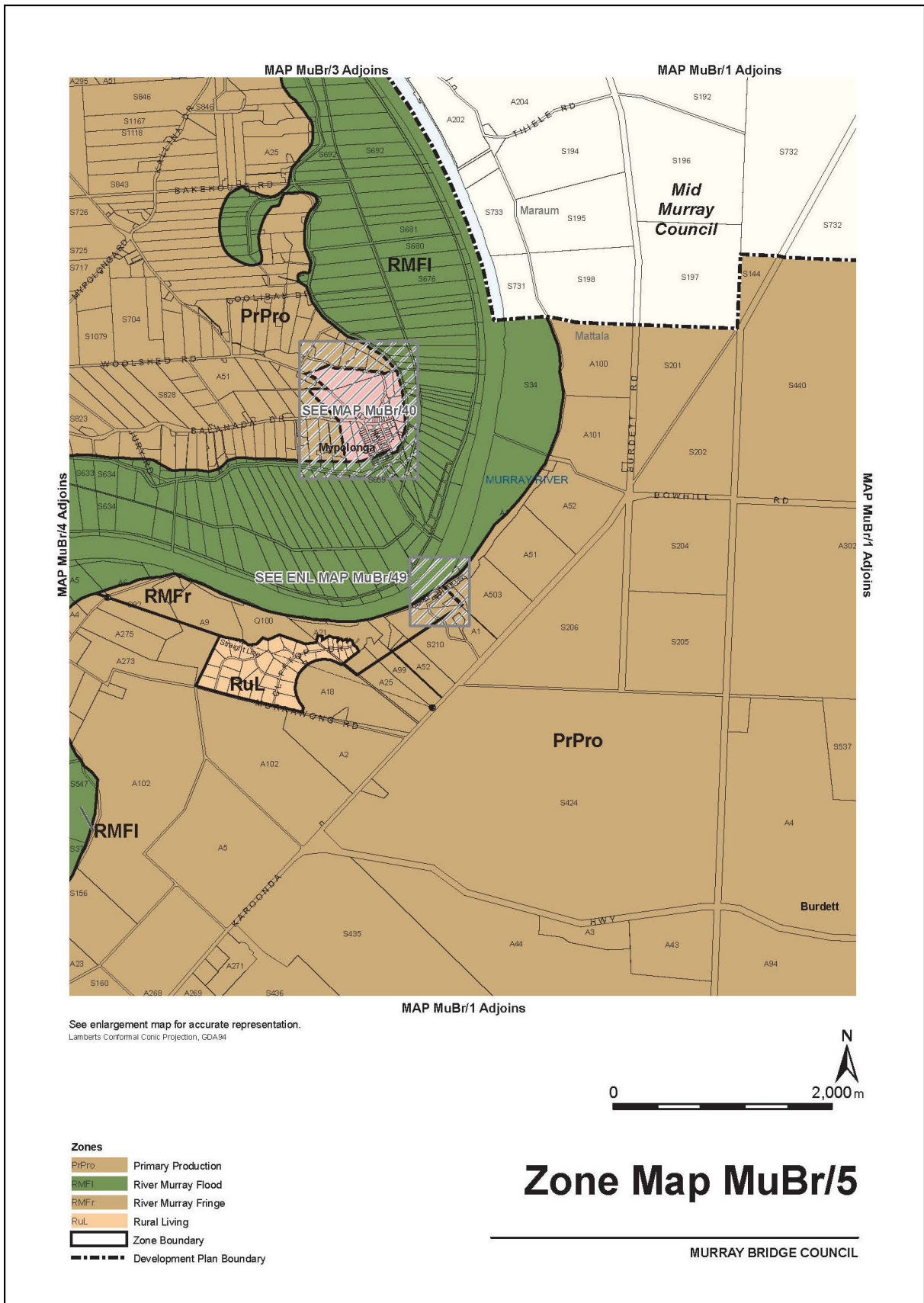

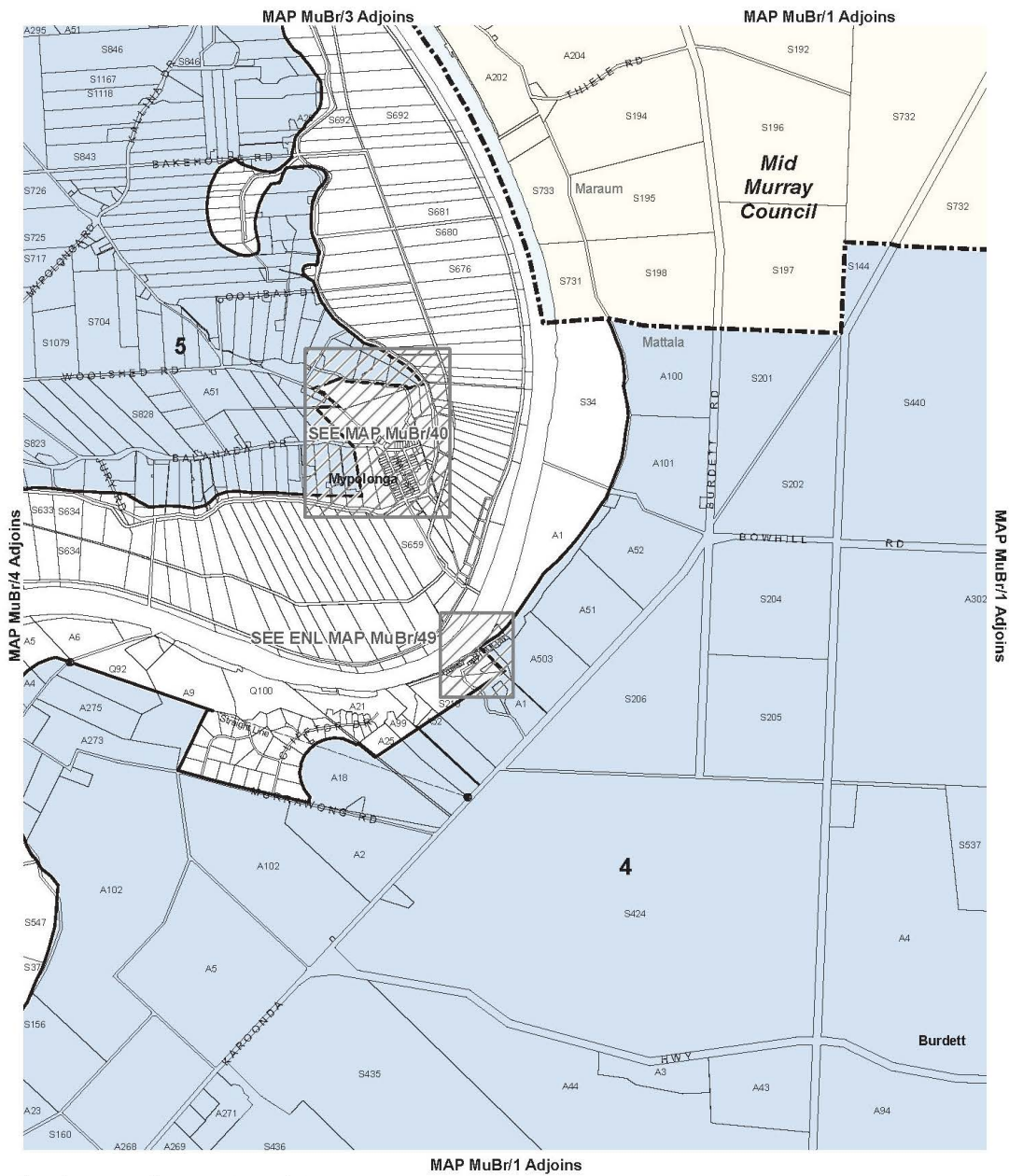


Policy Area Map MuBr/4

ENVIRONMENT PROTECTION ACT 1993

Approval of Category B Containers

I, ANDREA KAYE WOODS, Team Leader, Container Deposit Legislation and Delegate of the Environment Protection Authority ('the Authority'), pursuant to Section 68 of the Environment Protection Act 1993 (SA) ('the Act') hereby:

Approval of Category B Containers

Approve as Category B Containers, subject to the conditions in subclauses (1), (2), (3) and (4) below, each of the classes of containers identified by reference to the following matters described in the first 4 columns of Schedule 1 of this Notice which are sold in South Australia:

- (a) the product which each class of containers shall contain;
 - (b) the size of the containers;
 - (c) the type of containers; and
 - (d) the name of the holders of these approvals.
- (1) That containers of the class to which the approval relates must bear the refund marking specified by the Authority for containers of that class. The Authority specifies the following refund markings for Category B containers:
 - (i) '10c refund at collection depots when sold in S.A.'; or
 - (ii) '10c refund at S.A./N.T. collection depots in State/Territory of purchase'.
 - (2) The holder of the approval must have in place an effective and appropriate waste management arrangement in relation to containers of that class. For the purpose of this approval notice the company named in Column 5 of Schedule 1 of this Notice is the nominated super collector.
 - (3) In the case of an approval in relation to Category B containers that the waste management arrangement must require the holder of the approval to provide specified super collectors with a declaration in the form determined by the Authority in relation to each sale of such containers by the holder of the approval as soon as practicable after the sale.
 - (4) The holder of these approvals must ensure that if a sticker bearing the refund marking has been approved, and is applied to the container, then the sticker must not be placed on any portion of the opening mechanism or in any other place that would require complete or partial removal of the sticker before the contents may be consumed.

REMUNERATION TRIBUNAL

REPORT RELATING TO DETERMINATION NO. 2 OF 2014

Electoral Allowances for Members of Parliament, Allowances for Ministers of the Crown and Officers of the Parliament

1. Introduction

The Remuneration Tribunal issued Determination 2 of 2014 in accordance with the provisions of Section 4 of the Parliamentary Remuneration Act 1990. The Determination prescribes the electoral allowances to be paid to Members of Parliament and the expense allowances payable to Ministers of the Crown and Officers of the Parliament. These allowances were previously prescribed by the now superseded Determination 6 of 2006 (the superseded Determination).

2. Discussion

In its report of 21 August 2012, the Electoral Districts Boundaries Commission renamed the electoral district of Norwood as the Electoral District of Dunstan. The State Election to be held on 15 March 2014, will return a member for that electorate for the first time. Accordingly, Determination 2 of 2014 prescribes an electorate allowance for Dunstan to ensure that the member for that seat is appropriately remunerated, and to remove the superseded Electoral District of Norwood.

The electoral allowance for the Electoral District of Dunstan is the same as the allowance that previously applied to Norwood. Similarly the electoral allowances applying to all other electoral districts prescribed by Determination 2 of 2014 are no different

from those that applied under the superseded Determination. The Tribunal also determined to not vary the expense allowances payable to Ministers and Officers of the Parliament at this time. Therefore, the amounts prescribed in the new determination for these allowances mirror those applying under the superseded determination.

The superseded Determination also prescribed a Country Members Accommodation Allowance and Travelling and Accommodation Allowances for Ministers of the Crown and the Leader and Deputy Leader of the Opposition. However, these allowances have long been the subject of separate determinations by the Tribunal, the current one being Determination 3 of 2013. Accordingly, Determination 2 of 2014 does not deal with these accommodation and travelling allowances.

On the basis that the remuneration of a particular person, or persons of a particular class is unaffected by this determination, the Tribunal determined to not invite submissions in relation to this matter.
