*Draft for Public Consultation*

THE City of West Torrens has prepared a draft Plan Amendment Report (PAR) to amend the West Torrens (City) Consolidated Development Plan by incorporating heritage policies, local heritage places and Historic (Conservation) Policy Areas within the area of the former Town of Thebarton.

The PAR will amend the Development Plan in the following ways:

- By introducing Objectives and Principles of Development Control relating to the preservation and conservation of places of heritage value in the council wide section of the Development Plan;
- By establishing a list of local heritage places. This will enable the recognition, conservation and preservation of these places which are deemed to be worthy of retention;
- By establishing Historic (Conservation) Policy Areas which include contributory places in the zoning provisions. The Historic (Conservation) Policy Areas contain a cohesive historic character, which is recognised as valuable and worthy of conservation and retention.

The intention of the changes to the Development Plan is to enable the protection, conservation and enhancement of places of heritage character and importance within the area of the former Town of Thebarton.

The draft PAR is available for public inspection during normal office hours of the City of West Torrens Civic Centre or either branch of the Council Library from 14 December 2000 to Monday, 26 March 2001. Copies of the PAR are available for purchase from the council at a cost of \$16.50 each, which is inclusive of the GST.

  - (a) delete the heading 'Land Division' and the contents of Principles 1, 2 and 3; and
  - (b) delete clause 6 (b) and insert the following:  
'(b) 0.5 hectares for land contained within that part of the Rural Living Zone that has boundaries to Waterport Road and Port Elliot Road and contains Stock Drive, Vanali Drive and Frenchman Drive; and'.
3. In complying lists of development appearing within those zones that the Mount Lofty Ranges principles apply as well as in the standard exemption list, delete the 'complying' category where in conflict with the standard exemption list in the following zones:  
Flood Zone, General Farming (Port Elliot and Goolwa District) Zone,  
General Farming (Strathalbyn District) Zone, Grazing Zone,  
Horticulture (Port Elliot and Goolwa District) Zone,  
Horticulture (Strathalbyn District) Zone,

- (b) is connected to an approved sewerage or common effluent disposal scheme or has an on-site waste water treatment and disposal method which complies with the Standard for the Installation and Operation of Septic Tank Systems in South Australia (including supplements A and B) as prepared by the South Australian Health Commission;
- (c) not have any part of a septic tank effluent drainage field or any other waste water disposal area (e.g. irrigation area) located within 50 m of a water course identified in a current series 1:50 000 Government Standard topographic map;
- (d) not have a waste water disposal area located on any land with a slope greater than 20 per cent (one in five), or a depth to bedrock or seasonal or permanent water table less than 1.2 m;
- (e) not have a septic tank or any other waste water treatment facility located on land likely to be inundated by a ten year return period flood event;
- (f) is sited at least 25 m from any water course identified on a current series 1:50 000 Government Standard topographic map.



"**AS 4551**" means AS 4551/AG 101—*Approval Requirements for Domestic Gas Cooking Appliances* published by The Australian Gas Association, as in force on 1 May 2000 (including any code or standard called up by or under AS 4551 as at that date);

"**AS 5601**" means AS 5601/AG 601—*Gas Installations* published by The Australian Gas Association, as in force from time to time (including any code or standard called up by or under AS 5601);;

(e) by inserting after the definition of "**distribution system operator**" the following definition:

"**liquefied petroleum gas**" means a hydrocarbon fluid composed predominantly of one or more of the following hydrocarbons:

- (a) propane (C<sub>3</sub>H<sub>8</sub>);
- (b) propene (propylene) (C<sub>3</sub>H<sub>6</sub>);
- (c) butane (C<sub>4</sub>H<sub>10</sub>);
- (d) butene (butylene) (C<sub>4</sub>H<sub>8</sub>);;

(f) by inserting after the definition of "**retailer**" the following definition:

"**Type A appliance**" means an appliance to which an appliance approval scheme operated by The Australian Gas Association applies;;

(g) by striking out from the definition of "**Type B appliance**" "AG 601" and substituting "AS 5601".

#### **Variation of reg. 12—Quality of gas supplied through distribution system**

4. Regulation 12 of the principal regulations is varied by striking out paragraphs (c), (d), and (e) of subregulation (3) and substituting the following paragraph:

- (c) it must comply with the relevant specifications set out in Schedule 1A (unless otherwise agreed between the Technical Regulator and the distribution system operator).

#### **Insertion of reg. 12A**

5. The following regulation is inserted in Division 2 of Part 4 of the principal regulations, after regulation 12:

##### **Quality of liquefied petroleum gas supplied in pressurised vessel**

**12A.** A person must not sell liquefied petroleum gas knowing, or in circumstances in which the person ought reasonably to know, that it is likely to be supplied to Type A appliances from a pressurised vessel unless it complies with the relevant specifications set out in Schedule 1A.

#### **Variation of reg. 13—General gas fitting work**

6. Regulation 13 of the principal regulations is varied—

- (a) by striking out from subregulation (1) "installing or commissioning" and substituting "installing, commissioning or modifying";

- (b) by striking out from subregulation (1) "AG 601" (twice occurring) and substituting, in each case, "AS 5601".

7. Regulation 14 of the principal regulations is varied—

- (b) by striking out from subregulation (1) "AG 501 and AG 601" and substituting "AS 3814 and AS 5601";
- (c) by striking out from subregulation (2) "AG 501" and substituting "AS 3814";
- (d) by striking out from subregulation (3) "AG 501" and substituting "AS 3814";
- (e) by striking out from subregulation (4) "AG 501 and AG 601" and substituting "AS 3814 and AS 5601";
- (f) by striking out paragraph (a) of subregulation (7) and substituting the following paragraph:
- (a) must provide a copy of the completed certificate of compliance to—
- (i) the person on whose behalf the work was carried out; and
- (ii) the Technical Regulator; and;
- (g) by inserting after subregulation (7) the following subregulations:

(7a) If the person on whose behalf work on a Type B appliance was carried out is not the owner of the appliance, that person must provide a copy of the certificate of compliance to the owner of the appliance.

(7b) The owner of a Type B appliance must keep a copy of each certificate of compliance provided in relation to the appliance until the appliance is sold or otherwise disposed of.

(7c) The owner of a Type B appliance must, on sale or transfer of the appliance, deliver copies of all certificates of compliance held in relation to the appliance to the new owner (who must keep any certificate in accordance with subregulation (7b)).

**Insertion of Sched. 1A**

8. The following Schedule is inserted after Schedule 1 of the principal regulations:

**SCHEDULE 1A**  
*Gas Specifications*  
(Regulations 12 and 12A)

**Interpretation**

1. In this Schedule—

"**flame speed factor**" means the flame speed factor determined in accordance with the formula set out in Schedule 1;

"**natural gas**" means a substance that—

- (a) is in a gaseous state at standard temperature and pressure; and
- (b) consists of—
  - (i) naturally occurring hydrocarbons; or
  - (ii) a naturally occurring mixture of hydrocarbons and non-hydrocarbons,
    - the principal constituent of which is methane; and
- (c) has been processed to be suitable for consumption;

"**sooting index**" means the sooting index determined in accordance with the formula set out in Schedule 1;

"**Wobbe Index**" has the same meaning as in AS 4551.

**Specifications for natural gas**

2. The specifications for natural gas are as follows:

For the purposes of this table, the standard conditions for all gas properties listed are—

- (a) gas is dry (that is, completely free from water vapour);

- (c) absolute Pressure is 101.325 kPa.

**Specifications for liquefied petroleum gas**

3. The specifications for liquefied petroleum gas are as follows:

- (a) it must contain less than 12mg/m<sup>3</sup> of hydrogen sulphide; and
- (b) its combustion characteristics must not be more than 10% above or 10% below the limits of—
  - (i) the Wobbe Index; and
  - (ii) the flame speed factor; and
  - (iii) the sooting index,

as derived from Test Gas X referred to in the Test Gas Table set out in AS 4551.

**Specifications for other gas**

4. The specifications for gas other than natural gas or liquefied petroleum gas are as follows:

- (a) it must contain less than 12mg/m<sup>3</sup> of hydrogen sulphide; and
- (b) its combustion characteristics must not be more than 10% above or 10% below the limits of—
  - (i) the Wobbe Index; and
  - (ii) the flame speed factor; and
  - (iii) the sooting index,

as derived from the test gases for the type of gas referred to in the Test Gas Table set out in AS 4551.

22. (1) Clause 2 of Schedule 3 of the Act does not apply to a claim in respect of the provision by a dealer of goods or services that do not relate directly to the second-hand vehicle<sup>1</sup> purchased or sold by the dealer or left in the dealer's possession.

1. Goods or services not relating directly to the vehicle may include, for example, travel, accommodation, household goods, entry tickets to certain events, etc., or a scheme whereby goods or services may be redeemed in the future.

(2) For the purposes of clause 4 of Schedule 3 of the Act, each licensed dealer is required to pay to the Commissioner the contribution referred to in Schedule 5 of these regulations in accordance with the provisions of that Schedule.


