#### SHOP TRADING HOURS ACT 1977 SECTION 13: ALTERATION OF SHOP TRADING HOURS—EASTER 2000

Proclamation By The Governor

(L.S.) E. J. NEAL

PURSUANT to section 13 of the *Shop Trading Hours Act 1977* and with the advice and consent of the Executive Council, I authorise the opening of shops (subject to the conditions specified in the schedule) and require the closing of shops as follows:

#### **Central Shopping District**

Sunday 23 April 2000

All shops (other than exempt shops and shops to which section 13(5e) of the Act applies) are required to be closed from 11.00 a.m. until 5.00 p.m.

Monday 24 April 2000

All shops (other than shops the business of which is solely or predominantly the retail sale of boats or motor vehicles) are authorised to be open from 7.00 a.m. until 7.00 p.m.

## **Metropolitan Shopping District**

Wednesday 19 April 2000

All shops are authorised to be open from  $6.00~\mathrm{pm}$ . until  $9.00~\mathrm{p.m}$ .

Monday 24 April 2000

All shops (other than shops the business of which is solely or predominantly the retail sale of boats or motor vehicles) are authorised to be open from 7.00 a.m. until 7.00 p.m.

#### **Mount Barker Shopping District**

Wednesday 19 April 2000

All shops are authorised to be open from 6.00 p.m. until 9.00 p.m.

#### Port Lincoln Shopping District

Saturday 22 April 2000

All shops are authorised to be open from 6.00 a.m. until 5.00 p.m.

Sunday 23 April 2000

All shops are authorised to be open from 11.00 a.m. until 5.00 p.m.

Monday 24 April 2000

All shops are authorised to be open from  $6.00~\mathrm{a.m.}$  until  $6.00~\mathrm{p.m.}$ 

## Renmark Shopping District

Thursday 20 April 2000

All shops are authorised to be open from 6.00 p.m. until 9.00 p.m.

Saturday 22 April 2000

All shops are authorised to be open from 8.00~a.m. until 5.00~p.m.

Sunday 23 April 2000

All shops are authorised to be open from 11.00~a.m. until 5.00~p.m.

### SCHEDULE

This proclamation only authorises the opening of a shop if-

- (a) all relevant industrial awards, workplace agreements and enterprise agreements are observed by the shopkeeper and persons employed in the business of the shop during and in relation to the hours specified in this proclamation during which the shop is open; and
- (b) subject to an industrial award, workplace agreement or enterprise agreement to the contrary—a person who is employed in the business of the shop is entitled to refuse to work at the shop during the hours specified in this proclamation unless he or she has agreed with the shopkeeper to work during those hours.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, those persons not conducting fishing activity pursuant to a commercial river fishery licence (hereinafter referred to as the 'permit holders'), are exempted from clauses 113, 114 and 115 of Schedule 1 of the Fisheries (General) Regulations 1984 in that the permit holders shall not be guilty of an offence when using yabbie pots or shrimp traps not set from the shore in a commercial river fishery reach, or when using hoop nets, drop nets or trolling in a commercial river fishery reach (hereinafter referred to as the 'permitted activity'), subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 30 June 2000.

#### SCHEDULE 1

- 1. The permit holders shall not conduct the permitted activity in the waters of the main stream of the River Murray included within a commercial fishing reach.
- 2. The permit holders shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.
