FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, David Macdonald (hereinafter referred to as the 'exemption holder'), 23 Ferry Street, Whyalla Playford, S.A. 5600 is exempt from sections 34 and 41 of the Fisheries Act 1982 but only insofar as he may engage in the taking of those fish specified in Schedule 1 (hereinafter referred to as the 'permitted activity'), subject to the conditions specified in Schedule 2 for the purpose of trade or business.

SCHEDULE 1

Molluscs other than fish of the species abalone (*Haliotis* spp.), octopus (*Octopus* spp.), squid (order Teuthoidea), cuttlefish (*Sepia* spp.), tate king scallop, queen scallop (*Mimachlamys*, *Equichlamys* and *Pecten* spp.), mud oyster (*Ostrea* spp.), cockles of the genus *Donax* and *Katelysia*, mussels (*Mytilus* and *Perna* spp.) and razor fish (*Pinna bicolor*).

SCHEDULE 2

1. The exemption holder may only engage in the permitted activity from the date of this notice until 30 June 2001.

2. No more than one fish per day may be taken of any cowrie belonging to the *Zoila* sub-genus of *Cypraea armeniaca*.

3. The exemption holder may only use the registered boat number JO1 99S for the purpose of conducting the permitted activity.

4. When engaged in the permitted activity the exemption holder may collect fish by diving either from a boat or from the shore. When engaged in the permitted activity from the shore no more than one agent may also be engaged in the permitted activity and that agent must be no more than 50 m from the exemption holder.

5. Any fish taken whilst conducting the permitted activity pursuant to this exemption must be for sale as specimen shells only and the meat must not be sold.

6. The exemption holder must complete a daily logbook of catch and effort information in the form provided by the South

Australian Research and Development Institute (SARDI). This information must be provided to SARDI on a monthly basis.

7. The exemption holder must provide any additional information in relation to the permitted activity if and when required by the Director of Fisheries.

8. The exemption holder may not engage in the permitted activity within the waters of Coffin Bay south of latitude 34°31.2'S.

9. While engaged in the permitted activity the exemption holder shall carry or have about or near his person a copy of this notice. Such notice shall be produced to a PIRSA Fisheries Compliance Officer upon request.

10. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulation made under the Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, David Ayres, 447 Waggon Road, Victor Harbor, S.A. 5211 (hereinafter referred to as the 'exemption holder') is exempt from the Fisheries Act 1982 but only insofar as he may use up to 100 octopus traps for the purpose of trade or business (hereinafter referred to as the 'permitted activity'), subject to the conditions set out in Schedule 1 from the date of gazettal of this notice until 30 June 2001.

SCHEDULE 1

1. The permitted activity must only be conducted from a boat registered on marine scalefish fishery licence number M206.

2. The exemption holder must return all species other than octopus (*Octopus spp.*) to the water when conducting the permitted activity.

3. When conducting the permitted activity the octopus traps may be baited, must not have a maximum dimension exceeding 1m and must not have doors.

4. The exemption holder must provide the Director of Fisheries statistical catch and effort information (including zero returns if no fish have been collected) in the form of a written report, within 15 days of the completion of each calendar month. This report is to include the following information:

- Dates of fishing activity.
- Exact locations of fishing activity.
- Total weight of fish collected.
- Mean size of fish collected.
- Weight and use of any fish sold.

5. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.

6. Whilst engaged in the permitted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

1. The permitted activity must only be conducted from a boat registered on marine scalefish fishery licence number M250.

2. The exemption holder must return all species other than octopus (*Octopus spp.*) to the water when conducting the permitted activity.

3. When conducting the permitted activity the octopus traps may be baited, must not have a maximum dimension exceeding 1m and must not have doors.

4. The exemption holder must provide the Director of Fisheries statistical catch and effort information (including zero returns if no fish have been collected) in the form of a written report, within 15 days of the completion of each calendar month. This report is to include the following information:

- Dates of fishing activity.
- Exact locations of fishing activity.
- Total weight of fish collected.
- Mean size of fish collected.
- Weight and use of any fish sold.

FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, William J. Marmion and Neil Henry, Island Ocean Seafoods (hereinafter referred to as the 'exemption holder'), P.O. Box 121, Penneshaw, S.A. 5222 is exempt from the Fisheries Act 1982, insofar as he may take greenlip abalone (*Haliotis laevis*) and blacklip abalone (*Haliotis rubra*) for the purpose of aquaculture broodstock in the waters specified in Schedule 1 subject to the conditions in Schedule 2 (hereinafter referred to as the 'permitted activity').

SCHEDULE 1

South Australian coastal waters between the meridians of longitude 136°30'E and 139°E but does not include the waters of the Coorong or any other waters inside the Murray Mouth.

SCHEDULE 2

1. The exemption holder may take a maximum of 100 greenlip abalone (*Haliotis laevis*) and 100 blacklip abalone (*Haliotis rubra*). All abalone taken pursuant to this notice may not be sold or transferred to another party.

2. The exemption holder may engage in the permitted activity from the date of gazettal of this notice until 30 June 2001.

3. The exemption holder shall notify the PIRSA Fisheries Compliance Unit on 1800 065 522 at least 24 hours prior to conducting the permitted activity with the following information:

- (a) details of the boat that will be used to engage in the permitted activity;
- (b) the name of the person who will be conducting the permitted activity;
- (c) the intended place and time of launching and retrieval of the nominated boat for that day; and
- (d) the intended area of conducting the permitted activity.

4. The exemption holder must, within 50 m of the point of landing of any abalone taken pursuant to this notice, complete the PIRSA form Abalone Broodstock Collection Statement. Immediately upon arrival at the exemption holder's registered aquaculture site, this form must be faxed to PIRSA Fisheries on 08 8226 2320. Prior to release into the registered aquaculture site, all abalone taken pursuant to this notice must be tagged so as to be clearly identified as wild broodstock.

5. The exemption holder shall record the number of wild broodstock held pursuant to this notice in a register to be maintained at the registered aquaculture site, which must be made available for inspection by a PIRSA Fisheries Compliance Officer upon request.

6. PIRSA Fisheries Compliance Unit retains the right for a departmental officer to accompany the fisher at any time during the permitted activity.

7. While engaged in the permitted activity the exemption holder shall carry or have about or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer upon request.

8. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.
