FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, those persons specified in Schedule 1, (hereinafter referred to as the 'exemption holder') are exempt from sections 44 (1) and 34 (1) of the Fisheries Act 1982, insofar as the exemption holder is permitted to engage in a fishing activity of a class that constitutes a fishery for the purpose of trade or business and sell fish taken in waters to which this Act applies whilst not being the holder of a licence pursuant to regulations made under the Fisheries Act 1982 (hereinafter referred to as the 'permitted activity') subject to the conditions outlined in Schedule 2 during the period 1 July 2000 to 31 July 2000 or until this notice is revoked, whichever being the earlier.

SCHEDULE 1

1. Those persons who held a licence pursuant to the Scheme of Management (Rock Lobster Fisheries) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or
2. Those persons who held a licence pursuant to the Scheme of Management (River Fishery) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or
3. Those persons who held a licence pursuant to the Scheme of Management (Abalone Fisheries) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or
4. Those persons who held a licence pursuant to the Scheme of Management (Blue Crab Fishery) Regulations 1998 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or

5. Those persons who held a licence pursuant to the Scheme of Management (Lakes and Coorong Fishery) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or

6. Those persons who held a licence pursuant to the Scheme of Management (Marine Scalefish Fisheries) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or

7. Those persons who held a licence pursuant to the Scheme of Management (Miscellaneous Fishery) Regulations 1984 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year; or

8. Those persons who held a licence pursuant to the Scheme of Management (Prawn Fisheries) Regulations 1991 during the licensing year 1999-2000 and who have paid all fees due for the 1999-2000 year.

SCHEDULE 2

1. All fishing activity conducted pursuant to this notice must be conducted in accordance with the conditions and endorsements applicable to the last licence held by the exemption holder for the 1999-2000 licensing year; and

2. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.
