FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Jeremy Grant of Dragon Search, 120 Wakefield Street, Adelaide, S.A. 5000 or persons acting as his agents (hereinafter referred to as the 'exemption holder') is exempt from the provisions of section 42 of the Fisheries Act 1982, but only insofar as the exemption holder will not be guilty of an offence when possessing beach cast leafy sea dragons (*Phycodurus eques eques*), (hereinafter referred to as the 'permitted activity') from the date of gazettal of this notice until 30 June 2001.

SCHEDULE 1

- 1. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice
- 2. Two sea dragons are to be kept for educational purposes at Dragon Search. the collected specimens are to be held temporarily at Dragon Search and SARDI, and stored at the South Australian Museum.
- 3. While engaging in the permitted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries and Aquaculture Compliance Officer if such an officer requests that it be produced. Dated 16 March 2000.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Nigel H. Cranfield, P.O. Box 969, Victor Harbor, S.A. 5211 (hereinafter referred to as the 'exemption holder') is exempt from the provision of paragraph 9, Schedule 1 of the Fisheries (General) Regulations 1984, in that the fisher shall not be guilty of an offence when leaving longlines within those waters specified in Schedule 1 for more than 4 hours (hereinafter referred to as the 'permitted activity') pursuant to Marine Scalefish Fishery Licence M053, subject to the conditions specified in Schedule 2 from the date of gazettal of this notice until 30 June 2000.

SCHEDULE 1

South Australian coastal waters between longitude $138^{\circ}15.00^{\circ}E$ and longitude $139^{\circ}30.00^{\circ}E$.

SCHEDULE 2

- 1. The exemption holder must ensure that longlines are not left in the specified waters for any period comprised of more than 12 consecutive hours.
- 2. Whilst engaged in the permitted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries and Aquaculture Compliance Officer.
- 3. PIRSA Fisheries and Aquaculture retains the right for a departmental officer to accompany the exemption holder at any time during any fishery operation conducted pursuant to this exemption.
- 4. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this exemption.
