1. The whole of the unnamed public road adjoining the south-eastern boundary of allotment 3 in Deposited Plan 54849 adjacent to the railway reserve (section 876) in the Hundred of Barunga more particularly lettered 'A' in Preliminary Plan No. PP32/0557 be closed.

2. The whole of the land subject to closure be transferred to the AUSBULK LTD in accordance with agreement for transfer dated 13 December 2000 entered into between the Wakefield Regional Council and AusBulk Ltd.

## ROAD TRAFFIC ACT 1961

*Exemption for the Position of Lighting Equipment on the Rear of  
Roll-on/Roll-off Vehicles used to Transport Waste Products or Scrap Metal*

PURSUANT to the provisions of section 163AA of the Road Traffic Act 1961, I, T. N. Argent, Executive Director, Transport SA, as an authorised delegate of the Minister for Transport and Urban Planning, hereby exempt roll on/roll off vehicles which have a manufacturer's Gross Vehicle Mass exceeding 4.5 tonnes, used to transport waste products or scrap metal:

From the following provisions of the *Road Traffic (Vehicle Standards) Rules 1999*:

- Part 8, Division 7, Rule 93(2) – Rear Clearance Lights;
- Part 8, Division 9, Rule 98(2) – Brake Lights;
- Part 8, Division 15, Rule 109(1) – Rear Reflectors; and
- Rule 20 – Compliance with third edition Australian Design Rules (ADRs) in so far as it relates to ADR 13.6.4.4.3. – Reversing Lamp, ADR 13.6.5.4.3. – Direction Indicator Lamp, ADR 13.6.7.4.3 – Stop Lamp, ADR 13.6.10.4.3. – Rear Position Lamp, ADR 13.6.14.4.3. – Rear Retro-Reflector Non-Triangular and ADR 13.6.18.4.3. – Side Marker Lamps:

As the above rules relate to the position of lights and reflectors which are required to be fitted on the rear or not more than one metre from the rear of motor vehicles, the exemption hereby granted is subject to the following conditions:

1. The vehicle is only permitted to travel on a road or road related area for the purposes of:
    - 1.1. Undertaking activities associated with the transport of waste products or scrap metal; or
    - 1.2. Transporting the vehicle to or from a place of storage, maintenance or repair.
  2. That this exemption is only valid while a bin is being transported on the vehicle and the "loading frames" do not protrude beyond the rear of the bin.
- Note: If the vehicle is driven on a road or road related area in circumstances other than those specified in this notice (such as being driven without transporting a bin), this exemption does not apply and all lighting equipment required under Part 8 or Rule 20 of the *Road Traffic (Vehicle Standards) Rules 1999*, as applicable, must be fitted to the vehicle. It is acceptable to use a temporary lighting board attached to the rear of the vehicle in such circumstances.
3. That the rear lighting equipment is fitted no further forward than 1600 millimetres from the rear of the vehicle.
  4. That the rear of the bin(s) transported on the vehicle is painted white and maintained in a clean condition.



**Citation**

1. The *Livestock Regulations 1998* (see *Gazette* 22 January 1998 p. 288), as varied, are referred to in these regulations as "the principal regulations".

**Commencement**

2. These regulations will come into operation one month from the day on which they are made.

**Variation of reg. 4—Interpretation**

3. Regulation 4 of the principal regulations is varied by inserting after the definition of "**vaccine**" the following definition:

"**vendor declaration**" means a declaration made in connection with the sale or proposed sale of livestock, using—

- (a) a form known as a "Vendor Declaration" from time to time approved by the Chief Inspector in respect of livestock of the relevant kind; or
- (b) a form to the same effect as the form referred to in paragraph (a).

**Variation of reg. 22—HGP free declarations**

4. Regulation 22 of the principal regulations is varied by striking out subregulation (2) and substituting the following subregulation:

(2) A person must not make a statement that is false or misleading in a material particular (whether by reason of the inclusion or omission of any particular) in an HGP free declaration.

Maximum penalty/expiation fee:

- (a) If the person made the statement knowing that it was false or misleading:  
Maximum penalty—\$10 000.
- (b) In any other case:  
Maximum penalty—\$5 000.  
Expiation fee—\$315.

#### **Insertion of Part 7A**

5. The following Part is inserted after regulation 31 of the principal regulations:

### **PART 7A VENDOR DECLARATIONS**

#### **Signing of vendor declarations**

**31A.** A person must not sign a vendor declaration in connection with the sale or proposed sale of livestock unless the person is, or was immediately before the sale or consignment of the livestock for sale—

- (a) the owner of the livestock; or
- (b) a person responsible for the husbandry of the livestock authorised by the owner to do so.

Maximum penalty: \$5 000.  
Expiation fee: \$315.

#### **False or misleading vendor declarations**

**31B.** A person must not make a statement that is false or misleading in a material particular (whether by reason of the inclusion or omission of any particular) in a vendor declaration.

Maximum penalty/expiation fee:

- (a) If the person made the statement knowing that it was false or misleading:  
Maximum penalty—\$10 000.
- (b) In any other case:  
Maximum penalty—\$5 000.  
Expiation fee—\$315.

The Mount Lofty Ranges Regional Strategy Plan (1993) identified the Mount Barker Township as a regional service centre for the Mount Lofty Ranges. A key purpose of this Plan Amendment Report is to reflect that significance by rezoning the existing Mount Barker District Centre to a Regional Town Centre.

The Plan Amendment Report also examines the role and relationship of a number of smaller commercial centres within the Mount Barker and Littlehampton Townships.

The major policy changes that will result from the Mount Barker and Littlehampton Townships Centres Plan Amendment Report include:

- the rezoning of the Mount Barker District Centre to a Regional Town Centre;
- the inclusion of additional land within the proposed Regional Town Centre Zone;
- the introduction of 8 new Policy Areas within the proposed Regional Town Centre Zone;
- the inclusion of 3 additional allotments within the Wellington Road, Mount Barker Local Centre Zone;
- amending the Littlehampton Neighbourhood Centre Zone to create two smaller zones (a Neighbourhood Centre Zone focussed around the intersection of North Terrace (Main Road) and Junction Road and a Local Centre Zone at the western end of the existing Neighbourhood Centre Zone). Eleven allotments will be rezoned to residential to reflect their existing use and 6 allotments will be rezoned to Neighbourhood Centre.
- amending the Industrial/Commercial Zone to accommodate bulky goods retail and inclusion of additional allotments within the Industrial/Commercial Zone; and
- a review of the complying conditions for certain advertisements, the public notification categories and general advertisement standards.

The Plan Amendment Report and Statement of Investigation will be available for public inspection during normal office hours at the District Council of Mount Barker Local Government Centre, 23 Mann Street, Mount Barker, and at the Mount Barker Community Library, Dumas Street, Mount Barker from Thursday, 25 January 2001 until Monday, 26 March 2001.
