FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, those persons specified in Schedule 1 (hereinafter referred to as the 'exemption holders'), are exempted from the provisions of Regulations 19 (1) and 19 (5) of the Fisheries (General) Regulations 2000, but only insofar as the exemption holders shall not be guilty of an offence when removing abalone from its shell at sea and having possession, control or custody of abalone that had been removed from its shell, subject to the conditions specified in Schedule 2, from the date of gazettal of this notice until 31 December 2001.

SCHEDULE 1

Those persons, or their registered masters, who hold a licence pursuant to the Scheme of Management (Abalone Fisheries) Regulations 1991 for the Central Zone Abalone Fishery.

SCHEDULE 2

The exemption holders shall not contravene or fail to comply with the Fisheries Act 1982, or any other regulations made under that Act except where specifically exempted by this notice.
