FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Dr Bronwyn Gillanders from the Faculty of Science, Department of Environmental Biology, The University of Adelaide, Adelaide, S.A. 5005 (the 'exemption holder'), or a person acting as her agent, is exempt from the Fisheries (General) Regulations 2000 and the Fisheries (Aquatic Reserves) Regulations 1989, but only insofar as they may engage in the collection of marine and/or estuarine organisms from the waters listed in Schedule 1 using the gear specified in Schedule 2 (the 'exempted activity'), subject to the conditions set out in Schedule 3 from the date of gazettal of this notice until 31 March 2005, unless varied or revoked earlier.

SCHEDULE 1

The waters of:

- Coorong and lower lakes
- Inman River
- Hindmarsh River
- Myponga River
- Onkaparinga River
- Patawalonga River
- Port River Barker Inlet
- Gawler River
- Light River
- Broughton River and estuary
- Northern Spencer Gulf, first to third estuary; and
- Fisherman Creek, Port Pirie
- Franklin Harbour
- American River
- Chapman River and estuary
- Cygnet River and estuary

- Willson River
- Western River
- Harriet River
- South West River
- Middle River

including aquatic reserves.

SCHEDULE 2

- Beach seine nets with minimum dimensions of 1 mm, maximum length of 20 m and maximum height of 2 m.
- Small baited hooks and line.

SCHEDULE 3

1. The specimens collected pursuant to this notice may only be used for scientific research purposes and must not be sold.

2. All specimens collected pursuant to this notice must be retained by the University of Adelaide or transferred to the South Australian Museum.

3. Before collecting any specimens pursuant to this notice, the exemption holder must advise the PIRSA Fisheries Compliance Unit on 1800 065 522, at least 24 hours prior to undertaking the exempted activity, with details of the persons undertaking the exempted activity, proposed locations and the dates on which the collections are to be made.

4. The exemption holder or her agents must not conduct any other fishing activity including recreational fishing whilst undertaking the exempted activity.

5. While engaged in the exempted activity, the exemption holder or her agents must be in possession of a copy of this notice. The exemption holder must also provide each of the agents with a short letter confirming that they may act as her agents. A copy of this notice and such a letter must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

6. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

7. The exemption holder must provide a report in writing detailing the outcomes of the research and the collection of organisms pursuant to this notice to the Director of Fisheries, (G.P.O. Box 1625, Adelaide, S.A. 5001) by 30 June 2004, giving the following details:

- the date and time of collection;
- the description of all species collected; and
- the number of each species collected.

FISHERIES ACT 1982: SECTION 59

TAKE note that the notice made under section 59 of the Fisheries Act 1982, and published in the *South Australian Government Gazette* on page 635, dated 4 March 2004, being the second notice on that page, referring to Dr Bronwyn Gillanders and the collection of marine and/or estuarine organisms, is hereby revoked.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, William Ritter, (the 'exemption holder') is exempted from Regulations 4 and 5 of the Fisheries (Vessel Monitoring Scheme) Regulations 2003, insofar as he is permitted to undertake fishing activity pursuant to the licence using a tender boat that is registered and endorsed on the licence, without having an operational VMS fitted on the registered boat, provided that the boat is one of two registered boats endorsed on the licence, and the other registered boat does have an operational VMS unit fitted to it in accordance with the Regulations (the 'exempted activity').

This exemption is granted subject to the conditions set out in the Schedule, and has effect from 30 April 2004 until 31 May 2004, unless this notice is varied or revoked earlier.

SCHEDULE

1. The exempted activity may only be undertaken when fishing pursuant to Northern Zone Rock Lobster Fishery Licence No. N077.

2. The exemption holder or a registered master endorsed on the licence must contact PIRSA Fishwatch on 1800 065 522 prior to conducting the exempted activity, on each day that the exempted activity is to be undertaken, and provide the following information:

- licence number;
- the name of the person making the call;
- the date and time the exempted activity will commence;
- an estimated time when the fishing activity will end; and
- the area in which the exempted activity will be conducted.

3. The exemption holder must ensure that all commercial rock lobster pots are secured in a place that is not within the vicinity of any registered boat endorsed on the licence, being a place where a Fisheries Officer can inspect those pots.

4. No rock lobster pots may be on board the tender boat during the exempted activity.

5. No rock lobster may be taken, or be on board the boat, during the exempted activity.

6. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

7. An exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any other regulations made under that Act except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, any holder of a licence issued pursuant to the Fisheries (Scheme of Management—Abalone Fisheries) Regulations 1991, or the registered master endorsed on that licence (the 'exemption holder'), is exempt from section 34 of the Fisheries Act 1982 and the Fisheries (Scheme of Management—Abalone Fisheries) Regulations 1991; and clause 1 of Schedule 6 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder may take blacklip abalone (*Haliotis rubra*) and greenlip abalone (*Haliotis laevigata*) including undersized abalone of those species, from South Australian coastal waters (the 'exempted activity'), subject to the conditions in schedule 1, from the date of the gazettal of this notice until 30 June 2004, unless varied or revoked earlier.

SCHEDULE 1

1. The exempted activity may only be conducted by the exemption holder as a participant in FRDC Project 2001/201.

2. The exemption holder may only engage in the exempted activity at the direction of Dr Marty Deveney of PIRSA Aquaculture or Dr Stephen Mayfield of SARDI Aquatic Sciences.

3. A total of 240 blacklip and 240 greenlip abalone may be taken pursuant to this notice. Individual exemption holders must seek direction from Dr Marty Deveney of PIRSA Aquaculture or Dr Stephen Mayfield of SARDI Aquatic Sciences prior to engaging in the exempted activity regarding the numbers of each species of abalone to be collected and the location from which they may be collected.

4. Abalone taken pursuant to this notice may only be used for scientific purposes and must not be sold or traded.

5. All abalone taken pursuant to this notice must be transferred to Gribbles VetLab (formerly IDEXX VetLab), 33 Flemington Street, Glenside (phone: (08) 8202 3333 or 1300 307 190) for the purposes of disease and pathogen investigation.

6. The exemption holder must notify PIRSA Fishwatch on 1800 065 522 prior to commencing the exempted activity on the day the activity occurs.

7. While engaged in the exempted activity the exemption holder must carry or have about or near their person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer upon request.

8. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
