Notice of Approval of Contingencies

NO. 9 OF 2004

INDEPENDENT GAMBLING AUTHORITY, by this notice, approves contingencies relating to sporting or other events within or outside Australia for the purposes of betting operations conducted under a bookmaker's licence:

1. Citation

(1) This notice may be cited as the Approved Contingencies (Olympic Games—Bookmakers) Notice 2004.

(2) This notice amends the notice dated 20 June 2003 published in the *Government Gazette* on 26 June 2003 at pages 2634-2645, in this notice called 'the Principal Notice'.
