FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the exemption issued to Tony Lee dated 21 July 2005 is hereby revoked.

Take notice that pursuant to section 59 of the Fisheries Act 1982, Tony Lee, P.O. Box 242, Mount Gambier, S.A. 5290 (the 'exemption holder') is exempt from section 34 of the Fisheries Act 1982, but only insofar as the exemption holder may take Turbo (*Turbo undulatis*) for the purpose of trade or business from South Australian coastal waters (the 'exempted activity'), subject to the conditions in Schedule 1 from 19 December 2005 until 30 June 2006, unless revoked or varied earlier.

4. Turbo must not be landed at a time that is earlier than the estimated time of landing provided to PIRSA Fisheries in accordance with condition 3.

5. If the exemption holder is not able to land Turbo at the place or estimated time notified in accordance with condition 3 above (or within 30 minutes after the estimated time), the exemption holder must make a new report to PIRSA Fisheries by calling 1800 065 522. This new report must be made before the original estimated time provided in accordance with condition 3 and provide a new time of landing or place of landing.

6. Turbo must not be landed at a time that is earlier than the estimated time of landing provided to PIRSA Fisheries in accordance with condition 5.

7. Within half an hour of landing Turbo the exemption holder must weigh the Turbo and complete the daily log sheet in accordance with condition 8.

8. The exemption holder must provide the Director of Fisheries separate statistical catch and effort information, in the form of a log sheet as provided by the Director. The exemption holder must complete the log sheet every day and submit a completed monthly log to the Director no later than the 15th day of the month following the month to which the log sheet relates. The log sheet must be submitted to the Director at the address specified on the approved log sheet. If no fishing activity was undertaken or no fish were taken on a day or during the month, a nil return must still be completed and submitted to the Director.

9. The exemption holder must allow a Departmental Officer to accompany the exemption holder at any time during fishing operations.

10. While engaged in the exempted activity the exemption holder must carry or have about or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer upon request.

11. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

Open Season for Ducks

PURSUANT to section 52 of the National Parks and Wildlife Act 1972, I, John Hill, Minister for Environment and Conservation, being the Minister for the Crown to whom the administration of the National Parks and Wildlife Act 1972, is for the time being committed, declare an open season for the taking of protected animals as set in this notice.

1. General Open Season

1.1 Area of the State

1.1.1 The open season applies to those species of protected animals listed in Clause 1.1.2 over the whole of the State, excluding any reserves constituted under the National Parks and Wildlife Act 1972, or any wilderness protection area or any wilderness protection zone constituted under the Wilderness Protection Act 1992, other than the game reserves listed in Clause 2 of this notice.

2.1.3 A person shall not, without the written permission of the Director of National Parks and Wildlife, take duck during the period between half an hour after sunset on any one day of the open season and quarter of an hour before sunrise on the next day.

2.2 Moorook Game Reserve

2.2.1 The open season applies to all the Reserve, other than the strip of land 100 m wide on the western boundary of sections 474, 475 and 476, Hundred of Moorook, County of Albert, adjacent to the Kingston-Loxton Highway.

2.3.1 The open season applies to all creeks and associated backwaters of the Reserve, north of the marked navigation channel of Chambers Creek, excluding a 500 m radius of any house or outbuilding, and within 300 m of any road or bridge and for safety reasons, the open season does not apply to all of the area, within 500 m radius of the homestead of Section 706, McIntosh Division, Hundred of Cobdogla Irrigation Area.

Note: Access to Loch Luna is mainly by boat—all hunters should be aware of dangerous quicksand in a number of areas.

2.4 *Tolderol Game Reserve**Area*

2.4.1 The open season applies to all the Reserve, other than, Section 349, Hundred of Freeling, County of Sturt, as the area containing the ponded wetlands.

2.4.2 Subject to Clause 2.4.3 of this notice, the period of the open season for the Tolderol Game Reserve is 6.30 a.m. on Saturday, 18 February 2006 to 5.35 p.m. on Sunday, 25 June 2006.

1.1.2 Stubble Quail (*Coturnix pectoralis*).

1.2 *Period*

1.2.1 Subject to Clause 1.2.2 of this notice, the open season for those areas described in Clause 1.1 of this notice is from 6.30 a.m. on Saturday, 18 February 2006 to 5.35 p.m. on Sunday, 30 July 2006.

- 1.2.2 A person shall not, without the written permission of the Director of National Parks and Wildlife, take the abovementioned species of quail during the period between sunset on any one day of an open season and sunrise on the next day.

2. *Prohibition Against Taking Eggs*

- 2.1 A person shall not take quail eggs during the open season.

3. *Bag Limit*

- 3.1 On the first day of the open season, a person shall not have possession, or control, of more than 25 Stubble Quail (*Coturnix pectoralis*).
