DEVELOPMENT ACT 1993: SECTION 46 (4)

Preamble

1. On 5 June 2003, the Minister for Urban Development and Planning, by notice in the *Gazette* (see *Gazette* 5 June 2003, page 2380) declared that section 46 of the Development Act 1993, applied to a development of a kind specified in Schedule 1 of that notice. The declaration applied to a land division proposal in the Buckland Park area near Virginia.

2. It has been decided to vary the declaration.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Tracy Warland, P.O. Box 2236, Port Lincoln, S.A. 5607, (the 'exemption holder'), or a person acting as her agent, is exempt from the Fisheries (General) Regulations 2000 but only insofar as the exemption holder shall not be guilty of an offence when engaging in the collection of the organisms listed in Schedule 1 in the waters described in Schedule 2 (the 'exempted activity'), subject to the conditions specified in Schedule 3, from 1 January 2007 until 31 December 2007, unless varied or revoked earlier.

SCHEDULE 1

- Up to two egg-bearing male and two female weedy seadragon (*Phyllopteryx taeniolatus*);
- up to ten spotted pipefish (*Stigmatopora argus*);
- up to ten wide-bodied pipefish (*Stigmatopora nigra*);
- up to ten short-snouted seahorses (*Hippocampus breviceps*); and
- up to ten pot bellied seahorses (*Hippocampus abdominalis*) or (*Hippocampus bleekeri*).

SCHEDULE 2

South Australian coastal waters excluding aquatic reserves and excluding waters within one nautical mile of the jetties at Rapid Bay and Second Valley.

SCHEDULE 3

1. All specimens taken pursuant to this notice may be used for broodstock purposes only and may not be sold or traded without written consent from the Director of Fisheries.

2. Seadragons of the same sex must not be collected within 5 km of each other.

3. No more than five short-snouted seahorses (*Hippocampus breviceps*) may be collected within 5 km of any one collection site.

4. No more than five pot bellied seahorses (*Hippocampus abdominalis*) or (*Hippocampus bleekeri*) may be collected within five kilometres of any one collection site.

5. No more than five spotted pipefish (*Stigmatopora argus*) of the same sex may be collected within five kilometres of any one collection site.

6. No more than five wide-bodied pipefish (*Stigmatopora nigra*) of the same sex may be collected within five kilometres of any one collection site.

7. All specimens taken pursuant to this notice must be retained at the site endorsed on Land Based Aquaculture Licence No. FT00550.

8. The exemption holder must provide a written report on the number of animals taken, specific location and their condition to the Director of Fisheries (Attention: Alex Chalupa, P.O. Box 1625, Adelaide, S.A. 5001) within seven days of the completion of each collection.

9. The exemption holder must provide a written report on the progress of captive breeding of any gravid seadragons collected (*Phyllopteryx taeniolatus*) including methods used and survival rates of offspring, to the Director of Fisheries (Attention: Alex Chalupa, P.O. Box 1625, Adelaide, S.A. 5001) prior to 31 December 2007.

10. Before collecting any specimens pursuant to this notice, the exemption holder must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption with them at the time of making the call and be able to provide information about the area and time of the exempted activity, the vehicles and boats involved, the number of agents undertaking the exempted activity and other related issues. Exemption No. 9901954.

11. Whilst engaged in the exempted activity the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if requested.

12. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 43


FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Neil Carrick (the 'exemption holder'), or a person acting as his agent is exempt from Clause 34, Schedule 1 of the Fisheries (General) Regulations 2000 prohibiting the use of fish nets in specified areas, but only insofar as the exemption holder may only collect sea mullet (*Mugil cephalus*) from the closed area of Streaky Bay for feasibility studies (the 'exempted activity'), subject to the conditions specified in Schedule 1, from 1 January 2007 until 30 June 2007, unless this notice is varied or revoked earlier.

SCHEDULE 1

1. A copy of the proposed sampling timeframe must be provided to PIRSA Fisheries prior to the commencement of the exempted activities.
2. The exemption holder may only take sea mullet (*M. cephalus*) pursuant to this exemption, all other species must be returned to the water.
3. Only gill nets with minimum mesh sizes of 3.5 inch (8.9 cm) and 4 inch (10.2 cm) may be used pursuant to this exemption.
4. The exempted activity may only be undertaken in depths of 3 m or less.
5. The exempted activity can only be undertaken between 0600 hours and 2000 hours on any given day.
6. The exempted activity may only take place in the five regions of Streaky as shown in Schedule 2.
7. A maximum of 10 tonnes of sea mullet (*M. cephalus*) may be taken pursuant to this exemption.
8. All fish must be accurately weighed and consigned to a registered fish processor within 12 hours of being landed.
9. Within 24 hours of consigning the catch to a registered fish processor, the exemption holder must provide PIRSA fisheries with copies of receipts indicating the total landed weight. These are to be faxed to PIRSA Fisheries 8226 0434 (Policy) and 8449 1646 (Compliance).
10. Information about fish collected pursuant to this exemption must be recorded in the Marine Scalefish Daily Fishing Log sheets that are completed in accordance with the Fisheries (Scheme of Management—Marine Scalefish Fisheries) Regulations 2006. This information may be recorded on the same log sheet as information supplied for normal fishing activities for that day. Each log sheet is to be provided to SARDI in accordance with the regulations.
11. The exemption holder must notify PIRSA Fisheries on 1800 065 522 at least 12 hours prior to conducting the exempted activity and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption notice at the time of making the call and be able to provide information about the area and time of the exempted activity, the vessels and vehicles involved and other related questions. Exemption No. 9901949.
12. The exemption holder must allow a Fisheries Officer or another nominated person to be present on board the boat during the exempted activity if requested by PIRSA Fisheries.
13. The exempted activity may be undertaken on behalf of the exemption holder by the following agents: L. Wright (N079), J. R. Wright (M522), N. Schmucker (M012) and J. Paleologoudias (M518).
14. Only commercial fishing vessels, registered by endorsement on the licences listed in Condition 13 may be used pursuant to this exemption.
15. While engaged in the exempted activity, the exemption holder or a person acting as their agent must have in their possession a copy of this notice and produce a copy of this notice if requested by a PIRSA Fisheries Compliance Officer.
16. The agents may not undertake any other fishing activities whilst undertaking the exempted activity.
17. A report outlining the outcomes of the study as described in the application material must be provided to PIRSA Fisheries within two months of the exemption expiry date.
18. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulation made under that Act, except where specifically exempted by this notice.

3.1 On the first day of the open season, a person shall not have possession, or control, of more than 10 Stubble Quail (*Coturnix pectoralis*).

3.2 On any other day of the open season, a person shall not take more than 10 Stubble Quail (*Coturnix pectoralis*).
