TAKE notice that pursuant to section 115 of the Fisheries Management Act 2007, Tracy Warland of South Australian Seahorse Marine, 20 Divett Street, Port Adelaide, S.A. 5015, (the 'exemption holder'), or a person acting as her agent, is exempt from the section 71 of the Fisheries Management Act 2007 but only insofar as the exemption holder shall not be guilty of an offence when engaging in the collection of the organisms listed in Schedule 1 in the waters described in Schedule 2 (the 'exempted activity'), subject to the conditions specified in Schedule 3, from 25 March 2009 until 31 December 2009, unless varied or revoked earlier.

6. No more than five widebody pipefish (*Stigmatopora nigra*) may be collected within 5 km of any one collection site.

7. All specimens taken pursuant to this notice must be retained at the site endorsed on land based Aquaculture Licence No. AQ00079.

8. The exemption holder must provide a written report on the number of animals taken, specific location and their condition to the Director of Fisheries (Attention: Mark Ayliffe, G.P.O. Box 1625, Adelaide, S.A. 5001) within seven days of the completion of each collection.

9. The exemption holder must provide a written report on the progress of captive breeding of any gravid seadragons collected (*Phyllopteryx taeniolatus*) including methods used and survival rates of offspring, to the Director of Fisheries (Attention: Mark Ayliffe, G.P.O. Box 1625, Adelaide, S.A. 5001) prior to 31 December 2009.

10. Before collecting any specimens pursuant to this notice, the exemption holder must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 and answer a series of questions about the exempted activity. RULES OF COURT

District Court Civil Rules 2006 (Amendment No. 9)

BY virtue and in pursuance of section 51 of the District Court Act 1991 and all other enabling powers, we, Terence Anthony Worthington, Chief Judge, Dean Ernest Clayton, and Kevin Gordon Nicholson, Judges of the District Court of South Australia, make the following Rules of Court:

1. These rules may be cited as the District Court Civil Rules 2006 (Amendment No. 9).
2. The District Court Civil Rules 2006 as amended by these Rules may be cited as the District Court Civil Rules 2006.
3. The District Court Civil Rules 2006 are amended as set out below.
4. These amendments will commence on 1 April 2009, or upon their gazettal, whichever is the later.
5. A new Rule 204A is inserted immediately after Rule 204 as follows:

‘204A—Warrants of possession to be executed more than six months after the possession order

- (1) This rule applies to any warrant of possession which is to be executed more than six months after the making of the order for possession on which it is based.
- (2) A plaintiff must not cause a warrant to which this rule applies to be executed unless:
 - (a) it was issued by permission of the Court under this rule; or
 - (b) it was issued under subrule (8).
- (3) At least 10 days before applying for the issue of a warrant to which this rule applies, a plaintiff is to send, by ordinary prepaid post, a notice in an approved form to:
 - (a) each defendant at their last known address; and
 - (b) the occupiers of the premises which are to be the subject of the warrant.
- (4) A defendant or occupier who wishes to oppose the issue of the warrant, must, within 10 days of the date of the notice sent to them, file in the Court a request, in an approved form, for a hearing together with any affidavits deposing to facts on which they seek to rely.
- (5) If a request under subrule (4) is filed the Registrar will, before issuing a warrant of possession, convene an urgent hearing by the Court and will send notice of it to all plaintiffs and defendants and to all persons identified in the application for the issue of the warrant or in the request for a hearing as an occupier of the premises.
- (6) Upon a hearing under subrule (5) the Court will consider whether, having regard to the circumstances which have occurred since the making of the order for possession, there is any good and sufficient reason why permission for the warrant to issue should not then be granted and, unless satisfied that such reason exists, will order the issue of the warrant.
- (7) The plaintiff may prove compliance with subrule (3) by filing a certificate in the approved form.
- (8) When a certificate has been filed under subrule (7), and no request has been received under subrule (4), the Registrar may issue the warrant of possession.’

BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999

By-law No. 8—Vehicles

FOR the management and regulation of the movement of vehicles on roads and access to and use of Local Government Land by vehicles.

1. *Definitions*

In this by-law:

- 1.1 'Authorised Person' has the same meaning as in the Local Government Act 1999;
- 1.2 'Local Government Land' means all land owned by the Council or under the Council's care, control and management;
- 1.3 'Road' has the same meaning as in the Local Government Act 1999;
- 1.4 'Vehicle' has the same meaning as in the Road Traffic Act 1961 and Australian Road Rules.

2. *Activities Requiring Permission*

A person must not, without the permission of the Council undertake any of the following activities:

2.1 *Animals*

Drive, ride or exercise any animal on a Road or Local Government Land except in an area where the Council has set aside a track or other area for the use by or in connection with an animal of that kind.

2.2 *Flora*

Ride or drive any vehicle or animal on any flower bed or garden plot on a Road or Local Government Land.

2.3 *Vehicles on Parklands*

- 2.3.1 drive or propel a Vehicle on Local Government Land, unless on an area constructed or set aside by the Council for the parking or travelling of Vehicles of that kind;
- 2.3.2 ride, drive or propel a bicycle or skateboard on Local Government Land except upon paths or areas set aside for that purpose;
- 2.3.3 promote, organise or take part in any race, test or trial of any kind in which Vehicles or bicycles take part on Local Government Land except in an area where the Council has set aside a track or other area for use in connection with that purpose;
- 2.3.4 drive or propel a Vehicle on any Local Government Land without payment of the fee for the entry of Vehicles to that land, where the Council has authorised by resolution a fee to be charged for that purpose.

3. *Obey Signs*

The driver of a Vehicle on Local Government Land must obey the indications given by any sign erected by or with the authority of the Council, for regulating traffic or indicating the direction or route to be followed by traffic on that land.

4. *Directions*

- 4.1 A person must comply with any reasonable direction or request from an Authorised Person relating to:
 - 4.1.1 that person's use of a Vehicle or animal on Local Government Land;
 - 4.1.2 that person's safety on Local Government Land;
 - 4.1.3 the safety or enjoyment of Local Government Land by other persons.

5. *Exemptions*

The restrictions in this by-law do not apply to any Police Officer, Council Officer or Council employee acting in the course and within the scope of that person's normal duties or to a contractor while performing work for the Council and while acting

under the supervision of a Council Officer, or to the driver of an emergency vehicle when driving an emergency vehicle as defined in the Road Traffic (Road Rules—Ancillary and Miscellaneous Provisions) Regulations 1999 and the Australian Road Rules 1999.

6. *Application of Paragraphs*

Any of subparagraphs 2.1, 2.3.1, 2.3.2, 2.3.3 and 2.3.4 of this by-law shall apply only in such portion or portions of the area as the Council may by resolution direct (in accordance with section 246 (3) (e) of the Local Government Act 1999).

This foregoing by-law was duly made and passed at a meeting of the Council of the City of Mitcham held on 24 March 2009, by an absolute majority of the members for the time being constituting the Council, there being at least two-thirds of the members present.
