## POLICE ACT 1998

*Directions to the Commissioner of Police*

PURSUANT to section 6 of the Police Act 1998, I, Michael Wright, Minister for Police, hereby give the following directions to the Commissioner of Police relating to the control and management of South Australia Police:

*Definitions*

1. In these Directions, unless the context otherwise implies:

‘ASIO Agreement’ means the agreement regulating the relationship between ASIO and South Australia Police approved by the Governor in Executive Council on 2 September 1982, or any subsequent agreement replacing this agreement;

‘Auditor’ means the Auditor or a Deputy Auditor appointed pursuant to the provisions of Clause 7;

‘Branch’ means the State Protective Security Branch as constituted pursuant to the Notice published in the *Police Gazette* on 11 December 2002 or any subsequent group substituted for this Branch;

‘Critical Infrastructure’ includes those physical facilities, supply chains, information technologies and communication networks which, if destroyed, degraded or rendered unavailable for an extended period, would significantly impact on the social or economic well-being of the nation, State or Territory of Australia, or affect Australia’s ability to conduct national defence and ensure national security;

‘Intelligence’ means information of any kind and from any source whatsoever which is created or held by the Intelligence Section for operational or audit purposes, but does not include information created or held for administrative reasons;

‘Intelligence Section’ means the Security Intelligence Section as constituted pursuant to the Notice published in the *Police Gazette* on 11 December 2002 and the provisions of Clause 2, or any subsequent group substituted for this Section;

‘Minister’ means the Minister for Police or any subsequent portfolio that includes responsibility for South Australia Police;

‘Records’ means the records established and maintained by the Intelligence Section pursuant to Clause 6 and includes records that are contained in or reproduced from an electronic data storage system and any copies or duplicates thereof in whatever form;

‘Terrorism act’ means a terrorist act as defined under Australian law (and in general terms is an act or threat, intended to advance a political, ideological or religious cause by coercing or intimidating an Australian or foreign government or the public, by causing serious harm to people or property, creating a serious risk to the health and safety to the public, or seriously disrupting trade, critical infrastructure or electronic systems);

‘Terrorism incident’ means a combination of circumstances or conditions which may lead to or result from a terrorist act, and which require preventative and/or responsive action.

*Structure and Function of the Intelligence Section*

2. The Officer in Charge of the Branch will maintain an Intelligence Section and it shall include at least one Officer.

3. Subject to these Directions, the Intelligence Section shall discharge its functions by:

- (i) gathering, receiving and analysing intelligence pursuant to Clause 4;
- (ii) recording intelligence for retrieval as required; and
- (iii) disseminating such intelligence pursuant to the provisions of Clause 5.

4. The Intelligence Section shall collect, record and disseminate intelligence only with respect to:

- (a) any person, place, activity or thing, where there is reasonable cause to suspect, the commission, the supporting, assisting or inciting the commission of:
  - (1) an act or threat of force or violence directed towards the overthrow, destruction or weakening of the constitutional Governments of the States, Commonwealth, a Territory; or a foreign country;

- (2) an act or threat of violence calculated to evoke extreme fear for the purpose of achieving a political, ideological, or religious objective in Australia or in a foreign country;
  - (3) an act or threat of violence against the safety or security of any dignitary;
  - (4) violent behaviour within or between community groups;
  - (5) an act or threat of force, violence or unlawful interference directed towards critical infrastructure;
  - (6) any terrorism act or terrorism incident; or
  - (7) Any criminal act or breach of the peace incidental to Clause 4 (a) (1-6).
- (b) any person, place, activity or thing that may be at risk from the activities or behaviour referred to in this clause;
  - (c) any person, place, activity or thing that may be able to provide information regarding the activities referred to in this clause;
  - (d) for the purpose of this clause, ‘dignitary’ means:
    - (i) the Governor-General of the Commonwealth, the Governor of a State or the Administrator of a Territory;
    - (ii) any Minister of the elected Government, any member of Executive Government, or any member of the Judiciary of the Commonwealth or of any State or Territory;
    - (iii) any person who, for the time being, occupies the office or discharges the functions of an Officer or person referred to in paragraph (i) or (ii);
    - (iv) the Head of State of a foreign country;
    - (v) any accredited representative of the Head of State of a foreign country;
    - (vi) any person of a foreign country who occupies an office that is or discharges functions that are similar to that or those occupied or discharged by an Officer or person referred to in paragraph (iv) or (v); or
    - (vii) any person whom the Minister, the Commissioner of Police, the Deputy Commissioner of Police or the Assistant Commissioner responsible for the Branch determines to be a dignitary. In the case of a determination made under this subparagraph, the Auditor and the Minister are to be advised.

*Dissemination*

5. (a) except as provided by these Directions no person shall have or be given access to intelligence held by the Intelligence Section:

(b) intelligence may only be disseminated to:

- (1) members of the South Australia Police involved in or concerned with the investigation, prevention or containment of situations referred to in Clause 4;
- (2) members of other law enforcement agencies who are carrying out a similar function to the Branch or are involved in the investigation, prevention or containment of situations referred to in Clause 4;
- (3) the Australian Security Intelligence Organisation;
- (4) any Minister of the Crown;
- (5) any person to whom the provisions of Clause 4 (b) or (c) apply;
- (6) the Commissioner of Police, the Deputy Commissioner of Police, Assistant Commissioner(s) or Director(s) of Police for the effective and efficient operations of the South Australia Police;
- (7) any member of the Branch for the effective and efficient operation of the Branch; or
- (8) any other person the Assistant Commissioner responsible for the Branch deems proper and legitimate for the protection or safety of persons or property or the efficient and effective operation of the South Australia Police.

*Maintaining Records*

6. (a) the Officer in Charge of the Intelligence Section will ensure records are established and maintained to the satisfaction of the Auditor, so as to ensure the fair, complete and accurate recording of the intelligence holdings of the Section;
- (b) without derogating from the generality of subclause (a) the records shall provide fair, complete, and accurate particulars of:
- (1) the intelligence held by the Intelligence Section;
  - (2) any determination made pursuant to Clause 5 (b) (8); and
  - (3) when, to whom, by whom and for what purpose intelligence was disseminated pursuant to Clause 5;
- (c) clause 6 (b) does not apply to intelligence disseminated to members of the Branch, the Protective Security Co-ordinator (Counter Terrorism) and the Assistant Commissioner responsible for the Branch pursuant to Clause 5;
- (d) the Officer in Charge of the Intelligence Section may set policy concerning the dissemination of intelligence pursuant to Clause 5 providing such policy is consistent with these Directions;
- (e) the Officer in Charge of the Intelligence Section shall ensure records that are no longer required for the operational needs of the Section are culled and destroyed after a period of three years;
- (f) the Officer in Charge of the Intelligence Section may set policy concerning the culling and destruction of records providing such policy is consistent with these Directions.

*Audit*

7. (a) The records of the Intelligence Section may at any time be subject to inspection by the Commissioner of Police, the Deputy Commissioner of Police or an Assistant Commissioner of Police;
- (b) for the purposes of these Directions the Minister shall appoint an Auditor who shall serve in that capacity for a period not exceeding three years from the date of appointment. The Minister may appoint a Deputy Auditor to act as Auditor in the event that the appointed Auditor is unable to perform the function. Neither the Auditor nor a Deputy Auditor shall be an officer of the Public Service or a member of the South Australia Police;
- (c) at least once per financial year, the Auditor will conduct an inspection of the records of the Intelligence Section;
- (d) the Auditor shall, on or before 30 September in each year, prepare and present a report to the Minister on the compliance of the Intelligence Section with these Directions for the period of 12 months ending on 30 June in that year;
- (e) intelligence obtained by the Auditor in the course of his/her duties pursuant to these Directions shall not be disclosed except where necessary for the purposes of any inspection, direction or report made or approval given by the Auditor pursuant to these Directions.

## **Tobacco Products Regulation (Exemption) Proclamation 2010**

under section 71 of the *Tobacco Products Regulation Act 1997*

### **1—Short title**

This proclamation may be cited as the *Tobacco Products Regulation (Exemption) Proclamation 2010*.

### **2—Commencement**

This proclamation comes into operation on the day on which it is made.

### **3—Interpretation**

In this proclamation—

*Act* means the *Tobacco Products Regulation Act 1997*;

*prescribed period* means the period commencing on 10 February 2010 and ending on 10 March 2010;

*prescribed production* means the stage production of *The Chronic Ills of Robert Zimmerman* produced by the Tamarama Rock Surfers Theatre Company.

### **4—Application of proclamation**

This proclamation applies to the following persons:

- (a) a person employed by, or in relation to, the prescribed production;
- (b) an occupier of the Bakehouse Theatre at 255 Angas Street, Adelaide;
- (c) an employer with responsibility for a workplace consisting of the Bakehouse Theatre in relation to the prescribed production.

### **5—Exemption from section 46 of the Act**

- (1) A person to whom this proclamation applies is exempt from the operation of section 46 of the Act in relation to smoking occurring in the course of a performance or rehearsal of the prescribed production during the prescribed period.
- (2) An exemption under this clause is subject to the following conditions:
  - (a) smoking may only occur on a stage on which the prescribed production is being performed or rehearsed, or in a rehearsal room used in relation to the prescribed production;
  - (b) the area in which smoking may occur under the exemption must be well ventilated;
  - (c) a person may only smoke a tobacco product of a kind contemplated by paragraph (g) of the definition of *tobacco product* in section 4 of the Act.
- (3) If a person contravenes or fails to comply with a condition of an exemption specified in subclause (2), the exemption does not, while the contravention or non-compliance continues, operate in that person's favour.

## Part 1—Preliminary

### 1—Short title

These regulations may be cited as the *Upper South East Dryland Salinity and Flood Management (Statutory Easements) Variation Regulations 2010*.

### 2—Commencement

These regulations will come into operation on the day on which section 8 of the *Upper South East Dryland Salinity and Flood Management (Extension of Project) Amendment Act 2009* comes into operation.

### 3—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

## Part 2—Variation of *Upper South East Dryland Salinity and Flood Management Regulations 2002*

### 4—Insertion of regulation 8A

After regulation 8 insert:

#### 8A—Statutory easements

- (1) The easements set out in Schedules 3 and 4 are prescribed for the purposes of sections 12 to 12C (inclusive) of the Act.
- (2) The following scheme applies for the purposes of matching an easement to the nature of the land and the nature of the works to be undertaken for the purposes of the Project:
  - (a) the easement set out in Schedule 3 applies in relation to land within a project works corridor that is private land;
  - (b) the easement set out in Schedule 4 applies in relation to land within a project works corridor that is public land.
- (3) A reference in Schedule 3 or 4 to *relevant land* is a reference to land subject to an easement under this regulation.
- (4) In this regulation—

*private land* means land other than public land;

*public land* has the same meaning as in section 12(12) of the Act.

### 5—Insertion of Schedules 3 and 4

After Schedule 2 insert:

#### Schedule 3—Statutory easement—private land

##### 1—Statutory easement—private land

- (1) The terms of a statutory easement for private land are set out as follows.
- (2) The Minister has exclusive possession over the relevant land.
- (3) The following persons may enter the relevant land at any time:
  - (a) the Minister;
  - (b) an employee of the administrative unit of the Public Service that is, under the Minister, responsible for the administration of the Act;
  - (c) an agent of the Minister;
  - (d) a contractor engaged by the Minister for the purposes of undertaking any designated works;
  - (e) any other person authorised by the Minister in connection with the operation of the easement.
- (4) A person who enters the relevant land under subclause (3) may—
  - (a) remove any items, stock or fixtures on the relevant land; and

- (b) break the surface of, dig, open up or use the relevant land for the purpose of constructing, laying down, fixing, taking up, repairing, replacing, re-laying or examining drains, pipes, channels, banks, bridges, weirs, monitoring stations or other forms of works or infrastructure; and
  - (c) remove weeds or vermin, and clear vegetation and other material, located on the relevant land; and
  - (d) make inspections and surveys, take measurements, undertake tests, and take samples of any substance or thing; and
  - (e) carry out fencing work; and
  - (f) carry out other work authorised by the Minister for any purpose associated with the Project.
- (5) The Minister, and any person acting on behalf of the Minister, may—
- (a) use and maintain, and alter or replace, any drains, pipes, channels, banks, bridges, weirs, stations or other forms of works or infrastructure located on the relevant land; and
  - (b) intercept, divert, store or transport any water on or under the relevant land (including water that has flowed on to the relevant land).
- (6) Subject to the operation of the preceding subclauses, a person must not enter the relevant land, or permit stock or other animals to enter or remain on the relevant land, unless authorised by the Minister to do so.
- (7) Subclause (6) does not, however, apply—
- (a) to temporary access to the relevant land in an emergency situation; or
  - (b) to access to the relevant land by a person before the commencement of work for the purposes of the Project, if the person—
    - (i) does not erect a fence on the relevant land, or along the boundary of the relevant land, without the approval of the Minister; and
    - (ii) does not undertake any activity on or in relation to the relevant land contrary to any written direction of the Minister; and
    - (iii) complies with any written direction of the Minister to vacate the relevant land and to remove any plant, machinery, infrastructure or other items, or any animals, specified by the Minister; or

- (c) to access to the relevant land by a person after the relevant date in relation to the land—
- (i) where the relevant land is not fenced and access is for the purposes of grazing stock, carrying out periodic weed or vermin control or eradication, or undertaking fire prevention or control measures, if the person complies with any written direction of the Minister to cease any such activity, to reduce or replace stock, or to remove any plant, machinery, infrastructure or other items, or any animals, specified by the Minister; or
  - (ii) where the access consists of crossing over the relevant land, with or without stock or machinery, at a crossing point established or provided as part of the Project.
- (8) Without limiting a preceding subclause, the owner of the relevant land—
- (a) must not undertake any activity that constitutes a nuisance or hindrance to the Minister's use of the relevant land or to the exercise of a power conferred on the Minister under the Act or this easement; and
  - (b) without limiting paragraph (a)—must not erect a fence on any part of the relevant land, or along the boundary of the relevant land, without the approval of the Minister;
  - (c) must take reasonable steps to ensure the safety of any person who is permitted by the owner to gain access to the relevant land on account of any access allowed under this easement; and
  - (d) must immediately notify the Minister, in a manner and form determined or approved by the Minister, if the owner damages or obstructs—
    - (i) any aspect of the Project works scheme; or
    - (ii) any Project works, or the operation of any Project works; or
    - (iii) any other aspect of the Project Undertaking,or if the owner becomes aware of any such damage or obstruction.
- (9) In this clause—
- designated works** means any work or other activity in connection with the implementation of the Project or furthering or enhancing the Project Undertaking;
- fencing work** has the same meaning as for the purposes of section 21 of the Act;
- relevant date**, in relation to any land, means—
- (a) the relevant date that applies in relation to the land under section 13 or 13A of the Act (as the case requires); or
  - (b) if the Minister has, by notice published in a newspaper in the area where the land is situated, fixed an earlier date for practical completion of works in relation to the land—that earlier date.

## **2—Saving provision**

To avoid doubt, all Project works and other infrastructure of the Minister on the relevant land (including in the nature of a fixture) remain the property of the Minister despite the establishment of the statutory easement or the effect of any term of the statutory easement.

## **Schedule 4—Statutory easement—public land**

### **1—Statutory easement—public land**

- (1) The terms of a statutory easement for public land are set out as follows.
- (2) The Minister has exclusive possession over the relevant land.
- (3) The following persons may enter the relevant land at any time:
  - (a) the Minister;
  - (b) an employee of the administrative unit of the Public Service that is, under the Minister, responsible for the administration of the Act;
  - (c) an agent of the Minister;
  - (d) a contractor engaged by the Minister for the purposes of undertaking any designated works;
  - (e) any other person authorised by the Minister in connection with the operation of the easement.
- (4) A person who enters the relevant land under subclause (3) may—
  - (a) remove any items, stock or fixtures on the relevant land; and
  - (b) break the surface of, dig, open up or use the relevant land for the purpose of constructing, laying down, fixing, taking up, repairing, replacing, re-laying or examining drains, pipes, channels, banks, bridges, weirs, monitoring stations or other forms of works or infrastructure; and
  - (c) remove weeds or vermin, and clear vegetation and other material, located on the relevant land; and
  - (d) make inspections and surveys, take measurements, undertake tests, and take samples of any substance or thing; and
  - (e) carry out fencing work; and
  - (f) carry out other work authorised by the Minister for any purpose associated with the Project.
- (5) The Minister, and any person acting on behalf of the Minister, may—
  - (a) use and maintain, and alter or replace, any drains, pipes, channels, banks, bridges, weirs, stations or other forms of works or infrastructure located on the relevant land; and
  - (b) intercept, divert, store or transport any water on or under the relevant land (including water that has flowed on to the relevant land).

- (6) Subject to the operation of the preceding subclauses, a person must not enter the relevant land, or permit stock or other animals to enter or remain on the relevant land, unless authorised by the Minister to do so.
- (7) Subclause (6) does not, however, apply—
  - (a) to access to a public road subject to the easement, other than access to any area that has been fenced off by or on behalf of the Minister (in which case the authorisation of the Minister is required); or
  - (b) to temporary access to the relevant land in an emergency situation; or
  - (c) to access by a person to an area that has not been fenced off by or on behalf of the Minister, if the person—
    - (i) does not erect a fence on the relevant land, or along the boundary of the relevant land, without the approval of the Minister; and
    - (ii) does not undertake an activity on or in relation to the relevant land contrary to any written direction of the Minister; and
    - (iii) complies with any written direction of the Minister to vacate the relevant land and to remove any plant, machinery, infrastructure or other items, or any animals, specified by the Minister.
- (8) Without limiting a preceding subclause, the public authority with respect to relevant land—
  - (a) must take reasonable steps to maintain any relevant land that has not been fenced off by or on behalf of the Minister (including by carrying out periodic weed or vermin control or eradication, undertaking fire prevention or control measures, and ensuring public safety to a reasonable degree); and
  - (b) if Project works are situated underneath a public road—subject to subclauses (9) and (10), must take reasonable steps to maintain the public road (including by providing any road base but not so as to be responsible for any barrier that has been erected by or on behalf of the Minister to protect public safety or to prevent access to any area); and
  - (c) must not undertake any activity that constitutes a nuisance or hindrance to the Minister's use of the relevant land or to the exercise of any power conferred on the Minister under the Act or this easement; and
  - (d) must immediately notify the Minister, in a manner and form determined or approved by the Minister, if the owner damages or obstructs—
    - (i) any aspect of the Project works scheme; or
    - (ii) any Project works, or the operation of any Project works; or

- (iii) any other aspect of the Project Undertaking,  
or if the public authority becomes aware of any such damage or obstruction.
- (9) Subclause (8)(b) does not apply to the extent that access to a public road has been permanently blocked by the Minister.
- (10) The public authority with respect to the bridge known as the *G Cutting Bridge* on the Kingston/Keith road must maintain that bridge, in all respects, at its own expense.
- (11) For the purposes of this clause—  
*designated works* means any work or other activity in connection with the implementation of the Project or furthering or enhancing the Project Undertaking;  
*fencing work* has the same meaning as for the purposes of section 21 of the Act.

## 2—Saving provision

To avoid doubt—

- (a) all Project works and other infrastructure of the Minister on relevant land (including in the nature of a fixture) remain the property of the Minister despite the establishment of the statutory easement or the effect of any term of the statutory easement; and
- (b) all works and structures constructed or fixed on or in relation to the relevant land (including roads and bridges) by a public authority remain the property, or under the care, control and management, of the public authority; and
- (c) all other structures lawfully constructed or fixed on or in relation to the relevant land (including pipelines and telecommunications infrastructure) by another entity remain the property of the other entity.
