This proclamation may be cited as the *Administrative Arrangements (Committal of Acts) Proclamation 2011*.

### **2—Commencement**

This proclamation comes into operation on the day on which it is made.

### **3—Committal of Acts**

### **3—Constitution of Minister as body corporate**

The Minister for Workers Rehabilitation is constituted as a body corporate.

## **Administrative Arrangements (References to Minister for Industrial Relations) Proclamation 2011**

under section 8 of the *Administrative Arrangements Act 1994*

### **1—Short title**

This proclamation may be cited as the *Administrative Arrangements (References to Minister for Industrial Relations) Proclamation 2011*.

### **2—Commencement**

This proclamation comes into operation on the day on which it is made.

### **3—Interpretative provision**

A reference to the Minister for Industrial Relations—

- (a) in a statutory instrument under the *WorkCover Corporation Act 1994* or the *Workers Rehabilitation and Compensation Act 1986*; or
- (b) in a contract, agreement or other document made or entered into under or in connection with either of those Acts before the date on which this proclamation is made,

will have effect as if it were a reference to the Minister for Workers Rehabilitation.
