
It is necessary to amend the Wattle Range Council Development Plan dated 8 December 2011.

FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that pursuant to Section 115 of the Fisheries Management Act 2007, Andrew N. Wright, Calypso Star Charters Pty Ltd, Unit 3, 10 South Quay Boulevard, Port Lincoln, S.A. 5606 (the 'exemption holder') is exempt from Section 71 (2) of the Fisheries Management Act 2007 and Regulation 23 of the Fisheries Management (General) Regulations 2007, but only insofar as the exemption holder shall not be guilty of an offence when using blood, bone, meat, offal or skin of an animal as berley to attract White Sharks (*Carcharodon carcharias*) for the purpose of cage viewing in the waters described in Schedule 1 (the 'exempted activity'), subject to the conditions specified in Schedule 2, from 3 February 2012 until 31 March 2012, or unless this exemption is varied or revoked.

SCHEDULE 1

The waters of the Neptune Island Conservation Park.

SCHEDULE 2

1. The exemption holder or the nominated agents listed below must be on board the boat from which the exempted activity is undertaken. The nominated agents of the exemption holder are John Oliver, Simon R. James, Rolf D. Czabayski and Daniel Harvey.

2. All passengers when receiving their instructions at their initial briefing must be provided with a 'Notice to Passengers' letter (attached).

3. All berley used while conducting the exempted activity must consist of fish based products only. All berley (other than fish oil) must be stored below a maximum temperature of 4°C.

4. The exemption holder or his agents must take all measures to avoid any berley or fish oil from being dispersed near or over the submerged viewing cages while divers are in the cage.

5. The exemption holders or their agents must not deliberately goad, provoke or encourage a White Shark in an attempt to change its normal behaviour by undertaking the exempted activity (including deliberately attempting to have the White Shark jump out of the water), and must not permit any person to touch a White Shark, unless this activity is required for research purposes.

6. When using bait as an attractant for the shark, the bait must be attached to a length of rope by natural fibre twine of no less than 30 cm in length.

7. The exemption holder or his agents must not intentionally feed sharks or reward sharks with food.

8. The exemption holder must notify PIRSA Fishwatch on 1800 065 522 at least two hours prior to conducting the exempted activity and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption at the time of making the call and be able to provide information about the area and time of the exempted activity, the vehicles and boats involved, the number of agents undertaking the exempted activity and other related questions. Exemption No. 9902519.

9. The exemption holder or his agents must allow an officer of the Department for Environment and Natural Resources (DENR), a Fisheries Officer or another nominated person to be present on board the boat during the exempted activity if requested by the Executive Director Fisheries and Aquaculture, subject to the availability of space.

10. The exemption holder or his agents must comply with all instructions (including ceasing to berley if so instructed) given by an officer from DENR or a Fisheries Officer.

11. While engaged in the exempted activity, a pennant (approved by DENR) must be flown from the boat so as to be clearly visible.

FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that pursuant to Section 115 of the Fisheries Management Act 2007 ('the Act'), a registered master fishing pursuant to a Northern Zone Rock Lobster Fishery licence (the 'exemption holder') is exempt from Sections 52 and 53 of the Fisheries Management Act 2007 and Clause 18 of Schedule 6 of the Fisheries Management (General) Regulations 2007, but only insofar as the exemption holder, or a person acting as his agent, may take Southern Rock Lobster (*Jasus edwardsii*) using rock lobster pots that do not have escape gaps ('the exempted activity'), subject to the conditions in Schedule 1, during the period 1 February 2012 until 1 February 2013, unless varied or revoked earlier.

SCHEDULE 1

1. A person fishing pursuant to a Northern Zone Rock Lobster Fishery licence may only undertake the exempted activity when an employed independent observer is on board the boat and that observer is undertaking catch sampling for research purposes, in accordance with the agreement between the South Australian Rock Lobster Advisory Council Inc. and SARDI Aquatic Sciences.

2. Data generated from the exempted activity must be forwarded directly to SARDI Aquatic Sciences. Data may not be copied or provided to additional parties.

3. The observers for the purpose of this exemption are the persons acting as agents of the exemption holder and are limited to Emily Johns, Unit 2, 4 Hill Place, Port Lincoln, S.A. 5606; and Timothy Schoepf, 45B Dublin Street, Port Lincoln, S.A. 5606.

4. Only when the observer(s) are on board the boat can the escape gaps on all pots be closed.

5. All escape gaps must be opened as soon as the observer(s) leave the boat.

6. Before conducting the exempted activity, the exemption holder must contact the PIRSA Fishwatch on 1800 065 522 and answer a series of questions about the exempted activity. You will need to have a copy of your exemption with you at the time of making the call, and be able to provide the following details:

- name of the person making the call;
- licence number;
- name of the boat and its registration number;
- the name of the Registered Master on board the boat;
- port of departure;
- number of days at sea; and
- Exemption No. 9902505.

12. The exemption holder must maintain a log for the period that this exemption notice is valid which includes the following information in relation to each trip on which the exempted activity is undertaken:

- date and location;
- number of passengers;
- number of hours berleying;
- number of sharks observed; and
- any other relevant observations or comments.

A copy of the log must be provided to the Port Lincoln office of DENR within 14 days of the end of each calendar month.

13. While engaged in the exempted activity the exemption holder or his agents must have in their possession a copy of this notice and produce a copy of the notice if required by a Fisheries Officer.

14. The exemption holder or his agents must not contravene or fail to comply with the Fisheries Management Act 2007, or any regulations made under the Act, except where specifically exempted by this notice.

1. The permit is valid until 3 February 2013, unless varied or revoked earlier.

2. The permit holder must not sell European carp (*Cyprinus carpio*), meaning sell or give in exchange to any person, company or agent in South Australia.

3. For the purpose of this permit all permitted activities and conditions are pursuant to the land-based aquaculture site AQ00136 licensed under the Aquaculture Act 2001, located in ponds, dams and tanks located at Section 399 in the Hundred of Kuitpo, (Saddlebags Road, Kangarilla, S.A. 5257).

4. The permit holder must keep records of the source of the fish, number of fish, dates held and date, quantity and destination of the fish sold.

5. The permit holder must submit regular reports to Executive Director Fisheries and Aquaculture (G.P.O. Box 1625, Adelaide, S.A. 5001) on a quarterly basis, beginning 1 March 2012, with these details required in Condition 4 above, as well as results of disease testing.

6. The permit holder must not import any live fish (ova, fry, adult) into South Australia unless the shipment has certification from an appropriate authority in the State from which they are obtained that they are free from all relevant notifiable diseases listed pursuant to Section 4 of Livestock Act 1997.

7. The permit holder must prior report to PIRSA Fishwatch on 1800 065 522 at least two hours before transferring fish to and from the site.

8. The permit holder must report suspicion or occurrence of notifiable diseases to the Executive Director Fisheries and Aquaculture as per the Aquaculture Regulations 2005.

9. The permit holder must notify the Executive Director, Fisheries and Aquaculture if an unusually high number of aquatic organisms held on site (AQ00136) die within a period of 24 hours and the cause is not immediately apparent as per the Aquaculture Regulations 2008.

10. While engaged in the permitted activity, the permit holder must be in possession of a copy of this notice. Such notice must be produced to a Fisheries Officer if requested.

11. The permit holder must not contravene or fail to comply with the Fisheries Management Act 2007, or any regulations made under that Act, except where specifically permitted by this notice.



RADIATION PROTECTION AND CONTROL ACT 1982

SECTION 44

*Notice by Delegate of the Minister for Sustainability,
Environment and Conservation*

PURSUANT to Section 44 of the Radiation Protection and Control Act 1982, I, Graeme Robert Palmer, Manager of the Radiation Protection Branch of the Environment Protection Authority, being a person to whom the powers of the Minister under that section have been delegated under the Act, exempt diagnostic radiographers from the requirements of Regulation 40 of the Radiation Protection and Control (Ionising Radiation) Regulations 2000, subject to the following conditions:

1. This exemption only applies to the exposure of a person to ionising radiation for the purposes of plain radiography where the exposure has been directed by Stephen Wake while engaged in the capacity of Nurse Practitioner at an Emergency Department, and
2. The direction referred to in Condition 1 must comply with the following requirements:
 - (a) it must be in writing;
 - (b) it must contain details of the examination or treatment being undertaken;
 - (c) it must contain the clinical indications for the examination or treatment;
 - (d) it must contain a statement by Stephen Wake making the direction that the person is presenting with the following:
 - suspected cervical spine injury;
 - extremity injuries;
 - pelvic injuries;
 - abdominal pathology; or
 - chest pathology;
 - (e) it must contain a statement by Stephen Wake that he has due authority to give the direction;
 - (f) it must be signed by Stephen Wake; and
 - (g) it must be signed by the licensed person who is performing the examination or treatment.
3. Stephen Wake must, when directed to do so by the Radiation Protection Branch, provide the Radiation Protection Branch with a written report on diagnostic radiography authorised by him during a period specified by the Radiation Protection Branch. The report must contain statistics of diagnostic radiography authorised and details of any radiation safety issues associated with the examinations during the specified period.
4. The exemption shall take effect commencing on the date of publication of this Notice in the *Government Gazette*.
