## ELECTRICITY ACT 1996

## (SECTION 80 (6))

*Notice of Exemption by the  
Minister for Mineral Resources and Energy*

PURSUANT to subsection 80 (6) of the Electricity Act 1996 (the Act), I, Tom Koutsantonis, Minister for Mineral Resources and Energy, grant the following exemptions from specified provisions of Part 6A of the Act, subject to the conditions listed below:

*Conditions**1. Commencement and Expiry*

These exemptions commence on the date the National Energy Retail Law comes into operation in South Australia, and each will continue in force until each or all of the exemptions are varied or revoked pursuant to subsection 80 (7) of the Act.

*2. Exemptions*

2.1 A person who is a member of a class of persons in respect of whom the AER has determined a deemed exemption is in force pursuant to the NERR is exempt from:

2.1.1 Section 63AB (1) (a) of the Act, except to the extent that that section requires compliance with code provisions related to metering; and

2.1.2 Section 63AB (1) (d), 63AC and 63AE of the Act.

2.2 A person who is a member of a class of persons in respect of whom the AER has determined an exemption is registrable pursuant to the NERR is exempt from:

2.2.1 Section 63AB (1) (a) of the Act, except to the extent that that section requires compliance with code provisions related to metering; and

2.2.2 Section 63AB (1) (d), 63AC and 63AE of the Act.

2.3 The following persons are exempt from Sections 63AC and 63AE of the Act:

2.3.1 Cowell Electric Supply Ltd (ACN 095 517 490);

2.3.2 The Municipal Council of Roxby Downs (Constituted by proclamation pursuant to the Local Government Act 1999 and the Roxby Downs (Indenture Ratification) Act 1982);

2.3.3 OneSteel Manufacturing Pty Ltd (ACN 004 651 325);

2.3.4 BHP Billiton Olympic Dam Corporation Pty Ltd (ACN 007 835 761);

2.3.5 The Minister of the Crown in right of the State of South Australia who is responsible for the sale of electricity at the Techport Australia Common User Shipbuilding Facility; and

2.3.6 The partnership comprised of Flinders Power Holdings GMBH (ARBN 094 284 723), Flinders Labuan (No. 1) LTD (ARBN 094284812) and Flinders Labuan (No. 2) LTD (ARBN 094 284 769).

*3. Interpretation*

3.1 In this notice:

3.1.1 National Energy Retail Law means the National Energy Retail Law set out in the Schedule to the National Energy Retail Law (South Australia) Act 2011; and

3.1.2 NERR means the National Energy Retail Rules pursuant to the National Energy Retail Law.
