NOTICE is hereby given that the Minister for Planning, pursuant to Sections 24 and 26 of the Development Act 1993, has prepared a Playford Urban Growth Areas (Angle Vale, Playford North Extension and Virginia) and General Section Amendments Development Plan Amendment (DPA) to amend the following Development Plan:

- Playford (City) Development Plan.

The DPA proposes to review land use and zoning policy covering all the growth areas identified in the draft Playford Growth Areas Structure Plan at Angle Vale, Playford North Extension and Virginia. The proposed changes are to assist in supporting additional housing opportunities in these areas, as well as provide additional opportunities for local services, facilities and employment.

The DPA will be on public consultation from Tuesday, 28 May 2013 to Friday, 2 August 2013.
