COMMUNITY TITLES ACT 1996

Exemption

Pursuant to section 104(4) of the *Community Titles Act 1996* (the **Act**), I, the Honourable Stephan Karl Knoll, Minister for Transport, Infrastructure and Local Government, exempt the community corporation named in Schedule 1 from compliance with section 104(3) of the Act, subject to the condition set out in Schedule 2, for a period of 1 year commencing on the day on which this notice is published in the Gazette.

SCHEDULE 1 – EXEMPT COMMUNITY CORPORATION

Community Corporation No. 21109 Inc.

SCHEDULE 2 – CONDITION OF EXEMPTION

A policy of fidelity guarantee insurance must insure the exempt community corporation in the amount of—

- (a) \$100,000; or
- (b) the maximum total balance of the community corporation's bank accounts at any time in the preceding 3 years,

whichever is the lesser.

However, if the maximum total balance of the community corporation's bank accounts at any time in the preceding 3 years is less than \$50,000, a policy of fidelity guarantee insurance must insure the exempt community corporation in the amount of \$50,000.

The taking of fish by an unlicensed person by using—

- (a) 2 or more dip tins; or
- (b) 2 or more hand nets at the same time; or
- (c) 2 or more shrimp traps at the same time; or

- (f) 11 or more hoop nets at the same time; or
- (g) a yabby pot and a drop net at the same time; or

TAKE NOTICE that pursuant to Section 115 of the *Fisheries Management Act 2007*, Dr Russell Bradford of CSIRO, Castray Esplanade, Hobart, Tasmania 7000 (the 'exemption holder') or a person acting as his agent, is exempt from section 70 of the *Fisheries Management Act 2007* and clause 63 of schedule 6 of the *Fisheries Management (General) Regulations 2017*, but only insofar as the exemption holder or his agents may undertake the activity specified in Schedule 1, at the location specified in Schedule 2, subject to the conditions set out in Schedule 3 from 1 January 2019 until 1 May 2019 inclusive, unless varied or revoked earlier.

SCHEDULE 1

1. Tagging and destructive sampling of Southern Bluefin Tuna (*Thunnus maccoyii*).
2. The use of Pole and Line and Trolline fishing methods to capture Southern Bluefin Tuna specimens.

SCHEDULE 2

All waters adjacent to South Australia between the lines of longitude 132°0'00"E to 136°0'00"E from the coast to the line of latitude 36°0'00"S excluding aquatic reserves, sanctuary zones and restricted access zones of marine parks (unless otherwise authorised under the *Marine Parks Act 2007*).

SCHEDULE 3

1. The exempted activity may only be undertaken aboard the vessel FV *Yasmin*.
2. A maximum of two Pole and Line and two Trollines may be used when conducting the exempted activity.
3. No more than a total of 100 Southern Bluefin Tuna landed may be retained during the term of this notice.
4. All Southern Bluefin Tuna not retained pursuant to condition three must be immediately returned to the water upon completion of tagging.
5. For the purposes of this notice, the following persons may act as an agent of the exemption holder:

 - o Scott Cooper
 - o Naomi Clear

6. While engaging in the exempted activity, the exemption holder or agent must be in possession of a copy of this notice. Such notice must be produced to a Fisheries Officer immediately upon request.
7. The exemption holder must not contravene or fail to comply with the *Fisheries Management Act 2007* or any regulations made under that Act, except where specifically exempted by this notice.
8. The exemption holder must not conduct any other fishing activity including recreational fishing whilst undertaking the exempted activity.
9. The exemption holder must provide a report in writing detailing the outcomes of the tagging and collection of samples of Southern Bluefish Tuna, including the location of tagging and sample collection undertaken, pursuant to this notice to PIRSA Fisheries and Aquaculture, (GPO Box 1625, ADELAIDE SA 5001) within 14 days of expiry of this exemption.
10. Before undertaking the exempted activity, the exemption holder or a person acting as an agent must contact PIRSA Fishwatch on 1800 065 522 and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption at the time of making the call and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related questions.

This notice does not purport to override the provisions or operation of any other Act including, but not limited to, the *Marine Parks Act 2007*. The exemption holder and his agents must comply with any relevant regulations, permits, requirements and directions from the Department for Environment and Water (DEW) when undertaking activities within a marine park.

TAKE NOTICE that pursuant to section 115 of the *Fisheries Management Act 2007* Jeremy Gramp (the 'exemption holder') on behalf of the Adelaide and Mount Lofty Ranges Natural Resources Management Board – NRM Education Program, C/- Noarlunga Office, Ramsay Place, Noarlunga Centre, SA, 5168 or a NRM Education Staff member acting as his agent is exempt from the provision of Section 70 of the *Fisheries Management Act 2007*, and Regulations 5 and 10 and clauses 42, 74 and 95 of schedule 6 of the *Fisheries Management (General) Regulations 2007*, but only in so far as the exemption holder may take native fish species for research purposes (the 'exempted activity') from the areas specified in Schedule 1, using gear specified in Schedule 2, subject to the conditions set out in Schedule 3, from 21 December 2018 until 21 December 2019, unless varied or revoked earlier.

2. All native fish must, as soon as reasonably practicable, be returned to the waters from which they were taken on completion of scientific evaluation and before leaving the point of collection.

4. All non-native fish must be destroyed and disposed of appropriately.

You will need to have a copy of your exemption with you at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related issues.
6. Within 14 days of the expiry of this notice, the exemption holder must provide a report in writing to PIRSA Fisheries and Aquaculture (GPO Box 1625, ADELAIDE SA 5001), of the results of the project to which this exemption is related.
7. While engaged in the exempted activity the exemption holder or a person acting as his agent must have in their possession a copy of this notice and such a notice must be produced to a Fisheries Officer if requested.
8. The exemption holder must not contravene or fail to comply with the *Fisheries Management Act 2007* or any regulations made under that Act or any condition of this notice, except where specifically exempted by this notice.

2. The exemption holder, nominated agent or registered master must notify PIRSA FISHWATCH on 1800 065 522 at least two hours prior to conducting the exempted activity and answer a series of questions about the exempted activity.
3. A maximum of 500 kg whole weight or 165 kg meat weight of *Haliotis roei* is permitted to be harvested pursuant to this exemption per each nominated agent of the exemption holder.
4. The exemption holder or nominated agent may not take *Haliotis roei* that is less than 7.5 cm in shell length.
5. *Haliotis roei* with a minimum shell length of greater than or equal to 7.5 cm may be shucked at sea.
6. All *Haliotis roei* taken from waters east of Cape Carnot must be landed in shell.
7. All *Haliotis roei* taken pursuant to this exemption must be stored separately from other species of abalone taken in a tagged, approved bag or bin.
8. Subject to condition 7, the shells of any *Haliotis roei* shucked at sea must be retained in a separate tagged, approved bag or bin and consigned with the *Haliotis roei* meat to a registered fish processor.
9. The estimated meat weight or whole weight of *Haliotis roei* must be recorded on Part A of the CDR1 form separately to other species of abalone in a manner that clearly indicates the form of *Haliotis roei* recorded (meat or whole weight).
10. All *Haliotis roei* meat and corresponding shells taken pursuant to this notice must be delivered to one of the following registered fish processors for weighing, within 48 hours of landing, within the State of South Australia:

11. The exemption holder or nominated agent must measure the first 50 shells from each fishing day (including where less than 50 *Haliotis roei* are taken on any one day) with corresponding map code recorded on an Excel file as directed by the Science Leader, Fisheries, SARDI Aquatic Sciences.
12. The exemption holder or nominated agent must provide such further information including shell measurements as directed by the Science Leader, Fisheries, SARDI Aquatic Sciences upon completion of each day of fishing activities pursuant to this notice.
13. The exemption holder or nominated agents must not contravene or fail to comply with the *Fisheries Management Act 2007*, or any other regulations made under that Act except where specifically exempted by this notice.
14. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Officer.
