SECTION 4(1)(A)

GR NOTICE NO. 11 OF 2019

*Approved Contingencies (Burra Picnic Races—Gallopings) Notice 2019*

I, Dini Soulio, Liquor and Gambling Commissioner, by this notice, approve contingencies relating to sporting or other events within Australia:

##### 1. Citation

This notice may be cited as the Approved Contingencies (Burra Picnic Races—Gallopings) Notice 2019.

##### 2. Approval

- (1) The contingencies listed in the table are approved in respect of fixed odds betting by licensed bookmakers.
- (2) This approval is subject to the provisions of the *Authorised Betting Operations Act 2000*, the Bookmakers Licensing Rules 2000, any other rules made under section 62 of the Act, and the conditions to which a licence or permit are subject.
- (3) This approval of contingencies may be amended or revoked by further notice.

##### 3. Definitions

In this Notice—

“**Event**”—

- (a) means a race on the flat for horses where each animal is ridden by a person;
- (b) includes, in relation to an event mentioned in paragraph (a) for which there were more accepters than places, a division of that event offering the same prize as the event;

“**place**” means the contingency that a specified Entrant will place either first or second (or, if applicable, third or fourth) in a specified Event (including where different odds are offered by a bookmaker for first place *vis-a-vis* any of second or, if applicable, third or fourth place);

“**race**”, with respect to horses, includes—

- (a) a race conducted by a licensed racing club; and
- (b) a race at a picnic race meeting or a gymkhana;

“**win**” means the contingency that a specified Entrant will place first in, or win, a specified Event.

## DEVELOPMENT ACT 1993

### SECTION 48

#### *Decision by the State Commission Assessment Panel*

#### *Preamble*

1. The decision by the Governor under section 48 of the *Development Act 1993*, to approve the development of an Organics Waste Treatment and Recycling Research Facility at Buckland Park was published in the *Government Gazette* on 5 December 2003.
2. The development was the subject of a Public Environmental Report and an Assessment Report under sections 46 and 46C of the *Development Act 1993*.
3. Ten amendments to the development approval were subsequently considered and approved by the Development Assessment Commission as delegate of the Governor, and published in the *Government Gazette* on 29 April 2004, 6 May 2004, 27 May 2004, 13 January 2005, 9 June 2005, 23 June 2005, 12 October 2006, 16 August 2011, 7 November 2013, 31 March 2016.
4. The State Commission Assessment Panel was established on 1 August 2017 and assumed the role of the Development Assessment Commission in relation to decisions in relation to this Major Development through the transition arrangements under the new *Planning, Development and Infrastructure Act 2016*.
5. One further amendment to the development approval has been considered by the State Commission Assessment Panel as delegate of the Governor under Division 2 or Part 4 of the *Development Act 1993*, and published in the *Government Gazette* on 8 November 2018.
6. On 4 March 2019, Jeffries Group, the company having the benefit of the development authorisation, applied for a variation to the development authorisation comprising the inclusion of a Biochar Process Plant to be located on the southern (hard stand) area of the site. The variation application was the subject of an amended Public Environmental Report (development application dated 4 March 2019) under Section 47 of the *Development Act 1993*.
7. The State Commission Assessment Panel has, in considering the application for a variation, had regard to all relevant matters under section 48 (5) of the *Development Act 1993*.
8. For ease of reference, the State Commission Assessment Panel has decided to revoke all conditions and substitute therefore the conditions contained herein. Requirements that pertain to the variation (relating to air quality modelling and provision of final plans) have been added as Condition 29 and 30, respectively.

#### *Decision*

PURSUANT to section 48 of the *Development Act 1993*, the State Commission Assessment Panel, as delegate of the Governor:

- (a) vary the development authorisation granted to Jeffries Group on 8 November 2018 by:
  - (i) revoking all conditions of approval attached to the provisional development authorisation published in the *South Australian Government Gazette* on 8 November 2018; and
  - (ii) attaching the conditions of approval set out in this notice below;
- (b) specify all matters relating to this development authorisation (as varied) as matters in respect of which conditions of this authorisation may be varied or revoked, or new conditions attached.

#### *Conditions of approval*

1. The proposed Major Development shall be undertaken in accordance with the following documents and drawings:

  - (ii) Drawing Titled: Jeffries Group Recycled Organics Resource Centre at Buckland Park, Overall Layout Plan, Drawing Number AEV402-C-DWG-050 (dated 20 May 2004).
2. The quantity of feedstock to be received or processed at the site shall not exceed 185 000 tonnes per annum.
  3. The raw materials for composting shall comprise green organics (foliage, grass cuttings, prunings and branches), saw dust, timber (pallets, boxes), and wet organics (processed grease trap residue, street sweepings) unless otherwise prescribed under the provisions of an Environmental Management Plan prepared and amended (as approved by the EPA pursuant to this development approval).
  4. All incoming feedstock to be received and processed at the Jeffries Organic Waste Treatment and Recycling Research Facility in accordance with the Environmental Management Plan as approved by the EPA.
  5. The construction of the processing areas (windrowing and final product), wheel wash bay area and surface water storage area shall be to the specifications listed in the 'Environmental Management Plan for a Recycled Organics Resource Centre at Buckland Park, dated 21 August 2003, Revision 2.
  6. The construction of all stages for the windrowing areas and wastewater areas shall be to Level 1 Supervision as set out in Australian Standard 3798-1996. Daily logs and final supervision report shall be forwarded to the Environment Protection Authority.
  7. A minimum of 1m separation distance shall be maintained between the groundwater level and the underside of all liners on the site.
  8. The location and decommission status of old wells located on the site shall be confirmed and the operational wells decommissioned in accordance with the requirements of the *Water Resources Act 1997*.
  9. Work constituting building work under the *Development Act 1993* shall be certified by a private certifier as complying with the Building Rules, prior to any building work commencing.
  10. The design and construction of the road access junction to the site from Port Wakefield Road shall be to the reasonable satisfaction of Department for Transport, Energy and Infrastructure and at the cost of the proponent.
  11. Prior to commencing operation at the site McEvoy Road must be sealed to the standard agreed between the proponent and the City of Playford, and at the cost of the proponent.
  12. The proponent must install a meteorological monitoring station in accordance with 'Meteorological Monitoring Guidance for Regulatory Modelling Applications, US EPA, February 2000'. And be operational before operations at the site commence. It shall be to such a standard that it produces data suitable for air pollution modelling and complaint resolution.

*Note: the parameters that should be recorded are wind speed and direction at 10m height, standard deviation of wind direction, temperature at 2m and 10m heights, solar radiation and rainfall.*

Unless varied by the following conditions:

13. The mounds constructed up to 15 March 2004 with compost material contaminated with plastics shall be covered with a minimum of 300mm of topsoil and maintained to ensure no plastic material is exposed.
14. Compost material used for the construction of the mounds or used on site may only contain an incidental amount of plastic fragments or other contaminants after processing, with the exception of mounds constructed up to 15 March 2004.
15. The compost material containing plastics, currently located at the Jeffries Wingfield facility shall be allowed to be stockpiled adjacent to the proposed Primary Processing Building at the Jeffries Buckland Park site to enable future processing to remove the plastic and other contaminants prior to use on the site in future mound construction.
16. A topsoil cover of a minimum of 300mm shall be maintained over the stockpile to ensure there is no litter.
17. The 'Calgrit 50' and 'Grit' shall be maintained at a moisture content that will minimise the potential for generation of dust at stockpile areas, during stockpiling, construction and operation of the windrows.
18. The water quality in the surface water storage ponds shall be monitored in accordance with the relevant provisions of the Environmental Management Plan.
19. The surface and side slopes of the 'Calgrit 50' and 'Grit' capping layer and the surface water drainage system will be inspected on a monthly basis and after prolonged rain to ensure their integrity, and shall be maintained to ensure effective operation.

20. Unprocessed organic material shall not be received at the Jeffries Organic Waste Treatment and Recycling Research Facility until the primary processing facility proposed at the site is established.
  - All vehicles transporting feedstock to Buckland Park shall be fully enclosed with solid floor, sides and a canvas or synthetic top cover that is attached to the sides in a manner that does not allow the escape of material.
21. A combined wheel wash and wash bay shall be installed within the Buckland Park facility for vehicles transporting materials and products to and from the facility and for the wash down of mobile plant within the facility.
22. All vehicles used solely for the transportation of feedstock to the Buckland Park site shall be required to be washed down externally before leaving the site empty, provided the vehicle body remains fully enclosed. The vehicles shall be washed externally and internally if used to transport compost or other materials from the Buckland Park site.
23. All mobile plant moving from one activity area to another shall be washed down at the wash bay before entering the new activity area.
24. Construction for the variations shall occur as per the specifications supplied in the Jeffries letter dated 24 May 2004 and email from Robert Rodenburg dated 1 July 2004.
25. Raw material and feedstock for composting shall not be placed on the hard stand areas at any time.
26. Maintenance of at least a 200mm layer over the Calsilt perimeter mounds shall be required to be composed of a minimum layer of 100mm of sandy loam then followed by a minimum layer of 100mm of coarse compost.
27. The Equipment Washdown Facility shall be constructed as per the details listed in the letter dated 25 February 2005 from the Jeffries Group.
28. The roof storm water from the granulation shed is to be directed into the stormwater storage area (south of shed) as shown on the submitted Overall Layout Plan, Drawing No. AEV402 – C –DWG – 050.
29. Post-commission testing of the exhaust stack must be undertaken within three months to verify the emission rates used in the CALPUFF modelling undertaken in the Biochar energy generation emissions assessment Report 10-1032 prepared by Enviroscan Industrial & Marine Surveys. Results of the post-commission testing must be provided to the Environment Protection Authority within 30 days of the testing being completed.
30. Final detailed plans for buildings and structures associated with the BioChar Processing Plant (including site plans, floor plans, elevations, cross-sections, rendered perspectives and other relevant specifications) shall be submitted to the Department of Planning, Transport and Infrastructure for approval, prior to construction commencing.

## Notes:

1. The proponent has an obligation under the *Aboriginal Heritage Act, 1988* whereby any 'clearance' work, which may require permission to disturb, damage or destroy Aboriginal Sites must be undertaken with the full authorisation of the Minister for Aboriginal Affairs.
2. An environmental authorisation granted by the Environment Protection Authority will include conditions requiring compliance with the standards of site preparation, management and maintenance detailed in the Environmental Management Plan, dated 21 August 2003, Revision 2 and the following requirements:
  - The monitoring of the separation distance between groundwater and underside of the clay liner. Measures will be required to put in place to ensure corrective actions being activated prior to the separation distance being at, or less than 1m. It is proposed to set a trigger level at 1.10m separation distance for more frequent level monitoring (minimum daily) and a second one at 1.05m separation distance to activate corrective actions. The Environment Protection Authority licence condition will require water levels to be measured weekly and assessed and reported monthly to the Environment Protection Authority for the first year of operation.
  - Maintenance of all drains and ponds.
3. The Minister has a specific power to require testing, monitoring and auditing under section 48(c) of the *Development Act 1993*.

## ENVIRONMENT PROTECTION ACT 1993

## SECTION 68

*Vary the Approval of Category B Containers*

I, ANDREA KAYE WOODS, Delegate of the Environment Protection Authority ('the Authority'), pursuant to section 68 of the Environment Protection Act, 1993 (SA) ('the Act') hereby:

**Vary the Approval of Category B Containers:**

Approve as Category B Containers, subject to the conditions 1, 2, 3 and 4 below, each of the classes of containers identified by reference to the following matters described in the first 4 columns of Schedule 1 of this Notice which are sold in South Australia:

- (a) the product which each class of containers shall contain;

- (b) the size of the containers;
- (c) the type of containers;
- (d) the name of the holders of these approvals
1. That containers of the class to which the approval relates must bear the refund marking specified by the Authority for containers of that class. The Authority specifies the following refund markings for Category B containers:
    - (1) "10c refund at collection depots when sold in SA", or
    - (2) "10c refund at SA/NT collection depots in State/Territory of purchase", or
    - (3) "10c refund at collection depots/points in participating state/territory of purchase"
  2. The holder of the approval must have in place an effective and appropriate waste management arrangement in relation to containers of that class. For the purpose of this approval notice the company named in column 5 of Schedule 1 of this Notice is the nominated super collector.
  3. In the case of an approval in relation to category B containers that the waste management arrangement must require the holder of the approval to provide specified super collectors with a declaration in the form determined by the Authority in relation to each sale of such containers by the holder of the approval as soon as practicable after the sale.
  4. The holder of these approvals must ensure that if a sticker bearing the refund marking has been approved, and is applied to the container, then the sticker must not be placed on any portion of the opening mechanism or in any other place that would require complete or partial removal of the sticker before the contents may be consumed.

**Liquor Licensing (General Code of Practice) Notice 2019**

under section 11A of the *Liquor Licensing Act 1997*

**1 Short title**

This notice may be cited as the *Liquor Licensing (General Code of Practice) Notice 2019*.

**2 Commencement**

This notice comes into operation on 18 November 2019 and varies the *Liquor Licensing (General Code of Practice) Amendment Notice 2014* published in the Gazette on 27 February 2014.

The *Liquor Licensing (General Code of Practice) Amendment Notice 2014* remains in force until that date.

**3 General Code of Practice**

- (1) The Schedule sets out the Commissioner's General Code of Practice as varied for the purposes of the *Liquor Licensing Act 1997*.
- (2) The Attorney-General has approved the General Code of Practice.

**Schedule 1—Commissioner's General Code of Practice****Part 1—Preliminary****1 Citation**

This code of practice may be cited as the *General Code of Practice* under the *Liquor Licensing Act 1997*.

## 2 Commencement

This code of practice came into operation on 18 January 2013 and was amended on 1 March 2014 and on 18 November 2019.

## 3 Purpose of the code

(1) The purpose of this code of practice is to promote the objects of the *Liquor Licensing Act 1997* and, in particular -

- (a) to ensure that the sale and supply of liquor occurs in a manner that minimises the harm and potential for harm caused by the excessive or inappropriate consumption of liquor; and
- (b) to ensure that the sale, supply and consumption of liquor is undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor; and
- (c) to ensure as far as practicable that the sale and supply of liquor is consistent with the expectations and aspirations of the public.

(1a) For the purposes of clause 3(1)(a) harm caused by the excessive or inappropriate consumption of liquor includes—

- (a) the risk of harm to children, vulnerable people and communities (whether to a community as a whole or a group within a community); and
- (b) the adverse economic, social and cultural effects on communities (whether on a community as a whole or a group within a community); and
- (c) the adverse effects on a person's health; and
- (d) alcohol abuse or misuse; and
- (e) domestic violence or anti-social behaviour, including causing personal injury and property damage.

(2) The intention of this code of practice is to commit licensees to:

- (a) make an assessment of the risk of their operational practices;
- (b) not undertake operational practices involving unacceptable risk;
- (c) consider and implement measures to manage high risk operational practices; and
- (d) maintain standards of operational practice that, as a matter of course, address medium and low risk operations.

## 4 Interpretation

(1) Unless the contrary intention appears, expressions defined in the *Liquor Licensing Act 1997* have the same meanings in this code of practice.

(2) The levels of risk associated with the operational practices of a licensed premises are to be assessed on the basis of what a reasonable person would consider to be:

- (a) low risk;
- (b) medium risk;
- (c) high risk; or

- (d) unacceptable risk.
- (3) When assessing the level of risk associated with the operational practices of a licensed premises and the likelihood of a particular outcome occurring, consideration must be given to the class of licence and the nature of the operational practices being conducted under the licence.
- (4) *Reasonable steps* to prevent, reduce the likelihood of or manage an outcome associated with the operational practices of a licensed premises, will be deemed to have been taken where the licensee is able to demonstrate that they have reasonably assessed the risk and the likely occurrence of the outcome based on the class of licence and the operational practices being conducted under the licence, and have implemented a written management plan which contains reasonable measures to reduce the likelihood of the outcome occurring.
- (5) The existence of a management plan formulated in purported compliance with clause 4(4) will not constitute *reasonable steps* if it is no longer current and/or the licensee's staff have not received training as to the content of the management plan and the manner in which it is to be implemented.

*security personnel* means a person who holds a security agent's licence that authorises the person to perform the function of controlling crowds under the *Security and Investigation Industry Act 1995*.

*staff* includes any person who sells, offers for sale or serves liquor on licensed premises whether they are a paid staff member or not.

## 5 Mandatory nature of the code

- (1) Under section 42 of the *Liquor Licensing Act 1997*, it is a condition of every licence that the licensee must comply with the Commissioner's codes of practice.
- (2) This code of practice is in addition to, and does not derogate from, licence conditions imposed by the licensing authority.
- (3) For the purposes of section 45 of the *Liquor Licensing Act 1997*-
  - (a) If the letter "A", "B", "C" or "D" appears in column B of the table in Schedule 1 next to the listing of a provision, contravention or failure to comply with the provision is declared to be an offence in the category corresponding to that letter;
  - (b) If the letter "A", "B", "C" or "D" appears in column C of the table in Schedule 1 next to the listing of a provision, the offence of contravention or failure to comply with the provision is declared to be an expiable offence in the category corresponding to that letter.

## 6 Application of this code of practice under section 11A(3) of the *Liquor Licensing Act 1997*

- (1) The Commissioner may exempt the licensee from a specified provision of this code of practice.
- (2) The Commissioner may vary or revoke an exemption from a specified provision of the code on the Commissioner's own initiative or on application of the licensee.

## Part 2 — Required training and practices

### 7 Responsible service of alcohol training

- (1) The licensee must ensure that all staff engaged by the licensee have successfully completed nationally accredited responsible service of alcohol training by a Registered Training Organisation approved by the Commissioner and published on a website maintained by the Commissioner.
- (2) If any member of the licensee's staff has not completed the training specified in clause 7(1) at the time of engagement, the training must be successfully completed within three months from the commencement of the engagement of the staff member.

- (3) The licensee must ensure that prior to being engaged by the licensee all security personnel have successfully completed nationally accredited responsible service of alcohol training by a Registered Training Organisation approved by the Commissioner and published on a website maintained by the Commissioner.
- (4) Clauses 7(1) and 7(2) do not apply in relation to -
  - (a) a liquor production and sales licence that does not authorise the sale or supply of liquor for consumption on licensed premises;
  - (b) a packaged liquor sales licence that only authorises the licensee to sell liquor through direct sales transactions;
  - (c) a short term licence unless this clause is applied in relation to the licence by a licence condition imposed by the licensing authority, taking into account the nature and extent of the operations conducted under the licence;
  - (d) the sale or supply of liquor to a resident for consumption on licensed premises;
  - (e) an interstate direct sales licence.
- (5) The licensee must produce evidence of the completion of responsible service of alcohol training by persons as required by this clause or by licence conditions, within seven days of being requested to do so by an authorised officer (within the meaning of section 122 of the *Liquor Licensing Act 1997*).

## 8 Practices relating to minors

- (1) The licensee must take reasonable steps to prevent -
  - (a) minors consuming or being supplied with liquor on the licensed premises; and
  - (b) minors unlawfully entering or remaining on the licensed premises or any area of the licensed premises that is out of bounds to minors.
- (2) The licensee must not conduct, promote, advertise or permit the conduct, promotion or advertisement of their business in a way that tends to encourage minors to consume liquor.

## 9 Practices promoting responsible attitude to consumption of liquor on licensed premises

- (1) The licensee must not conduct, promote, advertise or permit the conduct, promotion or advertisement of their business in a way that tends to encourage the rapid or excessive consumption of liquor or that discourages a responsible attitude to the consumption of liquor.
- (2) The licensee must not conduct, promote, advertise or permit gender-based promotions involving free or discounted liquor on the licensed premises including free or discounted entry to the licensed premises.
- (3) Except where liquor is sold for consumption off licensed premises only, or where liquor is supplied by way of sample only, the licensee must at all times -
  - (a) ensure that free cool drinking water is readily available to patrons on licensed premises; and
  - (b) ensure that at least one non-alcoholic beverage (other than water) is available for purchase at a price that does not exceed the price of the least expensive alcoholic beverage available for purchase.
- (4) **Between 12.01 am and 7.00 am at all times while open for trade** the licensee must not supply liquor free of charge or permit the supply of liquor free of charge.

- (5) The holder of an on premises licence (except where the licensed premises is a public conveyance) must ensure that food is available to patrons at all times that the premises is open for trade.

## 10 Practices relating to drink spiking

- (1) The licensee must take reasonable steps to prevent the likelihood of drink spiking occurring on licensed premises.
- (2) The licensee must cooperate with and assist police in any investigation relating to alleged drink spiking.
- (3) In this clause -

*drink spiking* includes any addition of liquor or other substance to a person's drink without the person's knowledge or permission (whether at all or in the quantity added).

## 11 Practices relating to intoxication and disorderly, offensive, abusive or violent behaviour

The licensee, responsible person or staff of the licensee must take reasonable steps -

- (a) to prevent the sale or supply of liquor to persons in circumstances where their speech, balance, coordination or behaviour is noticeably affected and it is reasonable to believe that the affected speech, balance, co-ordination or behaviour is the result of the consumption of liquor or some other substance;
- (b) to reduce the likelihood of incidents of intoxication and/or disorderly, offensive, abusive or violent behaviour on licensed premises; and
- (c) to manage incidents related to intoxication and/or disorderly, offensive, abusive or violent behaviour that may occur on licensed premises.

## 12 Practices relating to disturbances

The licensee must take reasonable steps -

- (a) to prevent disorder and safety.

## 13 Queue management

**Between 12.01 am and 3.00 am at all times while open for trade** the licensee must take all practicable steps to ensure that any line up or queue to enter the licensed premises is orderly and continuously monitored and managed to prevent obstruction to pedestrian traffic on the footpath.

## Part 3 — Required measures promoting compliance with the code

### 14 Risk assessment and reasonable steps

- (1) The licensee must consider the measures that will be implemented in conducting operations under the licence for the purposes of compliance with this code of practice and, in particular, the measures that will be taken to comply with the requirements to take reasonable steps.
- (2) The measures must be contained in a written management plan.
- (3) A copy of the management plan must be kept on the licensed premises and made available as soon as practicable upon request of an authorised officer.

- (4) The management plan must be reviewed and if necessary, modified every two years or when operations under the licence alter in such a way that warrants a review and modification of the management plan to be undertaken.

## 15 Induction and refresher training in the written management plan

- (1) The licensee must provide to all staff involved in the service or supply of liquor on the licensed premises, training in relation to the management plan to be implemented to address the risks associated with the operational practices.
- (2) The training must be provided to all staff on induction and at least once in each subsequent period of two years.
- (3) The licensee must produce evidence of the completion of the training by persons as required by this clause within seven days of being requested to do so by an authorised officer (within the meaning of section 122 of the *Liquor Licensing Act 1997*).

## 16 Guidelines

The Commissioner may issue guidelines designed to assist in risk assessment and training for compliance with this code of practice.

## Liquor Licensing (Late Night Trading Code of Practice) Notice 2019

under section 11A of the *Liquor Licensing Act 1997*

### 1 Short title

This notice may be cited as the *Liquor Licensing (Late Night Trading Code of Practice) Notice 2019*.

### 2 Commencement

This notice comes into operation on 18 November 2019 and varies the *Liquor Licensing (Late Night Trading Code of Practice) Notice* published in the Gazette on 17 December 2015.

The *Liquor Licensing (Late Night Trading Code of Practice) Notice 2015* remains in force until that date.

### 3 Late Night Trading Code of Practice

- (1) The Schedule sets out the Commissioner's Late Night Trading Code of Practice for the purposes of the *Liquor Licensing Act 1997*.
- (2) The Attorney-General has approved the Late Night Trading Code of Practice.

## Schedule 1—Commissioner's Late Night Trading Code of Practice

### Part 1—Preliminary

#### 1 Citation

This code of practice may be cited as the *Late Night Trading Code of Practice* under the *Liquor Licensing Act 1997*.

#### 2 Commencement

This code of practice came into operation on 1 October 2013 and was amended on 1 February 2016 and was amended on 18 November 2019.

### 3 Purpose of the code

- (1) The purpose of this code of practice is to promote the objects of the *Liquor Licensing Act 1997* and, in particular -
- (a) to ensure that the sale and supply of liquor occurs in a manner that minimises the harm and potential for harm caused by the excessive or inappropriate consumption of liquor; and
  - (b) to ensure that the sale, supply and consumption of liquor is undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor; and
  - (c) to ensure as far as practicable that the sale and supply of liquor is consistent with the expectations and aspirations of the public; and
  - (d) to impose additional requirements for licensed premises that are authorised to trade after 2 am for the purpose of reducing alcohol-related violence and antisocial behaviour in and around licensed premises.
- (1a) For the purposes of clause 3(1)(a) harm caused by the excessive or inappropriate consumption of liquor includes—
- (a) the risk of harm to children, vulnerable people and communities (whether to a community as a whole or a group within a community); and
  - (b) the adverse economic, social and cultural effects on communities (whether on a community as a whole or a group within a community); and
  - (c) the adverse effects on a person's health; and
  - (d) alcohol abuse or misuse; and
  - (e) domestic violence or anti-social behaviour, including causing personal injury and property damage.
- (2) The intention of this code of practice is to commit licensees to:
- (a) make an assessment of the risk of their operational practices;
  - (b) not undertake operational practices involving unacceptable risk;
  - (c) consider and implement measures to manage high risk operational practices; and
  - (d) maintain standards of operational practice that, as a matter of course, address medium and low risk operations.

### 4 Interpretation

Unless the contrary intention appears, expressions defined in the *Liquor Licensing Act 1997* have the same meanings in this code of practice.

**metal detector** means a system or device that gives a signal when it comes into close proximity with metal.

**polycarbonate glassware** means thermoplastic glassware that is characterised by high-impact strength, flexibility and shatter resistance.

**tempered glassware** means safety glassware that has been processed to increase its strength compared with normal glass which when broken, crumbles into small granular chunks instead of splintering.

## 5 Mandatory nature of the code

- (1) Under section 42 of the *Liquor Licensing Act 1997*, it is a condition of every licence that the licensee must comply with the Commissioner's codes of practice.
- (2) This code of practice is in addition to, and does not derogate from, licence conditions imposed by the licensing authority.
- (3) For the purposes of section 45 of the *Liquor Licensing Act 1997*-
  - (a) If the letter "A", "B", "C" or "D" appears in column B of the table in Schedule 1 next to the listing of a provision, contravention or failure to comply with the provision is declared to be an offence in the category corresponding to that letter;
  - (b) If the letter "A", "B", "C" or "D" appears in column C of the table in Schedule 1 next to the listing of a provision, the offence of contravention or failure to comply with the provision is declared to be an expiable offence in the category corresponding to that letter.

## 6 Application of this code of practice under section 11A(3) of the *Liquor Licensing Act 1997*

- (1) This code of practice does not apply to a holder of the following (in respect of that licence):
  - (a) a liquor production and sales licence that does not authorise the sale or supply of liquor for consumption on licensed premises;
  - (b) a residential licence;
  - (c) a packaged liquor sales licence that only authorises the licensee to sell liquor through direct sales transactions;
  - (d) a short term licence unless this clause is applied in relation to a licence by a licence condition imposed by the licensing authority, taking into account the nature and extent of the operations conducted under the licence;
  - (e) an interstate direct sales licence.
- (2) In addition to clause 6(1), the Commissioner may exempt the licensee from a specified provision of this code of practice.
- (3) The Commissioner may vary or revoke an exemption from a specified provision of the code on the Commissioner's own initiative or on application of the licensee.
- (4) In addition to clause 6(1), this code of practice does not apply in relation to the sale or supply of liquor to a resident for consumption on licensed premises.

## Part 2

### 7 Drink marshal

- (1) **Between 2.01 am and 7.00 am at all times while open for trade**, the licensee must ensure that at any given time, at least one person who is approved as a Responsible Person under the *Liquor Licensing Act 1997* is performing the duties of a drink marshal.
- (2) The duties of a drink marshal are to monitor compliance with section 108 of the *Liquor Licensing Act 1997* and the Liquor Licensing General Code of Practice and, in particular, to monitor the behaviour and alcohol consumption of patrons to reduce the likelihood of incidents of intoxication and/or disorderly, offensive, abusive or violent behaviour on licensed premises.

- (3) The drink marshal must patrol the whole of the licensed premises accessible to and occupied by patrons, and must alert bar and serving staff to any concerning behaviour that is taking place by patrons on the licensed premises.
- (4) If the drink marshal suspects that a person is intoxicated or observes someone behaving in a disorderly, offensive, abusive or violent manner, the drink marshal may exercise the powers that they have under the *Liquor Licensing Act 1997* as a Responsible Person or they must immediately report this to the licensee or manager/supervisor on duty for appropriate action to be taken.

## 8 First aid

**Between 2.01 am and 7.00 am at all times while open for trade**, the licensee must ensure that at least one staff member is on duty who has been approved as a Responsible Person under the *Liquor Licensing Act 1997* and successfully completed nationally accredited first aid training.

## 9 Restrictions on the sale and supply of beverages promoting rapid or excessive consumption

**Between 2.01 am and 7.00 am at all times while open for trade**, the licensee must not advertise the sale, offer for sale, or permit the sale or supply of any alcoholic beverage that may encourage the rapid or excessive consumption of liquor including:

- (a) beverages commonly known as ‘shooters’, ‘doubles’, ‘laybacks’, ‘test tubes’, ‘blasters’, ‘stingers’ ‘jelly shots’ or similar; or
- (b) any other beverage that contains more than 45ml of spirits.

## 10 Footpaths and other outdoor areas

**Between 2.01 am and 7.00 am at all times while open for trade**, the licensee must not permit the service or supply of liquor for consumption on any part of the licensed premises comprised of a footpath or other outdoor area to which the general public has access (not including beer gardens, balconies, enclosed courtyards or similar that are only accessible from within the licensed premises).

## Part 3

The following mandatory requirements 11-12 apply to licensees who are authorised to sell or supply liquor for consumption on licensed premises between the hours of 3.01 am and 7.00 am on any day (whether or not the licensees, in fact, trade after 3.01 am on that day).

## 11 Entry onto licensed premises and use of metal detectors

- (1) **Between 12.01 am and 3.00 am at all times while open for trade** the licensee must ensure that suitably trained employees are operating a metal detector to screen all patrons upon entry onto the licensed premises, to detect persons who may be carrying weapons or other potentially dangerous objects.
- (2) The metal detector must comply with the standard technical specification approved by the Liquor and Gambling Commissioner and must be kept in good working order at all times.

## 12 Restriction on the use of Glassware

**Between 3.01 am and 7.00 am at all times while open for trade** the licensee must:

- (a) not allow any drink (whether it contains liquor or not) to be sold or supplied for consumption on the licensed premises in glassware unless it is tempered or polycarbonate glassware; and
- (b) ensure that all empty non-tempered and/or non-polycarbonate glassware receptacles are removed from all areas of the licensed premises to which patrons have access.

## Part 4

The following mandatory requirement 13 applies to licensees (other than the Skycity Adelaide Casino or the holder of a restaurant and catering licence in respect of that licence) who are authorised to sell or supply liquor for consumption on licensed premises at any time between the hours of 3.01 am and 7.00 am on any day.

### 13 Late night restricted entry

**Between 3.01 am and 7.00 am at all times while open for trade** the licensee must not permit a patron (other than a resident) to enter or re-enter the licensed premises.

## Part 5

The following mandatory requirement 14 applies to licensees who are authorised to sell or supply liquor for consumption on licensed premises between the hours of 3.01 am and 7.00 am on any day (whether or not the licensees, in fact trade after 3.01 am on that day) and who trade from within the area of the City of Adelaide bounded on the north by the northern bank of the River Torrens, on the south by the northern alignment of South Terrace, on the east by the western alignment of East Terrace and its prolongation north to the northern bank of the River Torrens and on the west by the eastern alignment of West Terrace and its prolongation north to the northern bank of the River Torrens.

### 14 Digital closed circuit television (CCTV)

- (1) **At all times while open for trade**, the licensee must have a digital CCTV system in place to take visual recordings at all entry and exit points, the footpath immediately adjacent to the premises and all other internal and external licensed areas of the premises (excluding toilets) to which patrons have access.
  - (2) The digital CCTV system must operate continuously while the premises is trading and must continue to operate for at least one hour after the premises ceases to trade.
  - (3) The digital CCTV system must record the correct date and time.
  - (4) The digital CCTV system must comply with the standard technical specifications approved by the Liquor and Gambling Commissioner.
  - (5) The licensee must ensure that while the digital CCTV system is in use, the level of lighting at all entry and exit points is adequate so as to allow clear visual recordings to be taken.
  - (6) The licensee must ensure that the visual recordings are securely stored so as to prevent unauthorised access, for a period of time not less than 28 days.
  - (7) The licensee must ensure that the visual recordings can be easily downloaded via disk and USB and must be compatible with contemporary operating systems.
  - (8) The licensee must ensure that the visual recordings and any information relating to the visual recordings is made available as soon as practicable upon the request of an authorised officer acting in the course of his or her official duties (noting that the authorised officer must identify the date, time and location of the premises to which the request relates as well as the reason for the request).
  - (9) The licensee must take all practicable steps to ensure that the CCTV system is in good working order at all times and, in the event of any cessation in the operation of the CCTV system, the licensee bears the onus of proving that such steps have been taken.





  - (b) A person who has possession of the liquor in the course of carrying on a business or in the course of his or her employment by another person in the course of carrying on a business; or
  - (c) A person who is permanently or temporarily residing at premises within the area or on the boundary of the area and who enters the area solely for the purpose of passing through it to enter those premises or who enters the area from those premises for the purpose of leaving the area.

**Description of area**

The area in and adjacent to Wilmington bounded as follows:
