Mining (Reservation from Act) (Coastal Land) Amendment Proclamation 2024

under section 8(2) of the Mining Act 1971

Preamble

- By proclamation made pursuant to the *Mining Act 1971* on 19 April 1973 (*Gazette 19.4.1973 p1777*, fourth appearing), as amended, certain land along the coast of the State of South Australia is reserved from the operation of certain provisions of that Act.
- By proclamation made pursuant to the *Mining Act 1971* on 4 July 2024 (*Gazette 4.7.2024 p2021*) certain land in the Hundred of Dalrymple was excluded from that reservation.
- It is now intended that the reference to that land be deleted due to errors in its description, and that the land as described in this proclamation be excluded from the reservation.

Part 1—Preliminary

1—Short title

This proclamation may be cited as the *Mining (Reservation from Act) (Coastal Land)* Amendment Proclamation 2024.

2—Commencement

This proclamation comes into operation on the day on which it is made.

Part 2—Amendment of proclamation under *Mining Act 1971* reserving lands from operation of certain provisions of Act (Gazette 19.4.1973 p 1777, fourth appearing) as amended

3—Amendment of Schedule

FISHERIES MANAGEMENT ACT 2007

SECTION 115

Ministerial Exemption ME9903327

Take notice that pursuant to Section 115 of the *Fisheries Management Act 2007*, I Professor Gavin Begg, Executive Director Fisheries and Aquaculture, delegate of the Minister for Primary Industries and Regions, hereby exempt Mr Garry Ian Warrick of 1979 Kingston Road, New Residence SA 5333, holder of River Fishery licence number R27 (the 'exemption holder'), and his nominated agent, from Sections 53(2) and 70 of the *Fisheries Management Act 2007* and Regulation 5, Clause 6 of Schedule 6 and Schedule 7 of the *Fisheries Management (General) Regulations 2017* but only insofar as the exemption holder may use the devices described in Schedule 1 (the 'exempted activity') to take the species specified in Schedule 2 from the areas specified in Schedule 3, subject to the conditions set out in Schedule 4, from 22 September 2024 until 21 September 2025, unless varied or revoked earlier.

SCHEDULE 1

- 30 x gill net with a ply greater than 5, having a maximum length of 50 metres and a minimum mesh size of 10 centimetres and a maximum mesh size not exceeding 18 centimetres ("carp nets").
- 2 x Carp Separation Cages forming part of Lock 1 in Blanchetown on the River Murray.
- 1 x Backpack electrofisher (Smith-Root LR24).
- 1 x Boat electrofisher (Smith-Root 5.0kW GPP).

SCHEDULE 2

- European Carp (Cyprinus carpio)
- Bony Bream (Nematalosa erebi)

SCHEDULE 3

- 1. The exemption holder may conduct fishing activities using the Carp nets and electrofisher gear specified in Schedule 1 in the following areas of the waters connected to the River Murray:
 - Lake Bonney and connected Chambers Creek
 - · Wachtels Lagoon
 - · Spectacle Lakes and unnamed connected creek
 - · Yatco Lagoon
 - Gurra Gurra Lakes
- 2. The exemption holder may conduct fishing activities using the Carp Separation Cages which form part of Lock 1 at Blanchetown on the River Murray consistent with any requisite approvals and requirements of SA Water.

SCHEDULE 4

- 1. The exemption holder must not use more than the permitted number of devices specified in Schedule 1 at any one time.
- 2. The exemption holder may only engage in the exempted activity when also fishing pursuant to River Fishery licence number R27 and may only use a boat to engage in the exempted activity if that boat is registered by endorsement on River Fishery licence number R27.
- 3. The exempted activity may only be conducted by the exemption holder or his nominated agent:
 - Mr Jayden Warrick, 1979 Kingston Road, New Residence SA 5333
- 4. Use of the electrofisher gear must comply with guidelines set out by the Australian Code of Electrofishing Practice. All persons using the devices must be trained in accordance with these guidelines.
- 5. All native fish (excluding Bony Bream (*Nematalosa erebi*)) taken in the course of the exempted activity must be immediately returned to the water, and consistent with the Australian Code of Electrofishing Practice, when native species are encountered while electrofishing, electrofishing must be discontinued until the native species recovers and escapes.
- 6. Immediately prior to commencing the exempted activity, the exemption holder must contact the Department of Primary Industries and Regions (PIRSA) Fishwatch on 1800 065 522 and provide the following details:
 - The licence number and person(s) conducting the activity;
 - The exact location(s) of the fishing activities;
 - · The gear type and quantity being used; and
 - Ministerial exemption number: ME9903327.
- 7. The exemption holder must ensure that the carp nets are checked and all fish removed at least once during any 24 hour period during which they are in the water. All noxious species captured during these activities must not be returned to the water and disposed of appropriately.
- 8. Carp nets must be removed from the water when fishing pursuant to this exemption notice ceases.
- 9. Where the exemption holder moves the carp nets more than 3 kilometres from the location of the nets reported to the Department under Condition 6, or removes any of the nets from the river completely, the exemption holder must provide an additional report to the PIRSA Fishwatch on 1800 065 522 and either provide details as required under Condition 6 of this exemption notice, or report that fishing with carp nets and carp separation cages has ceased.
- 10. While engaging in the exempted activity, the exemption holder and his nominated agent must be in possession of a copy of this notice. Such notice must be produced to a Fisheries Officer as requested.
- 11. The exemption holder must not contravene or fail to comply with the *Fisheries Management Act 2007* or any regulations made under that Act, except where specifically exempted by this notice.

LIQUOR LICENSING ACT 1997

South Australia

Liquor Licensing (Dry Areas) Notice 2024

under Section 131(1) of the Liquor Licensing Act 1997

1—Short title

This notice may be cited as the *Liquor Licensing (Dry Areas) Notice 2024*.

2—Commencement

This notice comes into operation on 7 December 2024.

3—Interpretation

(1) In this notice—

principal notice means the *Liquor Licensing (Dry Areas) Notice 2015* published in the Gazette on 5.1.15, as in force from time to time.

(2) Clause 3 of the principal notice applies to this notice as if it were the principal notice.

4—Consumption etc of liquor prohibited in dry areas

- (1) Pursuant to Section 131 of the Act, the consumption and possession of liquor in the area described in the Schedule is prohibited in accordance with the provisions of the Schedule.
- (2) The prohibition has effect during the periods specified in the Schedule.
- (3) The prohibition does not extend to private land in the area described in the Schedule.
- (4) Unless the contrary intention appears, the prohibition of the possession of liquor in the area does not extend to—
 - (a) a person who is genuinely passing through the place if—

- (i) the liquor is in the original container in which it was purchased from licensed premises; and
- (ii) the container has not been opened; or
- (b) a person who has possession of the liquor in the course of carrying on a business or in the course of their employment by another person in the course of carrying on a business; or
- (c) a person who is permanently or temporarily residing at premises near the public place and who enters the public place solely for the purpose of passing through it to enter those premises or who enters the public place from those premises for the purpose of leaving the place; or
- (d) a person who possesses or consumes the liquor for sacramental or other similar religious purposes.

Schedule—Lobethal Area 1

1—Extent of prohibition


The consumption of liquor is prohibited and the possession of liquor is prohibited.

2—Period of prohibition

From 7:00pm to 7:00am, 7 December 2024 to 1 January 2025.

3—Description of area

The area in and adjacent to Lobethal bounded as follows: commencing at the point at which the western boundary of Mill Road meets the north-western boundary of the Adelaide to Lobethal Road, then generally northerly along that boundary of Mill Road and the prolongation in a straight line of that boundary to the point at which it is intersected by the prolongation in a straight line of the northern boundary of Pioneer Avenue, then easterly along that prolongation and boundary of Pioneer Avenue to the point at which it meets the north-western boundary of Main Street, then generally north-easterly and easterly along that boundary of Main Street and the northern boundary of the Lobethal to Mount Torrens Road to the point at which that northern boundary is intersected by the prolongation in a straight line of the eastern boundary of Frick Street, then southerly along that prolongation and boundary of Frick Street to the point at which it is intersected by the prolongation in a straight line of the southern boundary of Kumnick Street, then westerly along that prolongation and boundary of Kumnick Street to the eastern boundary of Ridge Road, then southerly and south-westerly along that boundary of Ridge Road to the point at which it meets the northern boundary of the Lobethal to Woodside Road, then in a straight line by the shortest route to the point at which the eastern boundary of Golf Links Road meets the southern boundary of the Lobethal to Woodside Road, then generally south-westerly along that boundary of Golf Links Road to the point at which it is intersected by the prolongation in a straight line of the southern boundary of the sewage pond in Lot 200 of DP 71985, then westerly along that prolongation to the eastern boundary of Lot 200, then generally north-easterly along that eastern boundary to the north-eastern boundary of Lot 200, then north-westerly along the north-eastern boundary of Lot 200 and the prolongation in a straight line of that boundary across Jeffery Street to the north-western boundary of Jeffery Street, then north-easterly along that boundary of Jeffery Street to the southern boundary of the Lobethal to Woodside Road, then westerly along that boundary of the Lobethal to Woodside Road to the south-eastern boundary of the Adelaide to Lobethal Road, then south-westerly along that boundary of the Adelaide to Lobethal Road to the point atwhich it is intersected by the prolongation in a straight line of the western boundary of Mill Road, then northerly along that prolongation to the point of commencement.

Self-Insured Insolvency Contribution Aggregate (SIICA) Determination 2024

The Board of the Return to Work Corporation of South Australia ("the Corporation") determines as follows pursuant to Section 17 of the Return to Work Corporation of South Australia Act 1994, Section 157 of the Return to Work Act 2014 ("the RTW Act") and all other enabling powers:

Part 1—Preliminary Matters

- 1. This determination may be cited as the Self-Insured Insolvency Contribution Aggregate ("SIICA") Determination 2024.
- This determination which commences 1 July 2024 ("Commencement Date") applies to self-insured employers and replaces the determination of the Board made on 26 June 2017.

Continuation of SIICA

3. On 1 December 1995 the Board authorised the creation of the Exempt Employer Reserve Account (EERA) to operate from 1 January 1996, to which exempt employers contributed a proportion of their levy ("fees") to protect the Compensation Fund from a self-insured employer's insolvency. Section 162(e) of the RTW Act, allows the Corporation to record the amounts contributed by each self-insured employer in respect of future employer insolvency. On 29 November 2007 the Board agreed that these amounts can be known as SIICA and SIICA was established to meet the original stated purpose of EERA.

Powers under 146 of the RTW Act

4. The fees collected pursuant to Section 146(2)(e) of the RTW Act are collected by the Corporation to meet liabilities of self-insured employers arising out of the insolvency of a self-insured employer where the fund's liabilities arising from that insolvency exceed the full amount of the financial guarantee provided by that employer.

Operation of SIICA

- 5. The amount of fees paid by each self-insured employer by way of a contribution to the actual and prospective liabilities of the Corporation arising from the insolvency of self-insured employers pursuant to Section 146(2)(e) of the RTW Act are recorded in a separate statistical data record (or account) that is maintained for each employer. The actual funds are pooled and form part of the Compensation Fund.
- 6. The actual amounts paid by the Corporation as a result of the insolvency of a self-insured employer in excess of the financial guarantee held by the Corporation in respect of the insolvency of that self-insured employer will be tracked and offset against the total amount of the fees collected in SIICA.

- 7. The amount of the fees collected in SIICA from self-insured employers referred to in 5 above will be reported in the Corporation's annual report (less any amount paid by the Corporation as a result of the insolvency of a self-insured employer in excess of financial guarantee held by the Corporation in respect of the insolvency of that self-insured employer) as an amount entitled 'Self Insurers Insolvency Contribution Aggregate'. Any Investment income will be credited annually to SIICA based upon the net return achieved on investments of the Compensation Fund as at 30 June each year.
- 8. The fees from self-insured employers in respect of the items referred to in Section 146(2)(a), (c) and (d) of the RTW Act are a percentage of the base premium that represents a fair contribution by self-insured employers to the costs of running the scheme.
- 9. The fees from self-insured employers in respect of items referred to in Section 146(2)(e) of the RTW Act are set at 0% of the base premium.
- 10. Both the rates set out in 8 and 9 above will be combined to constitute the self-insured employer fees rate pursuant to Section 146(2) of the RTW Act and will continue to operate on and from 1 July 2024.
- 11. The scheme actuary shall review the SIICA annually to determine the adequacy of the SIICA to meet the actual and prospective liabilities arising from the insolvency of employers pursuant to Section 146(2)(3) of the RTW Act.
- 12. The fees collected pursuant to Section 146(2)(e) of the RTW Act may be varied by redetermination by the Board of this determination in the event that the SIICA becomes equal to or less than an amount advised by the actuary to be adequate until such time as the Corporation determines that the SIICA is at a prudential level.
- 13. The Board will maintain the operation of SIICA consistent with the terms outlined above unless and until such time as the Board determines to the contrary.
